## A VOTE FOR THE TREATY

## Mr. Sean Hayes Speaks for West Cork

Mr. Sean Hayes (W. Cork) said he did not feel himself competent to go in detail into the merits or den crits of the Treaty but it occurred to him that they had got much of what the other speakers had been looking for. They got control of their own finances, they got control of education, which he held to be most essential. They secured that the British forces eveauate this country, and they had the right to raise and maintain their own army.

These provisions led him to the opinion that he should vote for that Treaty; and, further because they had no other alternative but war.

He did not think for a moment that the British Government would hesitate to make war on this country. It was well known in and outside of Ireland that the Irish Army fought with great bravery. It was also well known that the civic population gave all the support that they could have given to that Army, and they fought with the moral authority and the moral support of the world behind them, not that he attached great improtance to that moral support.

MORAL SUPPORT INSUFFICIENT.

When they were looking for recognition of the Republic the moral support was not sufficient to get it for them, and that was the test he applied to it. When they agreed to a Truce with the British Government they created in the minds of the people an idea that they were going to make a bargain with the British Government, and they could not get away from that.

He spoke for West Cork, and he was prepared to say that the majority of these people would accept this Treaty, and, whatever he might think personally of it, he felt it his duty to give expression to their views so far as he

He held that if he did otherwise he would be acting against the principle of government

The dead had been referred to, and he did not want to refer to them further than to say that he agreed with speakers who had said they owed a duty to the dead, but he maintained that if they owed a duty to the dead they also owed a duty to the living, and he could not see how he could cast a vote that would expose the Irish people to the risk of

He thought the Irish people should be told what the alternatives were in this matter. If they went to war, if they exposed the Irish people to the risk of war, then the Irish people should be told that the Treaty was being rejected because they wanted a Republic.

Concluding, the Deputy threw out a suggestion. Seeing that there was this division of opinion in the Cabinet as well as in the Dail, he threw out the suggestion that if this great
