Whereas I, <u>GiAWAVGO ANA</u>, a <u>Sourd MAN</u>, accredited by COMUSMACV, am Reporter/Photographer/Correspondent about to embark and participate as an observer in a combat mission as authorized by the Government of the United States, and whereas I am doing so entirely upon my own initiative, risk and responsibility;

Therefore, in consideration of the permission extended to me by the United States through its officers and agents to participate as a noncombatant observer in such combat mission; and in consideration of the permission extended to me by any of the Free World Military Forces, including the Vietnamese government, to utilize their equipment during such mission, I do hereby for myself, my heirs, executors and administrators, release and forever discharge the Government of the United States, the Government of Vietnam, and the Governments of all the other Free World Military Forces, from any claims, demands, actions or causes of action, on account of my death or on account of any injury to me or my property which may occur from any cause during the course of this combat mission.
