

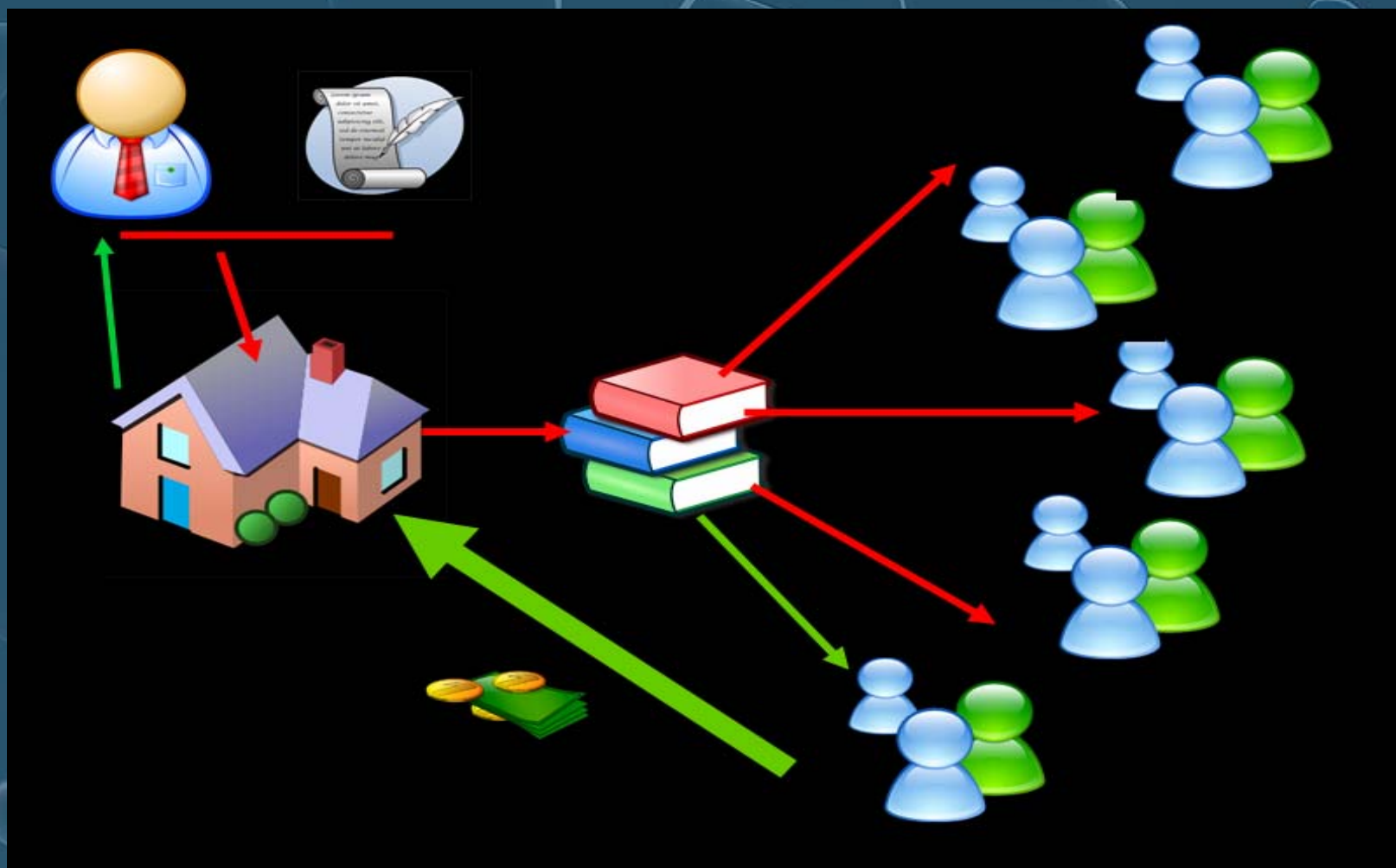
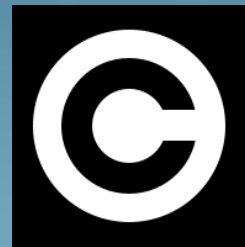

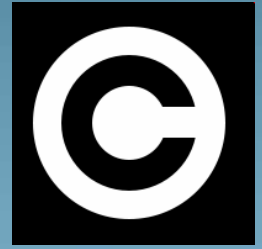
Wolne licencje – czyli legalne kopiowanie

Tradycyjjna dystrybucja





Copyright



- Wg polskiego prawa – twórcy przysługują **niezbywalne osobiste i zbywalne majątkowe** prawa autorskie automatycznie – w momencie ukończenia dzieła – nie ma potrzeby rejestrowania swoich praw
- Osobiste to: prawo decyzji o pierwszej publikacji, obowiązek podania autora i zakaz modyfikowania dzieła bez zgody autora
- Majątkowe to prawo do decydowania o opłatach za korzystanie z dzieła
- Nie istnieje **domniemanie** zbycia się praw autorskich. Wymaga to formy pisemnej może też nastąpić w efekcie stosunku pracy
- Wydawcy zwykle wymuszają podpisanie umowy na zbycie się majątkowych praw autorskich na wydawnictwo
- Serwisy internetowe tworzone przez społeczności wolontariuszy nie stają się właścicielami majątkowych praw autorskich do zawartych na ich stronach treści, chyba że ci podpiszą z nimi odpowiednie umowy

- Autor udostępnia swoje dzieło na określonej licencji i nadal pozostaje właścicielem praw autorskich
- Licencja zezwala na dowolne modyfikowanie i kopiowanie utworu
- Pod warunkiem podania autora, informacji o źródle i informacji o tym na jakiej licencji dzieło jest udostępnione
- Zwykle też nie można zmieniać licencji na dzieło pochodne
- jeśli decydujemy się stworzyć swoje dzieło na bazie innego, dostępnego na wolnej licencji, będziemy musieli je również udostępnić na tej samej licencji



Wolne licencje – GNU FDL



GNU FDL – GNU free documentation licence

Najstarsza licencja typu copyleft dotycząca tekstów a nie oprogramowania (1999) pomyślana dla dokumentacji.

Należy podać autorów, źródło, tzw. sekcje niezmiennie (np.: stopkę czy okładkę) oraz dołączyć pełen tekst licencji.

Kłopotliwa w użyciu przy dziełach o małej objętości i plikach multimedialnych.

Jest „zarażająca” – użycie fragmentu tekstu na tej licencji wymusza objęcie całego dzieła tą licencją.

Zastosowana w Wikipedii, bo w tym czasie nie było żadnej innej.



Licencje Creative Commons



CC – międzynarodowa organizacja z oddziałami w wielu krajach, tworzących lokalne odmiany licencji.

Cała rodzina licencji, których warunki można mieszać:

BY – obowiązek podania źródła i autorów

SA – obowiązek objęcia dzieła pochodnego tę samą licencją

NC – zakaz użycia komercyjnego

ND – zakaz tworzenia dzieł pochodnych.

Nie trzeba dołączać sekcji niezmiennych ani całego tekstu licencji – wystarczy link do ekranu informującego o podstawowych zasadach.

Licencja „nie zaraża” – nie ma konieczności obejmowania całego dzieła nią – jeśli wskaże się wyraźnie fragmenty na licencji CC

W ramach Wikipedii - dozwolone tylko CC-BY i CC-BY-SA



Multilicencjowanie



Można to samo dzieło objąć kilkoma licencjami. Wówczas, użytkownik ma wolny wybór na której z nich stworzyć swoją kopię/modyfikację.

Istnieją tendencje, aby uzgadniać różne wolne licencje z sobą, tak aby były one w pełni kompatybilne:

GNU FDL 1.3 i CC-BY-SA 3.0



Domena publiczna



Nie jest to licencja, lecz stwierdzenie faktu, że do dzieła wygasły prawa autorskie, lub dzieło jest wyłączone z działania prawa autorskiego.

Dzieła indywidualne, których autor zmarł 70 lat temu lub dawniej.

Dzieła grupowe, wydane 50 lat temu lub dawniej.

Proste informacje prasowe i innego rodzaju „suche dane” bez wkładu twórczego

Akty prawne, znaki i symbole urzędowe (ustawy, rozporządzenia, uchwały, orzeczenia sądów, teksty przyjętych zgłoszeń patentowych, oficjalne godła i herby jednostek terytorialnych i wojskowych.)

Można korzystać w zupełnie dowolny sposób, nawet bez podawania autora.



Domena publiczna



Dlaczego w takim razie nie dać sobie spokój z wolnymi licencjami i po prostu przenieść wszystko do domeny publicznej?

Dzieła pochodne (np.: tłumaczenia czy opracowania) mogą być „twardo copyrightowane”, przed czym zabezpiecza warunek „SA”.

W Polsce i wielu innych krajach nie można zbyć się swoich osobistych praw autorskich, autor nie może zatem przenieść swojego dzieła do domeny publicznej nawet jak sam tego chce !!!

Jego oświadczenie, że rezygnuje ze swoich praw autorskich jest prawnie nieważne, oznacza to tylko, że nie zamierza ich w żaden sposób egzekwować. Jednak - w każdej chwili może mu się odmienić i może on od użytkownika zażądać opłaty !!!



Open Content

Z wolnych licencji i domeny publicznej korzystają nie tylko projekty Wikimedia, ale też wiele innych, które łącznie tworzą ruch Open Content:

Deklaracja Kapsztadzka:

Znajdujemy się u progu światowej rewolucji w nauczaniu i uczeniu się. Nauczyciele z całego świata tworzą w internecie niezliczone materiały edukacyjne, dostępne do otwartego i wolnego użytku. Nauczyciele ci współtworzą świat, w którym każda osoba na ziemi może nie tylko korzystać z sumy ludzkiej wiedzy, ale także przyczyniać się do jej wzbogacania. Jednocześnie tworzą oni podwaliny dla nowego modelu pedagogiki, w którym wykładowcy i uczący się tworzą, kształtują i rozwijają wspólnie wiedzę, jednocześnie pogłębiając swoje umiejętności i rozumienie świata.

0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. Secondly, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.

This License is a kind of "copyleft", which means that derivative works of the document must themselves be free in the same sense. It complements the GNU General Public License, which is a copyleft license designed for free software.

We have designed this License in order to use it for manuals for free software, because free software needs free documentation: a free program should come with manuals providing the same freedoms that the software does. But this License is not limited to software manuals; it can be used for any textual work, regardless of subject matter or whether it is published as a printed book. We recommend this License principally for works whose purpose is instruction or reference.

1. APPLICABILITY AND DEFINITIONS
