Report

About the operations in general

Wikimedia Sverige is a for the common good non-profit organisation with the purpose to make knowledge frely available for all human beings, primarliy by supporting the Wikimedia Foundations projects. The fiscal year of 2014 have been a stable year without financial growth but where the operations have flourished. Since the new year we have once again an education manager and the operations towards the educational sector have been intensified. The chapter has conducted its work on the following areas:

- Liberating content
- Free knowledge in education
- Support to the community
- Reader participation
- Information about free knowledge

Board

Employees

During the year seven people have been employed on a mix of time limited contracts and regular employments. At the start of 2015 five were employed full time and one part-time, all on regular employments.

Members

The chapter had 585 members at the end of the year, of which 9 organizational members. With the help of Wikimedia Foundation a mail to previous donors were sent and the membership increased heavily.

The office

The chapter has during the year ended the PO box and changed the official adress to Hantverkargatan. The conference room has this year too been used for member initiated activities, which hopefully couls see an increase.

Economy

Financially we are still not independent from the Wikimedia Foundation, 69,3% of our finances came from them and 30,7% from other sources. Add to that member fees on 66 650 SEK, donations on 58 645 SEK and others on 9 047 SE during 2014. The interest rates have been lowered during the year and our income there were much lower than expected, so other savings accounts have been acquiered fo better interest in 2015. The chapter have not gotten grants to the extent we have budgeted for but we learn a lot on writing the applications. The largest single grants we worked on during the year were from the Swedish Agency for Youth and Civil Society for a project to increase the number of women editing Wikipedia, from the Internet Infrastructure Foundation for work on the translatiion platform translatewiki.net, Kulturbryggan for work on Umepedia and Swedish architecture and design for Meet Wikipedia. Smaller project grants came from the Wrld Wildlife Foundation for a pilot in Uganda, Europeana for Then and Now, some of the central museums for workshops with their employees, the University of Lund for workshops with researhers and communicators. For a overview of the grants we got, see note 2. Wikimedia Foundation is funding most of our projects, the exceptions are in the table below where the funders contributions are stated.

Expectations on future development

Growth in 2015 is estimated to 30%. The efforts with the long-term strategy to increase the number of donations and grants directly to the organisation will continue.

The organisation will continue several projects not completely financed by Wikimedia Foundation that started in 2014, Women on Wikipedia (226 169 SEK left), Recordings of free music (86 660 SEK left), Open Data knowledge dissemination (148 041 SEK left), DCAT-AP for Wikidata (110 000 SEK left), Database for public art (275 416 SEK left), translatewiki.net (140 000 SEK left) and Uganda Bootcamp (45 805 SEK left).

Information about risks and uncertainties

As expected in an organisation run by donations and project grants revenues are somewhat unstable and hard to predict. Basic security with 2 557 000 SEK from Wikimedia Foundation and the projects going over the new year is enough to keep the existing staff. During 2014 the organisation got sued by Bildkonst Upphovsrätt i Sverige (BUS) for the usage of images on offentligkonst.se. The organisation is of the viewpoint that this has been done in accordance with §24 URL and will continue the work.

Significant events after balance sheet date

No significant events occured.
