# **Management report**

#### General about the operation

Wikimedia Sverige is a public non-profit association, whose aim is to make information freely available for all people, mainly through supporting Wikimedia Foundation's projects. During the year a total of 10 persons have been employed with a variety of different time-limited contracts and full-time contracts.

At the end of the year, the association had 445 members, including 5 organisations. As our mail system has not worked we have been unable to reach all members and the number has been reducing this year.

#### Office

Our office and conference room has also this year been used by community members and organisations for different activities, and may also increase in use. Organisations include Open Knowledge Sweden, The Unstraight Museum and Mozilla.

# **Economy**

The economy of the organization has further been strengthened during 2016, and our financing has got a larger base. In 2016, our revenues have increased with 2,409,016 SEK as compared to 2015, which amounts to an increase of 54%.

The share of the financing from Wikimedia Foundation has decreased to 41 %, which means that we

for the first time have fulfilled the goal of not basing our financing to more than 50 % on one financier.

What's more, Wikimedia Sverige and Wikimedia Österreich were honored to become the first two

chapters ever to receive multi-year financing from Wikimedia Foundation.

Two larger projects, Wikispeech (with financing from Swedish Post and Telecom Authority, PTS) and

Connected Open Heritage (with financing from Postkodlotteriets Kulturstiftelse, the Cultural Fund of

the Postcode Lottery) each amounted to more than 20 % of the revenues. On top of that, we received

member fees and donations amounting to 161,833 SEK and other operating income amounting to

380,187 SEK under 2016.

We also received project support from Vinnova for a project on education, and for a couple of open

data projects (including continued support for a project around offentligkonst.se). We got supported by

Kalmar County Administrative Board for a project on open water-related data, and from the Swedish

Agency for Youth and Civil Society for a project on equality. Several of the projects were initiated in

2015. The organization has not managed to attract project support to the extent presented in the

budget, but has still managed better than last year.

We have received smaller grants from the Royal Armoury and Skokloster Castle with the Hallwyl

Museum Foundation (LSH) and from Nationalmuseum for working with their collections and some

training of their personnel, and from Lund University, The National Swedish Museums of Military

History, the National Union of Teachers in Sweden and the Swedish Exhibition Agency for different

trainings and for travel costs.

We are happy that several of our financiers are returning over the years.

## **Expectations of the future development**

Growth during 2017 is estimated to approximately 54 %. The work with long-term strategy to increase donations and contributions directly to the association was successful, and is going to continue.

#### Information about risks and uncertainty-factors

Basic security of 2,616,000 SEK from Wikimedia foundation and the projects that are going to be completed with contributions from Postcode Lottery's Cultural Foundation, as well as Post-and Tele-Council provide for a very stable economic situation for the association in both 2017 and 2018. The court case (trial) with Bildkonst Upphovsratt i Sverige (BUS) for the use of pictures on offentligkonst.se has yet to be finalized, but has been transferred to the new Patent and Market Courts, a special court for copyright, patent and trade cases.

# **Additional information**

# Note 1 Accounting principles and yearly statement of operation comments

Yearly statement of operation has been written in accordance with yearly statement of operation law and Swedish Accounting Statement Board's (BFN) general recommendations.

Receivables have been added to the sums whereby they are estimated to come in.

Other assets and debts have been added to acquisition value if not stated otherwise.

The accounting principles have not changed from previous year.

#### **Income Statement**

Income is shown to the real value of what has been obtained or will be obtained.

#### Membership fees

Membership fees comprises fees for membership in the non-profit organization. Membership fees are accounted as revenue at the time of the payment from the member.

#### Received donations

Received donations are reported according to BFNAR 2002:10, Reporting of donations to non-profit organisations and registered religious communities, i.e. the donation is accounted for when the donation is legally transferred.

# Received grants

Cash contributions are considered grants when an organisation receives them from a contributor who is a public body. A conditional grant has conditions meaning the grant has to be repaid unless the conditions are met.

Received grants are reported according to BFNAR 2002:10, Reporting of donations to non-profit organisations and registered religious communities.

A grant is accounted for at the time the grant is received. If the grant is intended to cover specific costs the accounting should show the connection between costs and contribution.

The accounting for a conditioned grant is done when there is a high probability that the grant does not have to be repaid.

# **Operational Costs**

Operational costs are the costs that Wikimedia Sverige incurs in order to fulfill its mission in accordance with laws. This includes the cost for having employees, who are hired in order to enable the realization of work that has been identified by the annual meeting, as well as administrative costs that directly follow the organization's commitment to fulfill its goals.

#### **Administrative costs**

Administrative costs are the costs that are necessary to administrate Wikimedia Sverige, such as costs for Board of Directors' meetings, member services, audit, costs for collections, parts of rent, leadership and the part of administration that is not accounted for by operational costs.
