Report

About the operations in general

The fiscal year of 2012 has been an exciting and turmoiling year without precedence in the chapters history. After carefully conducted planning in 2011 the chapter has during the fiscal year morphed from a totally volunteer driven chapter to a professional chapter with four full-time employees and three more on part time. At the same time the volunteer force and the ties to the Wikipedia community has remained intact and developed. As a part of that the chapter has made resources available to volunteers to manage their own projects and through a pool of technology.

Another part in our work has been to establish an office on Södermalm in Stockholm and getting a membership in IDEA with accompanying collective agreement with Unionen. This large expansion has been financed by the Wikimedia Foundation but also by project funding from the EU for the projects Europeana Awareness and Wiki skills. It is a long term strategic goal for the chapter to decrease the dependence of single donators like the Wikimedia Foundation and broaden our base of finances to secure our long term work.

A big focus during 2012 has been in the GLAM sector (Galleries, Libraries, Archives and Museums) where one of the highlights were the signing of a letter of intent with the Council of the Swedish Central museums on collaboration over the year. This has opened several doors and other similar organisations are about to sign similar letter of intent.

During the fall we launched a Swedish version of the Wikipedia Education Program. The work with the program was started off by an intern, who later was hired to continue the work. The program has been well received by teachers who are interested in using Wikipedia in their work.

Also during the fall a thorough strategy work was conducted, as a continuation of our work with the vision 2011 which will be a solid ground for 2013. The year was ended with the hiring of a CEO which will start in March 2013.

The challenge in 2013 will be to find ways to finance the chapter on a stable long term, which is even more important now that we have employees.

Wikimedia Sverige is a non-profit, for the common good organisations with 138 members, which of two are organisations.

The chapter will continue three externally financed projects, where two (Europeana Awareness and Chelha/Reference literature) got funded in 2012 of some is left (107,710 SEK and 64,000 SEK) to use in 2013 while the project Wiki skills already has used some (39,083 SEK) funds that will be paid out in the fiscal year of 2013.

Expectations on future development

The growth on 2013 is estimated to 30%, but regarding to staff the hirings will decrease. For the bookkeeping we are using CiviCRM a web based management system.

Information regarding risks and uncertainties

As expected in an organisation driven by donations and similar funding the revenues are a bit unstable and hard to foresee. The security through the 2,35 MSEK from Wikimedia Foundation will take us far but will require some planning and carefulness of us to be able to keep full staff during the year.

Environmental information

The chapter has introduced an environmental policy. It is designed to be easy to apply in as many cases as possible. Wikimedia Sverige strives to reach our goals in a sustainable way. This means that consideration should be made on what environmental impact the chapters activities and procurements has.
