Regal Press is publishing a book entitled <u>Six Qualities of a</u> <u>Strong Family</u>, consisting of the proceedings of a conference held in Washington last June. Bruce Chapman participated in the conference, and his remarks will appear in the book. Those putting the book together have advised Mr. Chapman that they intend to print the President's June 16, 1984 radio address on the family as a foreword to the book, and that the book cover will include the wording "Preface by President Ronald Reagan."

The publisher's plans seem calculated to convey the false impression that the President is associated with the book. By definition a foreword or preface looks to what follows, but in this case the President is in no way associated with what would follow his preface or foreword. The attached draft objects to the publisher's plans, not to reproduce the radio address (which is in the public domain) but to place and style it in the book in a misleading fashion.


Enclosed please find correspondence which I have just received from the Logos Research Institute of Manhattan, Kansas with regard to an introduction to a book from the President.

Dear Mr. Chapman:

On December 21, 1984, we mailed you a copy of the entire book manuscript, tentatively entitled, "Six Qualities of a Strong Family" which was the proceedings of the National Leadership Forum on Family Well-Being held in Washington, D.C. in June 1984. We had hoped for a personalized forword to be written from President Ronald Reagan.

Since it does not appear that a more personalized forword will be possible in the near future and because our publication deadline is approaching with the publisher, Regal Press of Ventura, California, we would like to print the President's radio address to the nation from Camp David on June 16, 1984 (the same week as our conference) which we understand is in the public domain and designate it as the forword to the book. The managing editor of Regal Press, Earl Roe, has said that this means that Regal Books may place the wording, "Preface by President Ronald Reagan" on the book cover.

Enclosed is a copy of the forword as it would appear in the book. Please notify me by March 31, 1985, in writing if you have any objection to our using this radio address as the forword to our book, otherwise we will proceed with this plan under the assumption that it is acceptable to the White House.

I appreciate having been invited to the East Room ceremony to open the National Center for Missing Children, and having been introduced to you by Jerry Regier. Jerry recommended using President Reagan's radio address on the family as the forword to our book. I trust this arrangement is acceptable.

FORWORD

My fellow Americans . . . our thoughts turn to to the well-being of family life in America. Families have always stood at the center of our society, preserving good and worthy traditions from our past, entrusting those traditions to our children, our greatest hope for the future.

Family life has changed much down through the years. The days when we could expect to live in only one home and hold only one job are probably gone forever. Perhaps we will not go back to the old family ways, but I think we can and should preserve family values--values of faith, honesty, responsibility, tolerance, kindness and love.

And we'll keep on trying to do better, trying to create a better life for those who follow. This hasn't been easy to do in the last decade. It's become more difficult to raise children that it once was.

For example, the dependency exemption on your income tax: The money you can deduct for raising a child or caring for an elderly relative was \$600 in the late '40s. That's been increased to \$1000 now. But if that deduction had been indexed to keep pace with inflation, today you would be deducting more than \$3000 for every one of your children.

Housing became harder to afford. And the cost of private education also became too expensive for millions of middle-income families. By 1980, American families felt the full shock of runaway taxes, inflation, record interest rates and soaring prices for housing, education, food and other necessities of life.

They saw the golden promise of the American dream disappearing behind storm clouds of economic misery. Liberals urged hugh government subsidies, paying parents for expenses they used to handle themselves. But big government becoming "Big Brother," pushing parents aside, interfering with one parental responsibility after another is no solution. It only makes bad situations worse, raising prices and taxes for everyone. We came to Washington with a better idea--help working parents to better provide for themselves and their children by enabling them to keep more of their earnings and help them by making government do its job so the terrifying specter of runaway price increases never returns.

Our tax rate reductions have helped parents, reducing the tax bill that would have been owed by a typical family by over \$900 a year. And we've helped parents by reducing the inflation rate by nearly two-thirds since 1980 and by creating more than six million new jobs. Things are getting better for American families, but much remains to be done.

That's why the Treasury Department is making greater tax fairness and greater tax incentives for families a central consideration in the tax reform proposals they're developing. We're trying hard to help fathers and mothers in other ways, too.

Many innocent children are exploited by those who traffic in the gutter of drugs, child pornography and prostitution. Last month, I signed the Child Protection Act of 1984, a key part of our determination to crack down hard on the smut merchants. And this past week, we opened a National Center for Missing and Exploited Children to help educate parents and authorities on how to protect their loved ones.

We've just launched a nationwide citizen effort to encourage volunteer, courtappointed special advocates in legal cases of neglect and child abuse. Soon, we'll start up a sophisticated detective program to help law enforcement officers identify and capture the so-called serial killers who prey upon women and children.

And we've urged the Congress to pass a law that will strengthen and improve child support from absent parents. Children should not be financially abandoned just because they're separated from one of their parents.

We're trying hard to make two other changes. We want to see fewer abandoned, handicapped or underprivileged children left in perpetual foster care. And we want to see the unborn child given his or her chance to live and to know the joys of life. Adoption is often the best option. Too often, it's been the forgotten option.

We're seeing hopeful signs that our policies are paying off. Family income is improving; infant mortality rates continue to drop. And the crime rate has taken a steep dive. The outlook for families in America is better today than in 1980. And we're determined to make it better still.



Requested Views Regarding Fairness in Media

Charles Donovan of Presidential Correspondence has asked us to review a proposed reply to an individual who wrote requesting the President's views on Fairness in Media and that organization's efforts -- sponsored by Senator Helms -to gain financial control of CBS. The proposed reply advises that the President generally does not comment on the merits of efforts undertaken by private organizations, with exceptions such as the Boy Scouts and the Red Cross.

The "policy" stated in the proposed reply strikes me as too broad. The President rather often comments on the activities of private organizations, as a review of any videotaping schedule would indicate. I think it would be better simply to note that it would be inappropriate for the President to become involved in this dispute between two private organizations. A revised draft reply is attached, and a transmittal memorandum to Donovan.

Dear Mr. Shapell:

Thank you for your letter of March 7 to the President. In that letter you offered to donate \$10,000 to a charity designated by the President, in exchange for a handwritten letter from the President discussing Presidents Jefferson and Lincoln.

We are unable to accept your offer. The White House receives countless requests to provide memorabilia to be auctioned off for the benefit of particular charities. We obviously cannot grant all such requests, nor is there any fair way to discriminate among the requests. Accordingly, the White House has adopted the policy of generally declining to provide memorabilia for charitable auction.

Your proposed exchange of a charitable contribution for a particular item of Presidential memorabilia, while not an auction per se, bears many of the same essential characteristics and, in our view, must be governed by the same policy. I hope you will understand the reasons we must decline your offer.




