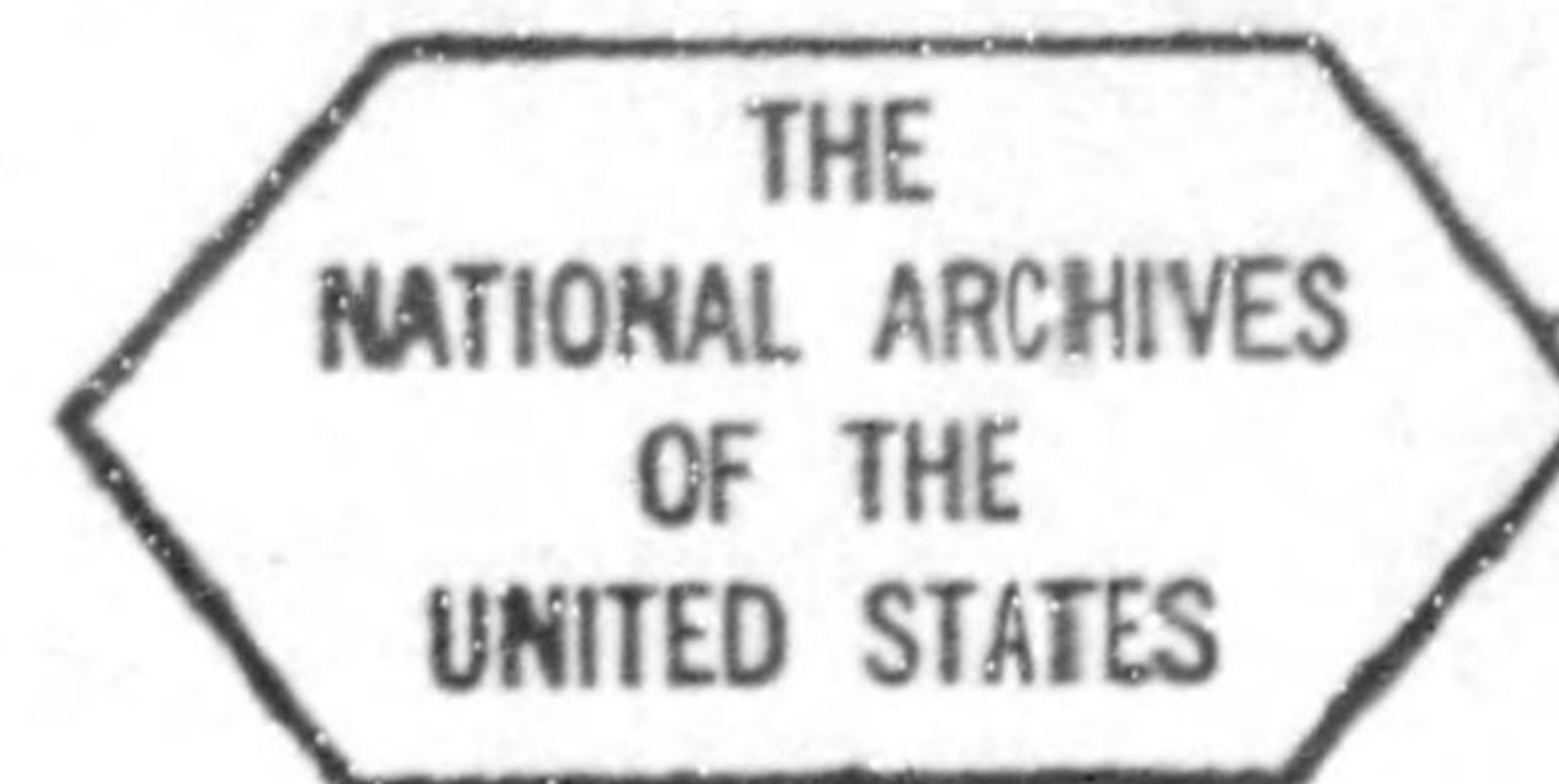

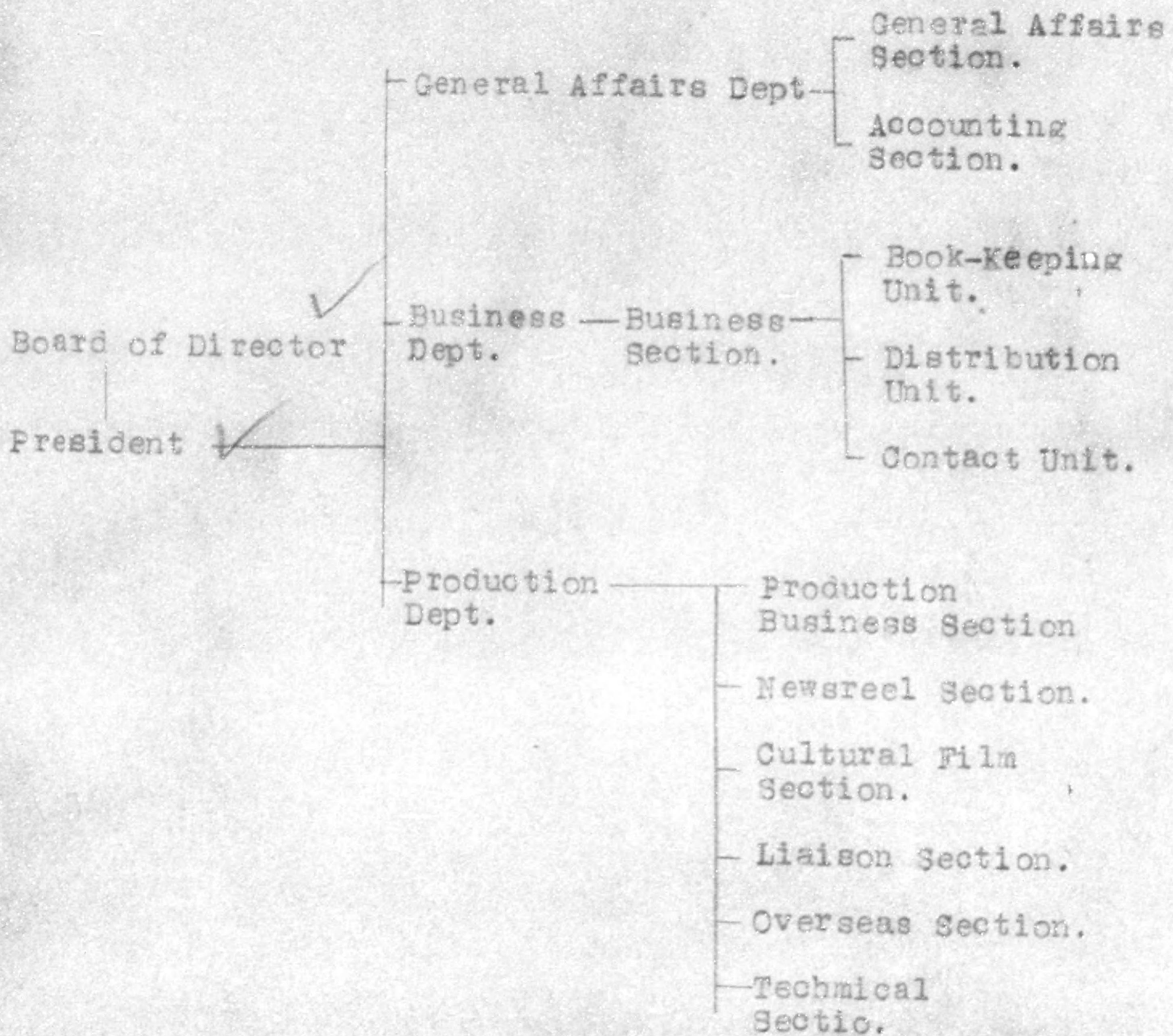

Chart of Official Responsibilities as of Dec, 1941



The following is the business structure of the Company from the Date of Inauguration in May, 1940, as the Nippon News Eiga Sha(Corporation) and to the Date of Being re-organized as the Nippon Eiga Sha(Corporation) in June, 1941.

1. The operation of General Affairs Department was divided into two sections and it transacted the general affairs of the Company as a whole.
2. The Business Department had one section. The negotiations and contracts were handled by Contact Unit, and the distribution of prints to the contracted theatres for the periodical exhibition was handled by Distribution Unit. The Book-Keeping Unit handled the accounting for the revenues from the exhibition to completed the transaction of the Department.
3. The Production Department attached importance to the production of newsreels. Liaison Section handled the contact and negotiations with outside organization, The planning for news coverage was handled by the newsreel section, while the cameramen of the Technical Section handled the production. Also, the editing and production of "Overseas News" was handled by Overseas Section which selects news items from material, collected from abroad. All the routine business concerning the above mentioned items was handled by Production Business Section.

Note:- Although the Cultural Film Section was made, the production was not started until August, 1941, when the planning began to materialize.
