He served in Europe and reached the rank of sergeant—a distinction he would give up in 1944 in order to re-deploy to the Pacific Theatre. During the battle at Fortress Corregidor in 1945, Mr. Bordonaro exhibited remarkable feats of fearlessness and commitment to his duties. After surviving behind enemy lines alone for three days—while suffering from malaria and shrapnel wounds—he finally reunited with his unit and refused to be taken off the front lines for treatment.

Following his military service, Mr. Bordonaro returned to Syracuse and settled in the town of Camillus with his wife, Josephine. Mr. Bordonaro worked as a high-skilled mason and was employed by Prestolite Co. for 35

years. He later held a position at Solvay Process for 11 years. He built a home in Camillus where he and his wife raised four daughters. To this day, Mr. Bordonaro still lives in the home he built.
