Lieut. G. A. BRAUN in a PB4Y-1P aircraft of Fleet Air Photographic Squadron Five took off from Agana Airfield, Guam, M. I. on 14 May 1945 at 0725 King to photograph enemy installations on Marcus Island. He arrived over his target at 1230 King and took good vertical photographs of the entire island from an altitude of 18,000 ft. The target was cloud free. No enemy interception or anti-aircraft fire was encountered. Lieut. BRAUN returned to Agana at 1750 King.
