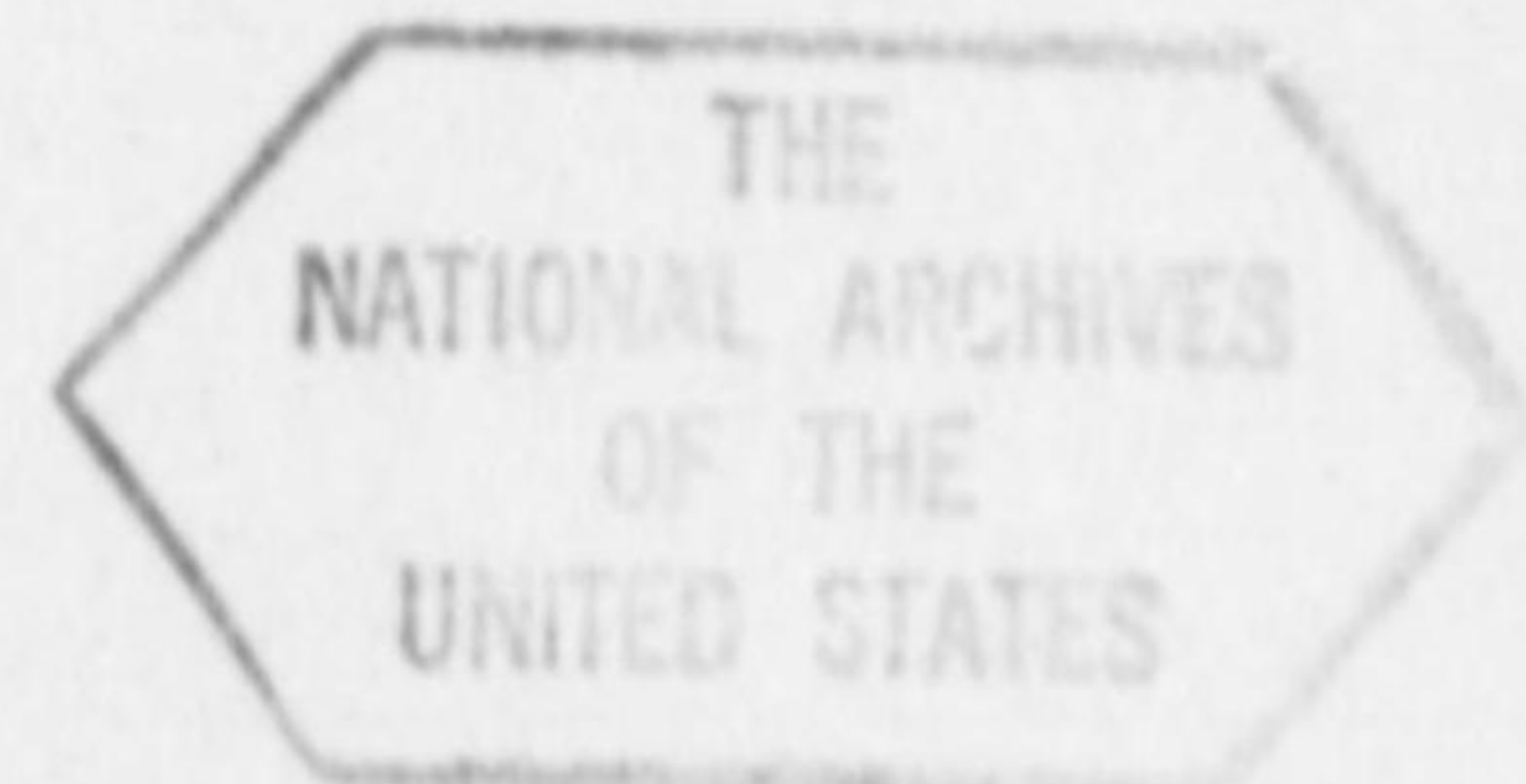

Policy Relative to Preparation of the Budget Estimates for JFY 52-53

1. Assumptions

The following assumptions as to the status of NPR on 1 April 1952 will be utilized as a basis for the preparation of budget estimates:

- a. Mission - See Cabinet Order No. 260, 10 August 1950
- b. Personnel:
 - (1) Strength will be 75,000 police officials and grade ceilings as provided for in the approved JFY 51-52 budget, will have been reached.
 - (2) Personnel for a female Nurse Corps will not have been authorized nor recruited.
 - (3) Civilian employees other than police officials will be employed in the same number as authorized at present.
- c. Operations:
 - (1) Training Status:
 - (a) All personnel will have received individual training.
 - (b) Tactical type platoon, company and battalions training will be completed.
 - (c) Service type units will have completed basic technical training and minimum advanced training.
 - (2) Part of the training aids and ranges will have been supplied as contained in JFY 51-52 budget.
 - (3) No major training areas other than those areas available in NPR camps will have been acquired.
 - (4) Only minimum training manuals will have been printed.
- d. Schools: GG School Center will be the only major school center for NPR; its facilities will be adequate for the conduct of staff and limited technical courses.
- e. Service and Supply:
 - (1) Part of the Organizational Equipment will have been procured as shown in JFY 51-52 Commodities Procurement Plan.
 - (2) Minimum amounts of individual clothing and individual equipment will be on hand as replacements factors.
 - (3) Status of Installation:
 - (a) Reasonable location of tactical type camps under the regional units have not been completed from defense point of view.

(b) Rehabilitation of camps will not have reached a normal reasonable standard (above minimum).

(c) Storage:

- 1 Uji and Tachikawa Depots will be in operation, and generally, adequate to perform their mission as presently known.
- 2 Depots in the 2nd and 4th Regions will not be adequate to perform their mission.
- 3 Ammunition and weapon storage facilities at camps and depots level will be generally inadequate.

(d) Miscellaneous Facilities:

1 Communications

The 4 fixed communications installations, and the Communications Center in Tokyo will be in operative condition.

2 Medical

With the exception of Hario, hospital will not be capable of providing medical care. Dispensaries in all camps will be operative. Hospital care will be by contract with civilian agencies.

3 Repair Facilities

Repair facilities (clothing, shoes, vehicles, etc) will be in operation for minimum essential requirements.

2. Policies

a. The following policies for JFY 1952-53 may be used as a guide in the preparation of budget estimates:

- (1) Authorized strength for police officials will be 75,000 and recruitment of new personnel will be accomplished at the appropriate time to maintain authorized strength.
 - (a) It is anticipated that a loss of approximately 50% in enlisted grades and 20% in officer grades will occur in 1952 FY, at the expiration of the enlisted grades term of service.
 - (b) Special separation allowance will be paid after completion of fixed term of service, regardless to actual separation.
 - (c) In order to induce present personnel to remain in the service and/or attract excellent new personnel, same amount of

special separation allowance (60,000 yen)
given to original members will be provided.

- (2) Personnel other than police officials may be employed as follows:
 - (a) Hospital nurses
 - (b) Technicians, such as Boilerman, Electrician, etc, at each installation.
 - (c) Repairer for clothing and signal equipment at depots.
 - (d) Typists, telephone operators and interpreters at GG Hq and Sv Gp Hq.
- (3) Base pay and sundry allowance for police officials will be calculated on the present basis.
- (4) Individual travel will be restricted to that necessary for Inspections, Conferences, Schools, Liaison, Survey, Investigations, Permanent Change of Station, Separations, etc.
- (5) Athletic and sound and wholesome recreational equipment is authorized to purchase in limitation of 300 yen per police official.
- (6) Unit training will be conducted to maintain readiness for action at 100% for all units to and including regimental level.
- (7) Field exercises will be conducted by ordinary regiments with attached special battalions and service units.
- (8) Regions will conduct Command Post Exercises.
- (9) One region mass movement exercise will be conducted.
- (10) 500 yard firing ranges will be provided on the basis of one range per ordinary regiment, and 300 yard firing ranges on the basis of one range per camp. Also, testing ranges will be provided at depots.
- (11) Training Aids and Training Manuals will be procured or prepared for training and exercising purposes.
- (12) In relation to the tactical type units under the regions, new camps will be established at areas most essential for defense purpose.
- (13) Training areas of 800 meters long and 500 meters wide in standard (approx. 130,000 tsubo) will be acquired on the basis of one per camp. In selection of the site, initial consideration must be on the ex-Army and Navy site which are National Government Properties.
- (14) Unit mass movement or activities must be made by foot or motor march whenever practicable.

- (15) Schools and Courses will be as follows:
- (a) Facilities for General Group School will be established in Tokyo or around the vicinity of Tokyo for training and education of 1st and 2nd class Inspectors and their candidates.
 - (b) Communication School will be set at Kurihama.
 - (c) Facilities for Medical School will be established attached to the Tokyo Central Hospital.
 - (d) Facilities for Regional Schools will be established at the location of each Regional Headquarters for training and education of ordinary type sergeants and their candidates.
 - (e) Prior to establishment of the above facilities, necessary schools or courses may be opened by using General Group, Kurihama, other camps, or depot installations, for those training and education mentioned above.
 - (f) Police officials may take necessary courses at outside agencies when deemed necessary under inevitable circumstances.
- (16) Technical Research Institute will be established in Tokyo for research and study of the standardization of the equipment, etc. Also essential research works may be entrusted to the outside agencies.
- (17) Band Units will be set up at each region.
- (18) Organizational equipment will be procured and maintained to equip all units with 100% of authorized allowances procurable in Japan (except manufactured goods imported), including a 90 day stock level in depots.
- (19) The cost of ¥80 per man per day for provision will be the standard provision funds. In addition to this, there will be available with additional rations for night duty, special training and etc. Also, prepare subsistence supplies for patients separately.
- (20) Rehabilitation of housing facilities will provide for a reasonable standard (above minimum) consistent with good health and reasonable comfort.
- (21) 2nd and 4th Regions depots will be completed.
- (22) Each depot will be provided with vehicle repair facilities for major repairs and maintenances of the vehicles.
- (23) Central repair facilities will be established at Tachikawa Depot for major repairs of communicational equipment.

- (24) Repair facilities will be established for minor shoe repair in each camp, and shoe and clothing repair facilities will be established in each depot.
- (25) Unit storage and parking space (including minimum covered parking space) will be made available for organizational equipment.
- (26) POL products for 13,000 vehicles will be necessary. Also construction of POL tanks are required for above.
- (27) In addition to Tokyo Central Hospital, hospitals will be completed in 2nd, 3rd and 4th Regions.
- (28) Medical services will be provided for by MFR facilities and personnel to the greatest extent possible, contractual medical care will be reduced to the minimum.
- (29) Dependent Housings will be made available to major portion of officers with the grade of Senior Inspectors and above, two-third ($2/3$) of all Inspector 1st Classes, and one-third ($1/3$) of all Inspector 2nd Classes.
- (30) In objectives to dependents medical care, government share in Mutual Aid Association will be calculated.

b. The present price level is the basis for entire calculation of the estimates and will not include changes in the future prices.

1. Request preliminary budget estimates for FY 1952-53 be prepared by CASA tech services and submitted to Logistics Division by 25 June 1951. These estimates will be used as a basis for recommendations to G-4 and the tech services of GGHQ for estimates to be included in the NPR budget.

2. Estimates for all tech services will include:

a. Cost of TE equipment to be procured in Japan, in accordance with Taylor Report. ✓

b. Sufficient replacements for TE equipment to maintain a 90 day depot level on 31 March 1953.

c. Maintenance, cleaning, and preserving supplies and spare parts for 100% TE equipment for the year plus a buildup to a 90 day depot level. } 16%

d. Cost of any necessary maintenance service for TE equipment, including U. S. loan.

3. In addition, the following estimates will be prepared by tech services indicated:

a. Engineer

(1) Construction of additional unit and camp storage to provide for 100% TE equipment.

(2) Provision of necessary additional parking areas and unit maintenance shops for 100% TE vehicles. (Coordinate with Ordnance)

(3) Provision of 500 yard known distance target ranges accessible to all units.

b. Quartermaster

(1) POL for all TE vehicles.

(2) Cost of transportation to distribute 100% of TE equipment, including U. S. loan equipment.

4. Include any other estimates which you consider GGHQ has insufficient information or experience to prepare.

MEMORANDUM FOR: Chief of Accounts and Supply Bureau, NPR Headquarters

SUBJECT: Preparation of NPR Budget for JFY 52-53

1. a. There are contained herein advices and information, representing CASA opinions, which may be of assistance to you in the formulation of a policy "Instruction" or "Notice" to the Chief of General Group concerning the formulation of the JFY 52-53 budget.

b. In view of the continuing development of the NPR, it must be recognized this information represents only the best available current information, based on factors known at this time.

c. As further information may become available or changes in the information herein occur, such information or changes will be forwarded to you.

2. Assumptions - The following assumptions as to the status of NPR on 1 April 1952 may be utilized as a basis for the preparation of budget estimates:

a. Mission - See Cabinet Order #260, 10 August 1950

b. Personnel:

(1) Strength will be approximately 75,000 police officials, distributed so that approximately 90% of T/O positions of Inspector 2nd Class and above, and approximately 105% of Sergeant 1st Class to Sergeant 3rd Class, are filled.

(2) Grade ceilings for police officials Inspector 2nd Class and above, and Sergeant 1st Class and under, as provided for in the approved JFY 51-52 budget, will have been reached.

(3) Personnel for a female Nurse Corps will not have been authorized nor recruited.

(4) Civilian Employees - Same number of civilian employees will be employed as authorized at present.

c. Operations:

(1) Training Status:

(a) All personnel will have received individual training.

(b) Tactical type platoon and company training will be completed.

(c) Tactical battalions will have completed training.

(d) Service type units will have completed basic technical training and minimum advanced training.

(2) Training aids and ranges will have been supplied as contained in JFY 51-52 budget program.

(3) No major training areas other than those areas available in NPR camps will have been acquired.

(4) Only minimum training manuals will have been printed.

d. Schools:

(1) GG School Center will be the only major school center for NPR; its facilities will be adequate for the conduct of staff and limited technical courses.

e. Service and Supply:

(1) Organization and individual equipment will have been procured as shown in JFY 51-52 Commodities Procurement Plan.

(2) Minimum amounts (not exceeding 90 days supply) of individual clothing and equipment will be on hand as replacements to 75,000 man force.

(3) Status of Installations:

(a) Rehabilitation of camps will not have reached a normal reasonable standard (above minimum).

(b) Storage Available:

1 Uji and Tachikawa Depots will be in operation and generally adequate to perform their mission as presently known.

2 Depots in the 2nd and 4th Regions will not be adequate to fully perform their mission.

3 Ammunition storage facilities at camp level will be generally inadequate.

(c) Miscellaneous Facilities:

1 Communications

The 4 fixed communications installations, and the Communications Center in Tokyo will not be in operative condition.

2 Medical

Tokyo Central Hospital will not be capable of providing medical care. Dispensaries in all camps will be operative. Hospital care will be by contract with civilian agencies.

3 Repair Facilities

Repair facilities (clothing, vehicles, etc.) will be in operation for minimum essential requirements only.

3. Policies and Objectives

a. The following policies and/or objectives for JFY 1952-53 may be used as a guide in the preparation of budget estimates:

(1) Recruitment of new personnel will be planned for and accomplished when necessary to maintain statutory strength.

(a) It is anticipated that a large loss of present personnel, approximately 50% in enlisted grades and 10% in officer grades, will occur in the autumn of 1952, at the expiration of the present two-year term of service.

- (b) In order to induce present personnel to remain in the NPR, and/or to attract new personnel, it probably will be necessary to offer a separation allowance.
- (c) The new separation allowance must be less than the ¥60,000 given original members of NPR. Until final determination is made ¥50,000 may be used as a planning figure.
- (2) Only athletic equipment, day room radios and games, are authorized.
- (3) Recruitment of personnel for a Nurse Corps will not be effected in JFY 52-53.
- (4) Civilian employees will continue to be employed on the present basis, that is, as utility supervisor personnel in NPR installations. Civilian personnel will not be used as laborers or janitorial personnel in headquarters, depots, or camps.
- (5) There will be no special activities funds for Information purposes.
- (6) Unit training will be conducted to maintain readiness for action at 100% for all units to and including regimental level.
- (7) Field exercises will be conducted by ordinary regiments with attached special battalions and service units.
- (8) Regions will conduct Command Post Exercises.
- (9) 500-yard firing ranges will normally be provided on the basis of one range per ordinary regiment. Battalion size camps will not normally have large rifle ranges.
- (10) Training aids may be procured where their use will result in more efficient training.
- (11) Training manuals will be provided to teach the use of present and new equipment.
- (12) Only minimum essential mass movement between camps will be planned. Regiments may move to training areas at least once a year. Whenever practicable, these moves will be made by foot or motor march.
- (13) Individual travel will be restricted to that necessary to provide essential travel for inspections, conferences, schools, TDY, permanent change of station, dependent travel, etc.
- (14) General Group School Center at Camp Kurihama will be the main NPR school. It will conduct all officer courses. Regional schools for Sergeants may be established. Technical training schools will generally be held at Kurihama.
- (15) Organizational equipment will be procured and maintained to equip all units with 100% of authorized allowances procurable in Japan, except for vehicles, including a 90 day stock level in depots.

- (16) Dependent housing will be made available for all authorized officers.
- (17) Construction of a depot and a hospital in the 2nd and 4th Regions will be completed.
- (18) Rehabilitation of housing facilities will provide for a reasonable standard (above minimum) consistent with good health and reasonable comfort.
- (19) One central maintenance facility for major repair of vehicles and communications equipment will be made operative.
- (20) Repair facilities will be established for shoe repair in each region. Clothing not economically repairable will be salvaged.
- (21) The average cost of \$2,400 per man per month for provisions will have to be increased due to increased costs.
- (22) POL products for approximately 13,000 vehicles will be necessary.
- (23) Medical services will be provided for by NPR facilities and personnel to the greatest extent possible, contractual medical care will be reduced to the minimum.
- (24) There will be no change in base pay and allowances of NPR personnel, unless general increase is given to all government employees.
- (25) Provision of unit storage and parking space for organizational equipment.
