1. Reference is made to the request dated 5 August 1963, subject as above, whose name you desired checked against the files of this office. The files contain the following information concerning Subject, and one who is probably identifiable with Subject.

2. Subject is REG-355; a returnee from Marfino and various PW camps.

3. According to information from the files of a predecessor organization, sources not indicated, one Dr. Fritz BAYER, born 31 May 1891, was, as of 9 November 1937, a non-commissioned officer in the Security Service of the SS (Nazi elite guard), SS number 19113.

4. For further information concerning Subject, you are referred to the Federal Bureau of Investigation.

5. [redacted] has no record of a current operational interest in Subject.
