


#### PREFACE

LITTLE has found its way into history relating to the Barnes Family in America. Such as has been published has resulted in many errors, and given rise to false impressions. It has been the life work of the author to trace, generation by generation, the descendants of those ancestors of the Barnes name who settled in Connecticut during the first half of the seventeenth century, embracing branches of relationship so very remote that almost all traces had become obliterated. The similarity of names running through families living near each other, has made his task a most difficult one, and only by close comparison and patient study has he been able to separate one individual from another bearing the same name and age, and from the same locality. Many will, no doubt, find he has traced their relationship to ancestors unheard of.

He has traced forward from the ancestor, step by step, rather than by the reverse, or backward process, until the living representatives of their different lines have been found. By this method he has been able to solve many stubborn problems, though not without many years' delay, and leaving others to occupy his attention.

He does not claim perfection for his work, but desires to present for preservation what he has, and asks the further co-operation of all, that all errors may be corrected, so when the time comes for a general history of the Barnes family to be published, it may be perfect in every respect and worthy of our greatest effort.

He contemplates making this pamphlet one of a series to appear annually, which shall include all records pertaining to all branches of the Barnes name and blood.

To our earlier genealogies and local histories, we owe almost everything; we have freely borrowed information, but have endeavored to verify them by individual research and investigation. If he has eliminated errors and opened family lines whereby others may gain an opportunity to go still farther toward perfecting them, his work will surely not be overlooked or forgotten, but as an association, it will be continued hand in hand with all who truly yearn for the preservation of family lines and traditions.

#### THE BARNES FAMILY ASSOCIATION

This is an association of members of the family for the object of cultivating a better acquaintance and a more social relationship between all, as well as for making a united effort for the collection and preservation of records and history of the family, as expressed in Art. III of their Constitution, reading as follows:

"The object of the Association shall be the collection and preservation of all genealogical records, the tracing of family lines, traditions and like matters of interest, all with a view to their ultimate publication in endurable form. We propose an active and aggressive campaign toward that end, that we may hasten the time when we can present to the public, a history of our family worthy of the undertaking."

This organization was perfected at New Haven, Conn., on the 4th of June, 1903, in answer to a call sent out by the author. An annual meeting and a general reunion of all of the Barnes blood is held on the third Thursday of August each year; all are invited to the reunion, but only members of the association participate in the business. There is a fee of fifty cents for annual membership, or five dollars for life, which enables the association to continue a correspondence for collecting records, but not sufficient to employ professionals to copy records which are known to exist on the records of almost every town, Church and Probate. We earnestly solicit such records as contributions, by our members and friends. Let the name of every person by our name, or bearing our blood, be placed in our keeping, and let us have a record of every death with a brief life sketch. It is hoped that the entire family will unite with the association and lend their encouragement to our undertaking.

#### BARNES HISTORY

THE name "Barnes" it is said was derived from the Norse "Bjorne," meaning warrior, and was brought to England with William the Conqueror, being the name of his trusted aide. The Norsemen were true-hearted, daring, and brave, and their blood is a heritage most highly prized. The names Barn, Barne, Bern, Berners, Barnard, Bernard, and others, have the same origin as Barnes. The family became numerous and spread through Great Britain and her colonies. It has been no part of the work of our historian to extend researches to the mother country, hence our information from the family there is merely incidental, but enough to show that they were numerous and influential, and as the name implies, true soldiers.

The Barnes family gave a Lord Mayor to London—Barnaby Barnes, a poet, whose father was Bishop of Durham. William Barnes received lands from Henry VIII. in the royal forest of Tillingham. Dame Juliana Bernier, who also wrote her name Barnes and Bornes, was a celebrated writer in the fourteenth century, and a copy of one of her works sold in London some years ago for three thousand dollars. Her father was created a Baron by Henry IV.

Burke gives seventeen different Coats of Arms for respective houses of the Barnes family, and five others for Barne. The lion, unicorn, greyhound, falcon, and leopard are prominent symbols displayed.

It is most likely that the name as transmitted to America, came by representatives of lines extending back many generations in England to a common ancestor. Here they have borne their share of the adventure and hardships experienced in clearing, and building up a great country, in conquering a savage hoard, and exterminating wild beasts. Coming carly to our eastern shore, they have swept back with each succeeding wave of civilization, foremost in every hazardous expedition requiring nerve and sinew for success. Foremost in cultivating and making productive the soil, foremost in preparing and protecting homes for the benefit and comfort of their posterity, they have permeated the whole land, have entered into all trades, and have been honored in all professions. As a family they have been strictly industrious. They have shunned speculative schemes as detrimental to the well-being of their fellowmen, and have chosen to render honest labor for their livelihood, rather than wring it from their neighbors in mercenary trade. They have ever been loyal to the spirit of freedom, borne to our New England shores by the Pilgrim ancestors. Obedient and stubborn soldiers, they have stood upon the field of battle in every hour of peril and sailed on privateers to meet invading foes. The only places we fail to find the name is on the rolls of the prison and the almshouse.

#### SOME IMMIGRANT BARNES

1 THOMAS BARNES came to the colony of Massachusetts and settled at Hingham, Mass., abt. 1634; believed to have been a son of Roland. He was b. in England in 1602 and d. in Hingham, Noy. 29, 1672. He received a grant in a land distribution in 1637. He was probably m. in Mass. abt. 1640. His wife Anna d. Apl. 5, 1691. Her family name is not known to us. They had seven ch., all b. before 1655, four sons and three daus. One dau. d. in infancy; one son is believed to have been a bachelor; the remainder, three sons and two daus. probably all left descendants, who have multiplied during the years, and are now represented in every part of our great Commonwealth. It has been no part of the author's work in past years to attempt to trace this branch, but we accept them as worthy representatives of those Puritan ancestors, and shall henceforth devote an equal effort to trace and preserve a genealogical record of this family.

2 THOMAS BARNES, whom we designate as "Thomas of Hartford," is claimed by many to have been the first of the name in America. No reference is found to him elsewhere than in Hartford, but he, without doubt came first to Mass., thence to Hartford, with, or soon after, the first settlers. He was one of the soldiers in the Pequot Battle, and received land grants of the Colony for that service—in 1639 six acres in Hartford,—and later was alloted 50 acres in Farmington, where he settled with the first party in 1646, and there resided, sharing in all the land distributions until the time of his death, 1688. (Farmington, at this early period, included the territory of Southington, New Britain, Plainville, Bristol, Burlington, and Avon of the present day.)

Thomas Barnes' first wife Mary (family not obtained), whom he married perhaps soon after he removed to Farmington, was charged with witchcraft and summoned before the General Court, where she was convicted (see Colonial Records, 1658), and most certainly executed. She left two sons and a daughter. He soon after m. second, Mary Andrus of Farmington, by whom he had two sons. Each of his ch. left a numerous posterity, who have moved westward with each advance of the adventurous pioncers, until the rivers, lakes, plains, and mountains have been passed by succeeding generations. Not even the mighty ocean on our west has checked the onward march of many. It is claimed that the ancestry of this branch has been traced back in England some five or six hundred years, but the connection does not appear sufficiently authentic to make it desirable that it be published in this volume.

3 THOMAS BARNES, hereafter referred to as "Thomas of New Haven," came to New Haven when still a boy, and no mention is found of his name until about 1644, when he became of age, and shared in the land distribution. (Savage confused the Thomases, assuming several different persons to have been one individual.) Thomas of New Haven m. abt. 1647, Elizabeth, whose family name has not been found. She appears to have been his only wife. They resided in New Haven until 1660 or 1665, then they moved to North Haven, and later to that part of Middletown, now Middlefield, where he d. in 1693. They brought up a family of eight ch. all of whom are supposed to have left families who have transmitted the Barnes blood through a dozen generations, and perhaps are at the present time the most numerous and widely distributed branch of the family in America.

4 THOMAS BARNES, came to America in the ship "Speedwell" in 1656, settled in Marlborough, Mass., and m. Abigail Goodnow. Their family of four boys and two girls all left descendants, who have become numerous and influential throughout our land, and will be followed in a future work.

5 WILLIAM BARNES, son of William of Eastwich, England, prob. came first to Mass., thence to Long Island, where he settled at Easthampton as early as 1644. He is generally supposed to have been the ancestor of most of those of the Barnes name from that place; but with present light there are reasons to cast doubts upon that supposition. William is said to have been the oldest son of William of Eastwich, and under English law would have succeeded to the inheritance; whereas, it is shown that his brother Charles took the inheritance from his father in 1658. No mention is found of a wife of William, or any record of his m. A record is found of the d. of William Barnes in Guilford, Conn., in 1646, a young man, of whom no other mention is made, and the theory is entertained that William of Southampton was the William who died, thus leaving Charles as the oldest son, in 1658.

6 CHARLES BARNES, brother of William (No. 5.) He and William are supposed to have come together to Easthampton. He is known as "Charles the schoolmaster," having been the first schoolmaster in Easthampton. After the death of his father, he executed the power of attorney for his wife to take possession of his inheritance in England, and a few years later returned there to live. No record of their family has been found, but the evidence is conclusive that there were ch. b. there to one of these brothers during 1644 to 1655. It is a tradition among their descendants that they trace back to Charles.

7 JOSHUA BARNES, a younger brother of William and Charles, came first to Mass., then to Easthampton, L. I., and resided there, or at Southampton, where he d. abt. 1690. He was twice m. and his wives' given names were, first, Prudence, second, Amy. He left two sons.

8 JOHN BARNES was in Plymouth, Mass., in 1634. His son Jonathan m. Eliza Hedge. They had ten ch. (See *Hist. of Bridgewater.*) John is probably the ancestor of many of the Barnes name in that section, also Rhode Island and Eastern Conn.

9 RICHARD BARNES came to America in 1639 on the ship "Jonathan," at the age of ten years, with his mother and stepfather, Thomas Blanchard. His grandmother, Agnes Bent, was of the party, also. They settled in Sudbury, Mass. In 1657 he went to Marlborough, Mass., where he m. abt. 1668, Deborah, widow of Leonard Dix. He settled south of the Pond, his estate remaining in the family through many generations. He had five ch., four of whom left descendants.

10 JOHN BARNES was probably a brother or cousin of Thomas of Marlborough (No. 4.) He settled in Marlborough, Mass., where he m. in 1664, Johanna ———, who d. Oct. 29, 1712. He d. Sept. 8, 1715. He probably had no ch. as his estate was willed to the ch. of Thomas, his kinsman.

11 ABRAHAM BARNES, son of Richard of Carshalton, England, was b. abt. 1665. He came to America, where he had a son Abraham, who settled near St. Mary's, Md., and two sons and two daus. were born to him. Neither of the sons married.

12 GEORGE BARNES AND BROTHER CHARLES BARNES, gt. grandsons of Richard of Carshalton; their father Charles, was son of Richard, Jr., a brother of Abraham (No. 11.) In 1795 they came to America, leaving the Barnes names extinct in Carshalton; settled in Georgetown, Md. George soon removed to Springfield, Ky.; was twice m.; had ten ch., most of whom died young.

14 JAMES BARNES, son of William of Norwich, England, was impressed into the British army during the Revolution and sent to America; was taken prisoner by the Americans at the Battle of Saratoga, and probably sent to the old Newgate prison in Granby, Conn. He refused to be exchanged or returned to England. He m. in Conn., and removed to Wilkes-Barre, Penna.

15 JOHN BARNES came to America some time prior to the Revolution, and settled at Shepardstown, Va. He served during the Revolution, from Virginia, as a captain; received a shot during the battle which broke one of his legs, laming him for life. He later moved to Ohio. His descendants claim him to have been one of the three first persons to sail on a steamboat.

16 JOSEPH BARNES, brother of Capt. John Barnes (No. 15), settled in Shepardstown, Va.; claimed to have been the inventor and maker of the first steamboat that sailed against the current. After the first trip of his boat, which carried himself, brother and Rumsev, the mechanic, up the James River, he went to England for more skilled mechanics to build a larger yessel. About this time it was against the law to take mechanics to America, and he was seized in England and never permitted to return. Rumsey, therefore, claimed the invention as his own. A man named Fitch saw his opportunity, and he also claimed the invention. A long controversy ensued, and Fitch, by more powerful influence at the Capitol, is said to have had the advantage, but neither had the honor of sailing his own boat. Fulton was permitted by friends to examine the mechanism and measurements of Barnes' boat, stored in the barn of Capt. John Barnes, and afterward made and sailed the first steamboat of history.

Joseph Barnes had a son who went back to his father in England. He also had a dau. who remained in America. The mother had previously died.

17 HENRY BARNES, brother of John (No. 15) and Joseph (No. 16), came to America with them. He served in the Revolution as a captain; afterward moved to Tenn. Nothing is learned of his family. Susannah Barnes, a sister of the above brothers, also came to America. She was mother, or grandmother of Gov. Lucas of Ohio.

18 ROBERT BARNES came to America during the Revolution; settled in Lancaster Co., Penna. He had two sons and seven daus. One son and two daus. remained unm. Very little is known of the descendants.

19 JACOB BARNES, b. in England more recently than the others; came to New York and settled in Kingston, where he lived and d., leaving two sons and three daus. The daus, all d. unm.

20 JAMES BARNES of Branford, came since the close of the Civil War, with his two sons, to America. 21 WILLIAM H. BARNES, b. in England. Soon after 1800 he came to America. Had two sons and a dau.

22 JOHN BARNES came from Ulster Co., Ireland, about 1760 to Albany Co., N. Y.; soon removed to Western Pennsylvania. His descendants are said to be quite numerous in some sections of the west.

23 HENRY BARNES, b. in England in 1816, came to America and settled in Michigan.

24 JOHN BARNES, b. in England, came to Montreal while still a boy, about 1850. After his marriage he settled in Indiana.

25 JONATHAN C. BARNES of Accrinton, England, m. Jennie Rigby. They came to America about 1860 and settled in Philadelphia.

26 WILLIAM BARNES, b. in Dublin, Ireland in 1814, of Irish-English parentage, came to America when 21 years of age, settling in Pittsburg, Penna. He moved to Illinois later, where he died in Freeport in 1896. Two daughters are living in Kansas.

# THE BARNES FAMILY OF LONG ISLAND

The record of this family goes back to Edward Barnes of Eastwieh and Lyme Regis, Dorset County, England, whose son, William, b. 1580 and d. 1657, was the father of the pioneers who later eame to Long Island. William m. first, Thomasina Howell, dau. of Richard Howell, and m. second, Thomasina Shepard, dau. of Owen Shepard, Esq. By his first marriage he had five daus., whose names are unknown. Her father, Charles Tuttle <sup>5</sup> was the second of six ch. of Charles <sup>4</sup> and Rosetta (Case) Tuttle, b. Sept. 16, 1791; d. Jan. 7, 1875; resided in Barkhamsted, Conn., farmer and drover. Frances's grandfather, Charles Tuttle <sup>4</sup> was the sixth of eight ch. of Jehiel and Charity (Dayton) Tuttle; b. June 30, 1762; d. 1800; a farmer in Barkhamsted. Her gt. grandfather, Jehiel Tuttle <sup>3</sup> was the fifth of nine ch. of Deborah (Barnes) Tuttle, and her first husband Josiah Tuttle. She was b. June 5, 1727; d. Oct. 8, 1781. He was one of the early settlers in the town of Barkhamsted; was there in 1770. Her gt. gt. grandmother, Deborah Barnes <sup>2</sup> was the teuth of fourteen ch. of Thomas, the third ch. of Thomas Barnes of New Haven. She was b. Feb. 1, 1698; m. second, Matthias Hitchcock.

(Thompson) Barnes of New Haven; b. ——; m. Charity Hyde; no ch. His father Samuel H.<sup>6</sup> was fourth of eight ch. of William S.<sup>5</sup> and Sarah (Hunt) Barnes. They reside in New Haven. His grandfather, William S.,<sup>5</sup> was youngest of cleven ch. of Samuel <sup>4</sup> and Lucy (Hale) Barnes. b. 1811, and m. first, Rebecca Hart. His gt. grandfather, Samuel <sup>4</sup> was fifth of seven ch. of Daniel <sup>3</sup> and Sarah (Sackett) Barnes, b. 1765. His gt. gt. grandfather, Daniel <sup>3</sup> was the oldest of six ch. of Daniel <sup>2</sup> and Abigail (Heaton) Barnes, b. Nov., 1725; d. Apl. 20, 1809. His gt. gt. gt. grandfather. Her father, Jairus H.<sup>7</sup> was youngest of six ch. of Joseph<sup>6</sup> and Huldah (Bartholomew) Barnes; b. in New Hartford, Conn.. Nov. 18, 1808; d. in Meriden, Conn. Her grandfather, Joseph<sup>6</sup> was second of four ch. of Joseph<sup>5</sup> and Elizabeth (\_\_\_\_\_\_) Barnes; b. abt. 1765. (Rufus Barnes, father of Rev. Albert Barnes, author of Notes on the Bible, was a bro. of Joseph<sup>5</sup>) Harriet's gt. grandfather, Joseph<sup>5</sup> was undoubtedly one of the older sons of Ebenezer<sup>4</sup> and Abigail Barnes; b. in Branford, Conn. Benjamin<sup>3</sup> was second of eleven ch. of William,<sup>2</sup> sup. son of Charles of Long Island, the schoolmaster.

Her grandfather, Richard Wheaton Barnes was the fourth of seven ch. of Joseph and Huldah (Bartholomew) Barnes, b. in New Hartford, Conn.; resided in West Hartford; continues same line as No. 20.

25 SHELDEN B. THORPE, North Haven, Conn., son of Dennis and Elmira (Bassett) Thorpe; b. Feb. 21, 1838; is Viee-President of the Barnes Association; author of the "North Haven Annals;" prominent in the G. A. R., etc. (Portrait with life sketch reserved for a future number.) Shelden is of the seventh generation from Thomas Barnes of New Haven, his mother being a dau. of Jared and Sukey (Miller) Bassett. His grandmother, Sukey Miller, was a dau. of Hezekiah and Sarah (Bradley) Miller. His gt. grandmother, Sarah Bradley, was a dau. of Joel and Miriam (Robinson) Bradley. His gt. gt. grandmother, Miriam Robinson was the youngest of four ch. of John and Mary (Barnes) Robinson, b. Dec. 1, 1731. Mary Barnes was the fourth ch. of Daniel and Mary Tappen Barnes.

26 ISABEL JANE (BARNES) THORPE, wife of Shelden B. of the sixth generation from Thomas Barnes of New Haven, and of the eighth generation of the Long Island race. She was b. Nov. 18, 1843; m. Dec. 25, 1865, Shelden B. Thorpe. They have two sons. She was the youngest of four ch. of Daniel and Jane (Barnes) Barnes. Her father, Daniel Barnes was the sixth of eleven ch. of Samuel<sup>4</sup> and Luey (Hale) Barnes of the New Haven line; b. Mch. 13, 1799. Continues line given in No. 16.

From the Long Island line, Isabel's mother, Jane Barnes, was the fifth of seven ch. of Lyman<sup>6</sup> and Bede (Brockett) Barnes, b. Ang. 25, 1809. Her grandfather. Lyman<sup>6</sup> was the oldest of eight ch. of Ebenezer<sup>5</sup> by his first wife Luranda (Shattuck) Barnes, b. in North Haven, July 22, 1774. Her gt. grandfather. Ebenezer<sup>5</sup> was the oldest of seven ch. of Ebenezer,<sup>4</sup> b. Sept. 30, 1743. Same line as No. 20.

27 WILLIAM BARNES, Albany, N. Y., descendant of Thomas Barnes of Hartford, in the sixth generation; the oldest of five ch. of Orson<sup>5</sup> and Eliza (Phelps) Barnes; b. May 26, 1824; m. July 10, 1849, Emily Peck Kempshall. She was b. Oct. 10, 1827; d. Feb. 10, 1889. He m. second. June, 1891, Lizzie Balmer; has two sons and three daus.; prominent in public affairs. His father, Orson<sup>5</sup> was the youngest of three ch. of William<sup>4</sup> and Sarah (Willard) Barnes. Their only son, he was b. Mch. 26, 1802, at Pompey, N. Y.; d. Aug. 6, 1852; was Superintendent of Schools of Onondaga Co., N. Y., in 1843 and 1844. His grandfather, William<sup>4</sup> was ninth of eleven ch. of Phineas<sup>3</sup> and Phebe (Bement) Barnes, b. in West Stockbridge, Mass., Dec. 26, 1771. His gt. grandfather. Phineas<sup>3</sup> was third of eight ch. of Thomas<sup>2</sup> and Hannah (Day) Barnes, b. in Southington, Conn., July 7, 1730; m. and lived in Southington until 1770, then moved to West Stockbridge, Mass, and late in life to Pompey, N. Y. His gt. gt. grandfather, Thomas<sup>2</sup> was second of sixteen ch. of Ebenezer,1 youngest son of Thomas Barnes of Hartford. He was b. June 21, 1703; d. abt. 1744.

28 MARY ANN (RICE) GRUBER, Hartford, Vt., descendant of Thomas Barnes of New Haven in the eighth generation. She was third of nine ch. of Anson<sup>7</sup> and Hannah (Dayton) Rice, b. in Torringford, Conn., Mch. 25, 1853; m. Dec. 25, 1873, John Gruber, a woolen manufacturer. They have one dau. Her father, Anson<sup>7</sup> Rice was the only surviving ch. of Reuben and Emily<sup>6</sup> (Barnes) Rice. Her grandmother, Emily Barnes<sup>6</sup> was second of ten ch. of Anson<sup>5</sup> and Martha (Mills) Barnes, b. Nov. 9, 1806; d. in Beacon Falls, Conn., of cancer, abt. 1878. Her gt. grandfather. Anson<sup>5</sup> was the oldest ch. of Israel<sup>4</sup> and Susannah (Hill) Barnes, b. in Bristol, Conn., Mch. 1, 1783; d. Apl. 16, 1827, in Barkhamsted. Conn. For line from Israel Barnes<sup>4</sup> see No. 12.

Mrs. Gruber takes an active interest in genealogical research. She was the first woman to subscribe as a life member of the Barnes Family Association, and the first person to make a donation to assist in defraying the expenses of collecting these records. She traces back to many of the foremost of the Pilgrim ancestors of New England. Among her ancestors were Francis Bell, one of the first settlers of Stamford, Conn.; William and Jonathan Tuttle, early of New Haven; the Rev. Peter Buckley, who is closely connected with the history of Concord, Mass., having bought the land of the Indians, and named it after his English home. He was known as the "father of the flock," and was the minister who addressed the troops before the battle of Concord, where were fired the guns heard around the world. Justus and Michel Dayton served during the Revolution. Israel Barnes was in the Conn. Regiment of Artificers, a favorite troop with Washington, and which at his request accompanied him on his southern tour. Mrs. Gruber lived in Johnston, Pa., at the time of the flood; she opened her house to receive the victims, and devoted herself to the care of the sufferers.

29 SAMUEL D. BARNES, Denver, Col. Attorney-at-law; in the seventh generation of the descendants of Thomas Barnes of Hartford; third of five ch. of Charles Montgomery 6 and Ellen (Moore) Barnes. His father, Charles M.6 was second of eight ch. of Rev. Romulos <sup>5</sup> and Olivia (Denham) Barnes, b. Sept. 18, 1833; graduate of Knox College, 1856; studied theology at Andover, Mass., and Chicago; entered the army as chaplain. Poor health and the loss of his voice compelled him to abandon the ministry, and he went into the book trade in Chicago. His grandfather, Rev. Romulus<sup>5</sup> was ninth of twelve ch. of Daniel Barnes,<sup>4</sup> [and seventh ch. by the second wife, Sarah (Webster) Barnes], b. Oct. 16, 1800; d. Sept. 24, 1846; studied at Amherst and Yale; graduated in 1828. He labored extensively as an evangelist in Ill. His gt. grandfather, Daniel<sup>4</sup> was fourth of eight ch. of Daniel<sup>3</sup> and Rachel (Bird) Barnes of Bristol, Conn., b. July 31, 1752; m. first, Jan. 13, 1773, Jerusha Webster, and second Nov. 23, 1785, her sister Sarah; a life-long resident of Bristol. He was a captain in the Revolutionary Army; was sunstruck at the battle of Monmouth, N. J., and never recovered good health. He d. Feb., 1814. His gt. gt. grandfather, Daniel<sup>3</sup> and second son of Ebenezer,<sup>2</sup> b. Oct. 4, 1723; d. in Bristol, Oct. 4, 1763. His gt. gt. gt. grandfather, Ebenezer<sup>2</sup> was the oldest son of Ebenezer<sup>1</sup> and Deborah (Orvis) Barnes; b. Feb. 7, 1700; brother of Thomas<sup>2</sup> (No. 27).

30 MARY K. THOMPSON, Winsted, Conn., of the seventh generation from Thomas Barnes of New Haven; the only surviving ch. of Warren A. and Katherine V. (Hunt) Thompson of Winsted; b. May 2, 1863. Her mother was dau. of Charles J. and Urania (Bentley) Hunt, b. Sept. 8. 1840. Her grandfather, Charles J. Hunt, was son of Rufus and Eunice (Barnes) Hunt, b. Oct. 10, 1805; d. Nov. 3, 1895. Her gt. grandmother, Eunice Barnes was fifth ch. of Phineas and Mercy (Provin) Barnes of West Grenville, Mass. Her gt. gt. grandfather, Phineas Barnes, was eighth of eleven ch. of Ebenezer and Mehitable (Miller) Barnes, b. Aug. 12, 1744. (Same line as in No. 2.)

JAMES LINCOLN CHAPMAN, died in Chicago, July 14, 1904. He was born Jan. 26, 1824, in Marcelles, N. Y.; married March 4, 1857, Agnes Josephine Barnes, only child by first marriage of Wilbert Barnes, and sixth in descent from Thomas Barnes of New Haven. Mr. and Mrs. Chapman had five children: Minerva J., b. Dec. 6, 1858, unmarried; Wilbert B., b. August 1, 1865, married and residing in Chicago; Blanche C., married and residing in Watertown, N. Y.; Irving E., b. October 2, 1869, d. 1881; and James L. Jr. Wilbert Barnes (above), b August 12, 1810, d. Feb. 26, 1879, was the third of six children of Manning and Lucy (Northrop) Barnes of West Camden. Manning Barnes was the third of seven children of Zopher and Mary (Barnes) Barnes, b. Oct. 15, 1780, d. Dec. 31, 1856, at Camden, N. Y. Mary, wife of Zopher Barnes, was a daughter of Capt. Joshua and Deborah (Woodin) Barnes of North Haven, Conn., b. in 1754, d. in Camden, N. Y., in 1820. Capt. Joshua Barnes, was b. Jan. 11, 1722-3, son of Thomas,3 Thomas,2 Thomas 1 of New Haven. Zopher Barnes above was son of Ebenezer,4 Ebenezer,3 Deacon Benjamin,2 William,1 b. Easthampton, L. I., 1644.

RUTSON RODMAN BULLOCK, b. in Bennington, N. Y., Jan. 13, 1819, died at State Center, Iowa, Aug. 25, 1904. He married Rebecca H. Barnes, Nov. 19, 1848, who survives him with three sons and one daughter.

ALBERT GALATIN BULLOCK, b. March 25, 1830, d. in Saratoga, Wyo., March 25, 1905; m. August 22, 1853, Sarah Jane Barnes; left three daughters. Rebecca H. Barnes, b. Nov. 27, 1827, and Sarah Janes Barnes, b. Feb. 1, 1834, were daughters of Stephen and Margaret (Walker) Barnes. They were born in Conneaut, Penna., and were of the seventh generation of descendants of William of Long Island, viz.: Stephen,<sup>6</sup> Abijah,<sup>5</sup> Moses,<sup>4</sup> Danicl,<sup>3</sup> Dea. Benjamin,<sup>2</sup> William.<sup>1</sup>

ALLEN BARNES, b. in Barkhamsted, March 3, 1816. d. at the home of his son, Sherman A. Barnes in Winsted, Conn., Dec. 17, 1906, he being the last surviving of the children of Anson and Martha (Mills) Barnes, outliving his sister, Mrs. Martha Messenger only three weeks. His whole life of over ninety years, had been spent in the immediate vicinity, and his death was caused by a general breaking down of his system only a few weeks previous. His illness was free from pain, and his death was very peaceful. On his father's death, when Allen was 11 years old, he was taken by Jared Deming in the Sandy Brook district of Coldbrook, with whom he remained until he bought for himself a farm on which he remained for seventy years. He was the father of ten children; only two of them surviving him, Sherman A. of Winsted, and Clifford W. of Glen Brook, Conn. Besides these he leaves five grandchildren, three great-grandchildren and many nephews and nicces to mourn his loss. A respected citizen has passed away; a strennous life of nearly a century has ended to be restored again, we trust, at the last great day when the Master calls "Come Home."

JOHN BARNES McQUEEN, b. March 13, 1850, d. April 16, 1904, in New Haven Conn., was the only son of Samuel and Susan E. (Barnes) McQueen. He leaves a widow and son, one sister and an invalid mother to mourn his loss. He was in business in New Haven and was a sergeant in the second company of Governor's Foot Guards. He was a descendant of Thomas Barnes of New Haven in the seventh generation, and married, June 10, 1873, Martha E. Baldwin of Whitneyville. His mother, Susan E. Barnes was the oldest of two daughters of Jared and Sally (Hemingway) Barnes, b. May 12, 1825; his grandfather, Jared Barnes, Jr., was son of Jared and Silence (Brockett) Barnes of North Haven, b. Jan. 15, 1795, d. Jan. 14, 1828. His great-grandfather was a Revolutionary patriot, son of Capt. Joshua and Deborah (Woodin) Barnes, whose line has been given.

MRS. LUCY ESTELLE (HILLS) BARNES, widow of John J. Barnes, an honored member of the Barnes Family Association, died at her home in Southington, Conn., March 22, 1905. Her husband was a descendant in the eighth generation from William Barnes of Long Island, and was a life-long resident of Southington, being a farmer and fruit-grower. Mrs. Barnes was a very talented and influential woman, a leader in all benevolent movements, and a member of the Grange in Southington; in recognition of her abilities, she was made lecturer of the State Grange, in which position she rendered valuable assistance to the order. She was a woman beloved and honored in every walk of life, and her loss will be lamented wherever her name has been recorded and her genial presence known.

MRS. MARTHA (BARNES) MESSENGER, widow of Horace Henry Messenger, whose life was sacrificed in the prison pen at Andersonville during the Civil War, died at the home of her daughter, Mrs. Erastus Hart in New Britain, Conn., Nov. 23, 1906, in her 84th year, after a long and useful life. She was born in Barkhamsted, Conn., July 9, 1823, youngest but one of the ten children of Anson and Martha (Mills) Barnes. Her father died before she had completed her fourth year, and she shared the hardships of the large and industrious family in its early trials. Married in 1841 she was the mother of eight children, only two of whom survive her; her only son died at the age of fifteen from wounds received from the accidental discharge of his gun while hunting; one daughter died in infancy, the others grew to womanhood and married. S. A. Barnes, her nephew, writes, "The home of Aunt Martha in Barkhamsted was the Mecca for family gatherings, as she was a royal entertainer, endowed with social qualities rarely attained. Surrounded by her own family, with the large families of her brothers and sisters living near, I well remember the delightful times we used to enjoy at her fireside listening to the old-time melodies as they were sung by the children, who were all natural musicians, having inherited the talent from their mother who was proficient in both vocal and instrumental music." Of her brothers and sisters, only one, Allen Barnes of Winsted, survived her, and he only by three weeks. Both attended the Barnes Family Reunion at Lake Compounce in 1903, and were the oldest persons in that gathering; we remember them as active and social. Their father, Anson Barnes, was the oldest son of Israel and Susannah (Hills) Barnes, b. March 1, 1783, whose ancestral line has been given.

LAURA ANN (BARNES) HINE, widow of Harry Boardman Hine, daughter of Joshua, and second wife Mary (Alvord) Barnes, b. Feb. 2, 1815, d. Sept. 23, 1904. She married Mr. Hine, June 18, 1838; he died in 1884. They had six children: Willis W., b. March, 1839, died young; Harriet C., b. July 12, 1842; Ellen Marie, b. April 12, 1844, wife of Rev. Egbert Anson Breman of Schenectady, N. Y.; Bernard J., b. 1847, died young; Amelia I., b. 1849, died young; and Laura A., b. 1861. Joshua Barnes, father of Mrs. Hine, was a resident of Ferrisburg, Vt., son of Joshua Barnes, who moved from New Fairfield, Conn., supposed to have been a descendant of the Long Island ancestors who moved to Westchester Co., N. Y.

MRS. CLARRISSA (BARNES) CARTER, widow of William

W. Carter, d. in Bristol, Conn., March 30, 1905. She was the third of five children of Amos and Esther (Danks) Barnes of Southampton, Mass., b. Aug. 18, 1814. She was married in Farmington, July 20, 1841, by the Rev. Noah Porter to William W. Carter, who died in 1894. They settled in Bristol. She was never blessed with children, and had few near relatives. She belonged to the Advent Church in Bristol, to which she gave liberally.

WILLIAM D. BARNES, a life-long resident of the town of Newburg, and one of the most prominent citizens, died at his home in the district of Middle Hope, Oct. 18, 1904. We quote from the Newburg Journal: "Mr. Barnes early devoted himself to the culture of small fruits, and for many years has been an accepted authority on horticulture. He was a member of the Eastern New York Horticultural Society from its organization; a member also of the Western New York Horticultural Society, and of the Newburg Bay Society. He was a man of education, and a great reader. His knowledge of agricultural and horticultural matters was extensive, and gained for him a widespread reputation. He was an easy and ready speaker, and his thorough knowledge of his subject always commanded the close attention of his listeners. He was prominent in public affairs, and held many offices of trust and honor, among which was that of Almshouse Commissioner of the town and city of Newburg. It was largely through his influence that the Children's Home was established, and he drafted the plans for its management.

"Under Governor Flower, Mr. Barnes received an appointment on the Board of Control of the N. Y. State Agricultural Experiment Station at Geneva, which position he honored for six years. Governor Odell appointed him as a State delegate to the National Farmers' Congress, which met in the west. He was closely connected with the Orange County Agricultural Society, of which he was for many years Vice-President and Superintendent of the fruit department."

Mr. Barnes was a descendant of the Long Island Family. His father was born at Litchfield, Conn. His ancestral line will be given from his son in a succeeding number of our publication. He was b. in Newburg, N. Y., Oct. 16, 1828; m. Jan. 25, 1860. Elizabeth Carpenter, who d. Jan. 29, 1890. They had five ch., Edwin W., who succeeded to his father's business; Mary, who married and resides at Marlborough, N. Y.; George D., who lives in St. Louis, Mo.; John S., living at Newburg, and Nathaniel H. who d. in 1886.

AMON BRADLEY, one of the oldest and most prominent eitizens

of Southington, was born in that town, Feb. 20, 1812, and traces his ancestry back to Isaac and Elizabeth Bradley of Branford, Conn. The name of Isaac Bradley first appears on the Branford records in 1674, where he is mentioned as a "sojourner at New Haven," and the town granted him a house lot of two acres at Canoe Brook. In 1683 he removed to East Haven, where he died Jan. 12, 1713, aged 62 years, and his wife died Jan. 3, 1713, aged 56 years.

Samuel Bradley, son of Isaac, was born in 1686, and was married Jan. 17, 1715, to Sarah, daughter of Jacob Robinson of East Haven.

Daniel Bradley, son of Samuel, and the grandfather of our subject, was married Nov. 28, 1751, to Sarah Judd, daughter of Benjamin and Sarah (Hollister) Judd of Glastonbury. She died Nov. 19, 1764, after giving birth to her sixth child, the father of our subject, by reason of which he was called Ichabod. In 1774 these children became heirs to a large property from the grandfather, Benjamin Judd. Daniel Bradley was again married Feb. 12, 1767, his second union being with Mehitable Hemingway of East Haven. He lived in East Haven until 1779, when he removed to Southington, where he subsequently purchased a large farm, and there made his home until 1798, when he removed to Litchfield.

Ichabod Bradley, father of our subject, was born in East Haven, Nov. 10, 1764, and was married, Nov. 27, 1788, to Miss Abigail Moore. The founder of the Moore family in the New World was Deacon John Moore, who settled in Dorchester, Mass., in 1630, and removed to Windsor, Conn., with the first settlers, about 1635. He frequently served as juror, and was deputy to the General Court from Windsor in 1662, 1665, 1667 and 1674. He lived in that part of Windsor now known as Simsbury, and died Sept. 18, 1677. His son, John Moore, was born in Windsor, Dec. 5, 1645, and died there. On Sept. 21, 1664, he married Hannah Goffe, who died April 4, 1697, and on Dec. 17, 1701, he married Martha Farnsworth. His son, John Moore, was born in Windsor, June 26, 1665, and married Abigail Strong. Their son John, the grandfather of Mrs. Ichabod Bradley, was born March 21, 1694, and died at Lake George, N. Y., Aug. 12, 1758. On Dec. 2, 1724, he married Abigail Stoughton, a daughter of Capt. Thomas and Abigail (Edwards) Stoughton; the latter was a sister of Rev. Timothy Edwards, the father of the celebrated Dr. Jonathan Edwards. Roswell Moore, the father of Mrs. Bradley, was born in East Windsor, May 17, 1728, and located in that part of Farmington now known as Southington, June 30, 1775. He married Desire Dunham, daughter of Gideon Dunham, formerly of Martha's Vinevard. He died Dec. 13, 1794. In 1779 Ichabod Bradley came with his father to Southington, where he successfully engaged in farming throughout the remainder of his life. He died Oct. 13, 1832, aged 68 years, and his wife, April 1, 1832, aged 63. Their ehildren were Polly, wife of Benjamin Andrews; Wyllys, who married Fanny Stedman; Roswell, who married Julia Newell; William, who married Sarah Gilbert; Diadamia, wife of Julius Hart; Hial, who married Eliza Gilbert; Charles, who married Delia Stedman; and Amon, our subject.

Amon Bradley was reared upon a farm, and received a good common school and academic education. He continued to work upon the old homestead until his twentieth year, and then engaged in general merchandising in Southington for about two years, after which, he spent two winters in the South, traveling as a peddler of dry goods, and Yankee notions through Virginia and North Carolina. In 1835 he again embarked in general merehandising, and continued in that business until 1866, for some years having Merritt N. Woodruff as a partner, the firm name being Amon Bradley & Co. Mr. Bradley has represented the Ætna Fire Insurance Co. in Southington for over forty years, and there are few enterprises in the town that he is not interested in, but since his retirement from merchandising in 1866, he has given his principal attention to his real estate interests. He has acquired a handsome property through economy, thrift, and perseverence, and has become one of the prosperous and substantial citizens of the community.

On Oct. 9, 1836, Mr. Bradley married Miss Sylvia Barnes of Southington, and to whom were born three children: Franklin B.; Aliee B., deceased wife of Norman A. Barnes; and Emma M., wife of Edward S. Yeomans. Truman Barnes, Mrs. Bradley's father, was born April 23, 1783, and was a prominent farmer of Southington. He was married Jan. 3, 1805, to Lowly Barrett, a daughter of William and Ruth (Coggswell) Barrett. His father, Jonathan Barnes, was born Feb. 2, 1731, and was married Aug. 4, 1757, to Elizabeth Woodruff, daughter of Hezekiah and Sarah (Macon) Woodruff of Southington. Jonathan Barnes lived on East Street for some time, but later removed to Kensington road. His parents were Stephen and Martha (Wheadon) Barnes of Branford, who at an early day removed to Southington, where he died March 27, 1777, and his wife March 18, 1773, she being the first one interred in Plantsville cemetery. Stephen Barnes was a son of Stephen and Mary Barnes, early settlers of Branford, Conn., formerly of Long Island.

There are few men in Southington, that have done more for its commercial interests and its growth and development than Mr. Bradley. When the Lewis Academy was erected, he was one the

building committee, and by his zeal and enterprise, he, with others, promoted the cause and secured the charter of the Southington Savings Bank, of whose first board of directors he was a member, having continued as such to the present time. Politically he has always been a staunch Democrat. He was Postmaster of Southington for twelve years, and represented the town in the State Legislature in 1863, 1864 and 1866. He is the oldest living Freemason in the place, having joined Friendship Lodge, No. 33, F. & A. M., of Southington, about 1850, and he is honored and respected wherever known.

Mr. and Mrs. Bradley enjoyed a long and happy wedded life; they celebrated the fiftieth anniversary of their marriage in 1886. The sixtieth in 1896, the sixty-fifth in 1901; no death having occured in their family in all there years; they lived to nearly reach the seventieth year of wedded life; united in life, united they have passed to their reward.


