Reference is made to my memorandum dated September 2, 1958.

D. Leonard Bird, Miami, Florida, advised on September 3, 1958, he is a personal friend of Arthur Bonhomme, Haitian Minister of Public Works, and is attempting to invest \$400,000 in Haiti through Bonhomme. Bird stated he is in favor of the present Haitian Government and has never been involved in Haitian revolutionary activities.

Rudolph Baboun, Haitian Consul, Miami, advised on September 8, 1958, that his informant in this matter, Harold Hussinius, a Haitian citizen, was then in Haiti and he did not believe the informant's information regarding Bird and Robert N. Billard was reliable.
