### DIRECTORY OF FEDERAL REGIONAL STRUCTURE

This directory of Federal agency regional structure is designed to give practical information about regional offices of Federal departments and agencies.

The Standard Federal Regional Boundaries System was established in 1969 to streamline Federal field office operations and encourage Federal-State-local interchange. Boundaries were drawn and regional office locations designated for 10 regions, and agencies urged to adopt the uniform system. A map of the Standard Federal Regions, and tables of the agencies conforming to this system can be found on pages 45008 to 450016.

The regional maps of agencies not conforming to the uniform regional system begin on page 450017. Each map is accompanied by a table showing addresses, telephone numbers, and key officials for all regions.

The information contained in this directory was compiled with agency assistance, as of July 1, 1975.
