KC 284-C advised on July 12, 1961 that while attending the recent International Teamsters Union Convention in Miami, Florida, July 3 - 7, 1961, he was advised on a highly confidential basis by ROY LEE WILLIAMS, President, Teamsters Union, Joint Council #56, Kansas City, Missouri, who acted in the capacity of Chairman of the Credentials Committee at the convention, that "DUSTY" MILLER would have to give up his official position as Vice President of the International.

CI explained that MILLER is presently a Vice President in the International, a General Organizer with the International and Chairman of both the Southern Conference and Southwest Conference of the Teamsters Union and makes his headquarters in Dallas, Texas.

WILLIAMS told CI that MILLER presently owns 25% of the Castaway in Miami, Florida, and 10% of the Atlanta Cabanna, Atlanta, Georgia. WILLIAMS said that MILLER has too many business interests and now desires to be a gentleman and therefore has lost his usefulness to the union. He also told CI that the Castaway and the Atlanta Cabanna have loans from the Pension Fund of the Teamsters Union in the amount of \$3,500,000 and \$4,000,000 respectively.
