ReBulet 2/18/64 enclosing NY letters 1/27/64, 1/29/64 and NY LHM 2/18/64 instructing London to contact sources, request coverage be assured JACK PERRY and TANG Ming-chou; ascertain contacts these individuals may have with Chinese Communists, the FRANKS, other U.S. residents, and to be sure the British understand the importance of the Bureau's efforts to penetrate Chinese Communist Intelligence.

London, by letter dated 2/27/64 to British Security Service, MI-5, furnished a copy of New York LHM 2/18/64 and made known the desires of the Bureau. Subsequently, this matter was thoroughly discussed with RALPH WHITBY, MI-5 officer on the Chinese Desk (As a result of the discussions, WHITBY by letter dated 4/13/64, classified TOP SECRET, furnished his analysis and conclusions concerning all subjects. Three copies of WHITBY's letter are enclosed hereinto the Bureau.

London indices denote that the Bureau in the past has had direct correspondence with MI-5 through MI-5's Washington representative regarding TANG Ming-chao and ISRAEL EPSTEIN; however, London files have been destroyed.
