Nine FM-2s led by Lieutenant Albert D. FOSTER, USNR, as Air-Coordinator, took off from parent ship to attack assigned targets on Okinawa Shima.

Upon arriving on station, the flight was ordered to the northern end of the island to make a reconnaissance. An enemy coastal battery had been reported to be firing at one of our ships off the north-western coast. The gun was thought to be located on the coast south of Awa Town. The Air-Coordinator flew low over the area but could not observe any gun positions. The flight was ordered to make dummy runs over the area as a threatening measure to keep the gun crew away from the battery.

No strafing or rocket attack was authorized and at 1800 the flight was ordered to return to base. 48 x 5" HE Rockets and 2 x F.S. Rockets were jettisoned in the sea on orders from parent ship. All planes returned successfully.
