2. The color slides submitted by [REDACTED] have been analyzed at ATIC and the following is concluded:

a. The slides are of the Mare Imbrium area of the moon and one contains the crater Plato as the outstanding feature.

b. Only one slide contains anything unusual. There are several blue colored areas on the slide in question and only one of these spots is immediately obvious to the unaided eye. The largest spot is irregularly shaped and is due south, moon directions, of the most obvious spot.

c. It is the opinion of photographic experts that the blue spots are areas which were not reached by the developer during processing and not real images. These areas were probably contaminated by some foreign substance during the developing procedure. When viewed with the naked eye from acute angles the most obvious spot shows a clear indentation. Microscopic examination reveals damage to the emulsion in the areas concerned.

3. The attached letter does not spell out the claims of Mr [REDACTED], but the subject infers that he suspects the blue spots are unidentified flying objects. It should be pointed out to Mr [REDACTED] that if the most obvious spot was a space craft in the vicinity of the moon that it would be approximately 35 kilometers long and 10.5 kilometers wide (21.8 miles long and 6.55 miles wide).

4. It is the ATIC opinion that the blue spots on the slide are not images but result from damage to the emulsion, probably during the developing process.

I am returning, herewith, the color slides you submitted through Selfridge Air Force Base to the Aerospace Technical Intelligence Center at Wright-Patterson Air Force Base, Dayton, Ohio for analysis and evaluation with respect to a possible unidentified flying object.

The color slides have been analyzed and the following represents conclusions of ATIC.

a. The slides are of the Mare Imbrium area of the moon and one contains the crater Plato as the outstanding feature.

b. Only one slide contains anything unusual. There are several blue colored areas on the slide in question and only one of these spots is immediately obvious to the unaided eye. The largest spot is irregularly shaped and is due south, moon directions, of the most obvious spot.

c. It is the opinion of the photographic experts that the blue spots are areas which were not reached by the developer during processing and not real images. These areas were probably contaminated by some foreign substance during the developing procedure. When viewed with the naked eye from acute angles the most obvious spot shows a clear indentation. Microscopic examination reveals damage to the emulsion in the areas concerned.

3. The investigation of this object has been limited to critical examination of the attached color slides and was conducted by use of projectors, the naked eye and microscope. Examination reveals the following:
 - a. The negative is extremely grainy while the object is well resolved.
 - b. All witnesses who viewed the photographic material stated they had seen similar marks on other color slides.
 - c. There is at least three other similarly colored areas on the slide in question, the largest being quite irregular in shape and faint in color.
 - d. When viewed by the naked eye under reflected light conditions the area of the film which contains the "object" shows a clear indentation.
 - e. Microscopic examination of the slide discloses damage to the emulsion in the areas concerned.

FBI DISOWNS UFO PHOTO

The photograph taken by a Grand Blanc, Michigan, man February 13 showing a UFO against the moon (see March UFO Investigator) has been turned over to the Air Force by the FBI agents who collected it at the owner's request. This was confirmed by FBI Director J. Edgar Hoover in answer to a NICAP query.

Joe Perry, owner of the picture, learned of the official UFO investigation after displaying the picture in his restaurant and notified the Air Force about it. The AF referred him to the FBI and two agents came and took the picture. Director Hoover has now told NICAP that the Bureau does not investigate UFO reports for the Air Force, but does accept information that is volunteered. "We did furnish these photographs to a representative of the Department of the Air Force for whatever action was deemed appropriate by that agency," he added.

Later FBI agents visited Perry several more times and repeatedly gave him the exact address where his picture was being held—an office at a local AF installation. In a taped report to NICAP, Perry said he thinks they were hinting for him to take the picture back. This, he suspected, would give official investigators an easy out. If anyone inquired about the analysis, officials could claim that they were not given enough time to complete an analysis. After learning about past treatment of photographic evidence, however, Perry decided to make an issue out of his case and insist that his picture be analyzed, then returned and the facts made public.

The FBI action may have been taken to offset any idea that the Bureau, which has the high regard of most citizens, would participate in any cover-up of data which rightfully belonged to a citizen. The failure of the AF base to take further action has not been explained. NICAP has asked the AF UFO spokesman about the analysis and what further action may be expected.

BULLETIN

The Air Force has notified NICAP that the color photograph taken by Joseph Perry, Grand Blanc, Michigan, has been returned to the owner. "It is the Air Force's opinion," the letter said, "that the blue spots on the slide are not images but result from damage to the emulsion during the developing process."

NICAP has asked Mr. Perry to make the slide available to NICAP photographic advisers who will check this conclusion.

At Grand Blanc, Michigan, Joe Perry, a pizza restaurant owner and amateur astronomer, shot a few pictures of the full moon in February. When the color pictures were developed, one showed a saucer-like object, radiating a green tail, and with a dome. Mr. Perry showed them around his restaurant, to customers and friends, and one individual said, "It's a flying saucer." Before long, two FBI agents dropped in, looked at the pictures, were noncommittal when looking at them, and in Perry's words, "They didn't seem to be interested until I showed this particular one, and then both of them jumped up." The agents took the photo showing the saucer, and several others. Perry said he hoped he has been of some service to the government, "but I hope I get that picture back," he said.

John Hopf, APRO's photo analyst, said in a recent letter to the staff: "This film will never be seen again—he might just as well have burned it up!"

The rest of the staff joins Hopf in urging members to keep a sharp eye out for any picture of a UAO. Inform the photographer that APRO will pay for the privilege of analyzing the film, and will guarantee that the original negatives will be returned, if requested.

1. The Federal Bureau of Investigation, by memorandum dated 9 March 1960, advised this Headquarters that Mr. [REDACTED] Street, Grand Blanc, Michigan took some photographs of the moon through a homemade telescope at 0100, 21 February 1960. After developing the film and preparing his slides, [REDACTED] noticed on two of the slides what appeared to him to be a flying object. After enlarging the particular negatives, [REDACTED] stated the object thereon appeared to be flat on the bottom, oval in shape and to have a fluorescent glow. He said the object was evidently moving because the photograph showed what appeared to be a vapor trail. [REDACTED] also stated that due to his thirty years of experience in photography, during which he has taken over a thousand photographs of the moon, he is sure that what appears on the slides is actually a flying object and not a malfunction of the camera, a blur on his telescope, or the result of faulty developing. [REDACTED] advised he took the pictures through his homemade telescope, which was set between 350-400 power, with a 35 mm German Retna camera, using Super Ansco color film. [REDACTED] gave the photographic slides in question to the Federal Bureau of Investigation.

2. The Federal Bureau of Investigation, by memorandum dated 9 March 1960, furnished the foregoing information and photographic slides to the Commander, OSI District Nr. 25, Selfridge Air Force Base, Michigan, who in turn forwarded the information and slides to the Commander, Selfridge Air Force Base, Michigan in accordance with the procedures set forth in AFR 200-2.

3. Attached for your information and any action deemed appropriate is a copy of a letter from the Federal Bureau of Investigation, dated 6 April 1960 and a copy of a letter dated 21 March 1960, which was addressed to President Eisenhower by Perry. OSI District Nr. 25 has advised the Commander, Selfridge AFB, of [REDACTED] 21 March letter.

Also, from other U.F.O. societies I have received the same perditions.

I would like the assurance that this colored transparency will be returned to me within a short time, as it would be financially profitable in the pursuit of my hobby, (cameras and equipment).

Reference is made to this Bureau's memorandum dated March 9, 1960, at Detroit, Michigan, captioned as above, a copy of which has been furnished your agency.

By letter dated March 21, 1960, Mr. Richard Hall, Secretary of the National Investigations Committee on Aerial Phenomena, 1536 Connecticut Avenue, N. W., Washington, D. C.; referred this Bureau to an article appearing in the "Detroit Times," issue of March 9, 1960, a copy of which is enclosed, and requested to be advised whether there had been any change in our policy with respect to unidentified flying objects; whether this Bureau gathered evidence of unidentified flying objects for the Department of the Air Force; and whether the photograph described in the article had been analyzed at FBI laboratories or for FBI purposes. This Bureau's letter to the afore-mentioned organization of September 26, 1958, had pointed out that we do not investigate incidents involving unidentified flying objects but furnished data received concerning them to the Department of the Air Force.

This Bureau advised Mr. Hall in our letter dated March 25, 1960, that there has been no change in our policy in regard to unidentified flying objects;

that we do not gather evidence concerning unidentified flying objects for the Department of the Air Force, although any information volunteered is, of course, accepted; and that the photograph mentioned in the "Detroit Times" article was not examined by the FBI Laboratory or anyone else for FBI purposes. Mr. Hall was further advised that this Bureau furnished two photographs obtained from [REDACTED] to a representative of the Department of the Air Force for whatever action was deemed appropriate by that agency.

On March 31, 1960, the Department of Justice furnished this Bureau a letter dated March 21, 1960, from [REDACTED] directed to the President. This letter had been referred to the Department of Justice by the White House. A copy of this letter is enclosed. Our Detroit Office will contact [REDACTED] and advise him that his letter directed to the President has been referred to this Bureau; that the photographs in question were furnished to the Office of Special Investigations, Department of the Air Force, Selfridge Air Force Base, Mount Clemens, Michigan; and that a copy of his letter to the President has been furnished to you.
