SUBJECT: ~~(S)~~ Reward for Saddam Hussein and Sons

- ~~(S)~~ I understand from General DeLong that General Franks wants to offer a \$2.5 million reward to any Iraqi who helps us capture Saddam Hussein and his two sons.
- ~~(S)~~ The Department of Defense does not have the authority to offer that amount of money within the rewards program. The largest reward which the Secretary can offer is \$200,000.
- ~~(S)~~ I am exploring other sources of money that General Franks may be able to utilize for this reward. The CIA may be able to secure additional funds for this purpose.

(b)(1),(b)(5)

- ~~(S)~~ None of these are guaranteed sources and it is vital that CENTCOM begin work on advertising a reward for the capture of Saddam and his sons. SO/LIC is prepared to secure SecDef approval for a \$200,000 reward based upon a recommendation from the Joint Staff.
- (U) I would appreciate an update on CENTCOM's plan as soon as possible.
