SUBJECT: KAMEI, Kanichiro and the Scientific Research Institute

- 1. A thorough study of the background of Dr. KAMEI, Kanichiro, and the Scientific Research Institute plans, reveal information that would suggest great caution should be exercised by CI&E in approving this man and his organization.
- 2. The following facts so far established re KAMEI, Kanichiro indicate that he might well be picked up and held possibly at Sugamo, at least for a period of interrogation.
- 3. The Jiji Year Book, 1942 Edition (Jiji Nenken, Showa 17) page 103, states KAMEI, Kanichiro was chief of the East Asia Section (Toa bu) of the National Policy Formulating Bureau (Sei Saku Kyoku), the head of which was OTA, Masataka, nor confined at Sugamo. The National Policy Formulating Bureau is part of IRAA.
- 4. Dr. KAMEI address is shown as 1112 Omachi, Kamakura, Kanagawa ken. Telephone: Kamakura 1033. He authored the following books:
 - 1. The Road to the Great East Asia United Race (Daitoa Minzoku no Michi)
 - 2. A Plan for Unifying Organizations and Societies for promoting a Greater Asia (Xoa Dantai Togo no Koso)

- 5. Dr. KAMEI was Councillor of Great Japan Industrial Workers' Patriotic Society (Dai Nippon Sangyo Hokoku Kai), the president of which was TOJO, Hideki, (now confined in Sugamo). This organization was sponsored by the government for controlling and mobilizing the laborers (industrial) toward war efforts. It was directly affiliated with IRAA, therefore, is interpreted as being prescribed under the 4 Jan 46 SCAP Directive.
- 6. The Japan Weekly (Nippon Shuho), #1, 9 Dec 45, is source which states Dr. KAMEI was involved in the March 1931 Incident (Sangatsu Jiken). KAMEI is named along with ASO, Hisashi (now dead) as unofficial members of the Army group who attempted to overthrow the HAMAGUCHI Cabinet and put Gen. UGAKI in as Premier. Three (3) other persons shown as unofficial members along with KAMEI and ASO are OKAWA, Shumei (now in Sugamo), KITA, Ikki (or KITA, Terujiro) and NISHIDA, Mitsugu both of whom were tried and given death sentences as a result of the 2-26 Incident, and MORI, Keku, then a leading politician of the Political Friend Society (Seiyukai Party), claimed to be the master-mind in all Japan. Mori is now dead. Members of the group which propounded expansion to the Asiatic Continent are shown as being NINOMIYA, Jiju Lieut. Gen. (Educational Minister in KOISO's Cabinet), TATEKAWA, Yoshitsugu, Lt.Gen. (notorious Jingoist and close friend of HASHIMOTO, Kingoro), UMEZU, Yoshijiro, Gen.
- 7. Dr. KAMEI, is also shown as having had an address at 2 Sannen cho, Kojimachi ku, Tokyo. He served in the Japanese consulates at Tsientsin and New York; was secretary in the Foreign Office; was elected four times since 1928 to the House of Representatives

from Fukuoka ken; was member of the Executive Committee of the Social Mass Party (Shakai Taishu-to) and was Chief of the East Asia Sect (Toa bu) under the Production Bureau (Seisaiku Kyoku) of IRAA, 1939040 (see par. 3 above). As a representative of the Social Mass Party (Shakai Taishu-to) in 1937, he called for stronger foreign policy toward China.

- 8. Reliable information shows Dr. KAMEI has not bee permitted to join the recently reorganized Socialist Party Nippon Shakai-to due to his past disagreeable record. He formed a new party along with a few former newspaper friends within the past month, which has been named the Social Democrat Party (Shakai Minshu-to). Informants state KAMEI follows 'Tammany Hall type politics'.
- 9. On informant reporting to the Public Health and Welfare Section stated KAMEI was pro-axis and had visited Berlin. (This is not verified by this writer). Since Japan's surrender he has been very active and 'supposedly' cooperating in SCAP circles. He now claims to be very much interested in democracy. "He maintains a very expensive and luxurious home in Kamakura". "His idea of democracy is nurtured best of all in younger officers of the Army and Navy". "He plans to line up the farmers in his organization", "sort of a society for Scientific Reconstruction of human lives", states the Public Health informant.
- 10. (e) Before Japan's surrender, KAMEI's society was called "Technological Society for making the present war as sacred and holy as possible for the people" (Seisen Gijutsu Kyokai). KAMEI's own statement, submitted to CI&E, claims "that is to say, our's has been a battle against the frantic and dogmatic execution of war, and for peace with independent and unified China, and for the federation of independent Asiatic states, and for the honorable reconsideration with the Allied Powers on these conditions."....(b) After Japan's surrender, the society changed its name to Scientific Research and Propagating Institute for Modernizing Peoples Life and Economy, (Jomin Seikatsu Kagaku).
- 11. After the 4 Jan 46 Directive "Abolition of Certain Political Parties, Associations, Societies and other Organizations" appeared, a reliable informant sent a note to this office which states in part:

12. Another informant reported to the Public Health and Welfare Section that one of KAMEI's assistants is a Dr. MASUBA (fnu), (who is said to have served with the Bacteriological Warfare Activities in Manchuria under Medical Major ISHII, Shiro, ordered apprehended 9 Jan 46) was recently entertained in Kamakura by KAMEI.

Personality notes are attached on <u>KAMEI</u>, <u>Kanichiro</u>; <u>OKUDA</u>, <u>Juichiro</u>; <u>KURUSHIMA</u>, <u>Hidesaburo</u>; <u>MORI</u>, <u>Hideoto</u>; <u>OKADA</u>, <u>Jiro</u>; <u>SHIBUSAWA</u>, <u>Keizo</u>; and <u>SHIMIZU</u>, <u>Yasuo</u>. There is no information in our card files on HORIKAWA, Masie; SASAMORI, Tatsumi; HASHINAKA, Ichiro and MORIKAWA, Kakuzo.
