SUMMARY OF RELEVANT POINTS

This document consists of answers to various standard questions on the activities of AOKI, Kazuo, who submitted the questionnaire at the request of Legal Section. Later, this report was made available to IPS through Cmdr Maxon and was to have been used as a basis for interrogation. It is now available as a document for whatever evidentiary value it may have.

Regarding political and nationalistic societies, AOKI states that in Sept 1942 he became an advisor of the Imperial Rule Assistance Assn in accordance with his appointment as a Minister of State and he was also a member of the Imperial Rule Assistance Political Society.

Other societies of which he was a member are: KENKYUKAI (Organization of House of Peers), KOKU SAKU KENKYU KAI (National Policy Research Society) and the NIHON Club.
