

Mr. CARTWRIGHT. Madam Speaker, I rise today to recognize Rabbi Samuel Sandhaus for his service to his community. Rabbi Sandhaus has dedicated his life to the service of his country and his fellow citizens, and will be honored for his contributions and achievements on Sunday, October 27, 2019.

Rabbi Sandhaus earned a bachelor's degree in economics and ordination, as well as a master's in Bible studies, from Yeshiva University. He also earned an MBA in finance and management from Boston University, and postgraduate certificates in health service administration and gerontology from Marywood University. Answering the call to serve his country in 1971, he served as a chaplain in the United States Army until 1979, and he was awarded the Army Commendation Medal with two Oak Leaf Clusters.

After his time in the Army, Rabbi Sandhaus was licensed as a nursing home administrator by the Commonwealth of Pennsylvania. He was then named the Assistant Executive Director of the Jewish Home of Eastern Pennsylvania in 1979, beginning his four-decade career with the organization. He served as Associate Director from 1981-1983 before being named the Executive Director in 1983. During his tenure, the Jewish Home became a leader in provisional long-term care in the region. Under his thoughtful direction and leadership, Jewish Home purchased 20 acres of land in Clarks Summit to build Elan Gardens, a personal care facility. Rabbi Sandhaus retired from the organization in 2019.

Rabbi Sandhaus' colleagues have often sought his professional opinion and experience. He served as the co-chair of the Quality Assurance Committee for the Association of Jewish Aging Services; president of Sigma Phi Omega; president of both the National Gerontology Academic and the Professional Honor Society's Scranton Chapter; and in various other capacities for the Association of Jewish Aging Services. He also offered his expertise as a management consultant for Elan Gardens.

Rabbi Sandhaus has been an active leader in his community. He served as community co-chair and chair of the United Jewish Campaign; director of the Scranton Hebrew Jewish Day School; director of both the Scranton Counseling Center and the United Way of Lackawanna; chaplain for the Sandy Weissberger/Leon Kaplan Post 165 Jewish War Veterans; an instructor at Marywood University School of Continuing Education; and secretary/treasurer of Webster Towers Senior High-Rise.

It is an honor to recognize Rabbi Sandhaus for his contributions to the Jewish community

and elder care services in Northeastern Pennsylvania. His professional career and personal endeavors have enriched the lives of many, and I hope his spirit of serving his fellow citizens inspires many generations to come.

The response from community members was incredibly generous and the Alleghany Rescue Squad continues strong today, comprised entirely of volunteer workers—including three of its charter members—who raise all funding for equipment and rescue classes. Whereas, in January 1989 the city of Mineola was chosen from several applicants throughout the state to participate in the Texas Main Street Program. The city has been a continuous member of the program for 30 years and is the seventh oldest program in the state; and

Whereas, the program's mission is to use the Main Street Four Point Approach to restore a positive image to downtown, while creating economic growth for our community. Our Main Street Program will be the vehicle to continue historic revitalization of downtown Mineola; and

Whereas, monthly, quarterly and annual reports are filed with the Texas Historic Commission to document the economic aspects of the program; and

Whereas, the Mineola Main Street District is bounded on the north by Blair and McDonald Streets, south to the city limits on Highway 69, east to the city limits, and west to the intersection of Kilpatrick Street with Highway 80; and

Whereas, the Meredith Foundation has been instrumental in supporting the Mineola Main Street Program, providing over \$1.2 million in grants for projects from its beginning through end of this year; and

Whereas, in the past 10 years, the Mineola Main Street Board had approved 44 incentive grants in the amount of \$35,765 for improvements in the Main Street District. The money for these grants was raised by the board and other volunteers; and

Whereas, the Main Street Board has operated a successful Wine Train fundraiser with Amtrak to Fort Worth for 16 years; and

Whereas, in the last decade, total reinvestment in the Mineola Main Street District by private ventures, public investment and joint projects has totaled \$19,963,731; and

Whereas, the grand total of reinvestment reported to the Texas Historic Commission over the 30 years of Main Street in Mineola is more than \$32 million; and

Whereas, over the 30 years, the Main Street Program has purchased, placed and overseen the placement of Christmas decorations downtown; and

Whereas, in 2013 the city's Historic District was named to the U.S. Department of Interior's National Register of Historic Places; and

Whereas, the Mineola Historical Museum was opened under the umbrella of the Main Street Program and celebrates its 10th anniversary this year; and

Whereas, an interactive model train set in scenery replicating 1930s Mineola and its trains was purchased and is on display at the depot; and

It is important that we recognize this historic site because of the extraordinary life and legacy of Judge Motley. Born and raised in New Haven, CT, Judge Motley was a first generation American, the child of Caribbean immigrants. At an early age, a local philanthropist offered to fund her college education, after hearing her speak at a community event. After graduating from New York University, she attended Columbia Law School at which point she joined the NAACP's Legal Defense Fund. As a contemporary of great civil rights activists like Dr. Martin Luther King, Jr, and Justice Thurgood Marshall, Judge Motley helped litigate most of the defining civil rights cases of the era, including the landmark Brown v. Board of Education.

After a successful career as a lawyer and activist, she became the first female African American New York State Senator. Then, in 1966, President Lyndon B. Johnson appointed her to the federal district court for the Southern District of New York, making her the first black woman to serve on the federal judiciary. There, she spent the next 40 years shaping the legal landscape of the 20th century and even became the court's Chief judge. It was during this part of her life that Judge Motley often escaped to her Chester home with her family.

I'd like to thank the Chester Land Trust and the greater Chester community for embracing Judge Constance Baker Motley's legacy by preserving her home and estate. I'd also like to thank the Motley and Coleman families for being so supportive of this endeavor.

We honor Judge Constance Baker Motley's life and legacy by inducting her historic home into the Connecticut Freedom Trail. Colleagues, I ask that you please rise and join me in acknowledging this special occasion and the incredible woman we have to thank for it.

DEAR SPEAKER PELOSI AND LEADER MCCAR-THY: As state banking supervisors, we are responsible for ensuring the safety and soundness of state-chartered banks and credit unions, as well as the regulation of non-depository financial service providers that may provide services to these entities. The financial services industry in state authorized marijuana jurisdictions is unable to effectively service the needs of this new and growing industry because of conflicting federal and state regulation for marijuana. Medical marijuana is available to 67 per-

cent of the country's population, and 11 states have legalized adult recreational use. This significant portion of the country's population is funding a growing cannabis industry. The lack of federal safe harbors or authorization for financial service providers is creating commercial risk for the legitimate marijuana industry, due to the lack of financial servicing of these monies.

This absence of servicing encourages a grey economy, as the industry's participants are unable to use safe, regulated, and verifiable money services. Until financial institutions can serve the industry without violating federal laws, then tax collection, consumers, and the financial system will remain at risk.

Until Congress can take broader action to more comprehensively address cannabis, we support the passage of H.R. 1595 to provide a safe harbor for depository institutions that supply financial services to legitimate marijuana businesses and allow for the transparent and safe banking of the marijuana industry.

We urge a YES vote on H.R. 1595.

DEAR CONGRESSIONAL LEADERS: As our States' chief executives, we urge Congress to pass legislation allowing states with legalized medical or adult-use cannabis to operate safely and under the scrutiny of the national banking system. We strongly support the passage of the Secure and Fair Enforcement (SAFE) Banking Act (H.R. 1595) and (S. 1200) or similar legislation that would remove the legal uncertainty for banks and credit unions, reducing their risk, enhancing public safety, and increasing financial transparency.

We were pleased that the House Financial Services Committee held a subcommittee hearing on cannabis and financial services on February 13, and we were especially encouraged to see that H.R. 1595 passed the full committee on a strong bipartisan basis on March 28. We urge the full House to pass this legislation to help provide banking services to state-licensed cannabis businesses.

State and federal governments have a shared interest in upholding the rule of law, protecting public safety, and transitioning markets out of the shadows and into our transparent and regulated banking system. Without access to banking services, state-licensed cannabis businesses operate predominantly on a cash basis. This poses a significant public safety risk to customers and employees. Additionally, because banking services are barred, these businesses are unable to write checks, make and receive electronic payments, utilize a payroll provider, or accept credit and debit cards. The cash-only environment puts an additional burden on state and local government agencies that must collect tax and fee payments, in person and in cash, incurring additional public expenses and employee safety risks.

Currently, thirty-four U.S. states, three U.S. territories, and the District of Columbia have legalized the medical use of cannabis. Additionally, ten states and the District of Columbia have legalized recreational use by adults over 21 years of age. Despite legalization of cannabis at the state-level-in many cases to provide medical treatment-our financial institutions face enormous barriers, legal risks, and criminal and civil liability under the Controlled Substances Act that prevent them from providing banking services to state-licensed businesses. As a result, very few banks and credit unions will provide these services, leaving many businesses in this sector unbanked.

Many of our states have implemented laws and regulations that ensure accountability of the cannabis industry. However, without banking services, cannabis businesses are less able to obey the law, pay taxes, and follow these important regulations. The public safety risks posed by these cash-only businesses can be mitigated through access to banking service providers.

To adequately address these issues, we urge Congress to pass legislation, such as the SAFE Banking Act (H.R. 1595) and (S. 1200), that would provide a safe harbor for depository institutions that provide a financial product or service to a cannabis business in states that have legalized it. We look forward to working with you as legislation progresses to address this urgent public policy concern.

The Global Alliance for Cannabis Commerce (GACC) announces its endorsement of the Secure and Fair Enforcement (SAFE) Banking Act.

The SAFE Banking Act is sponsored by Representatives Ed Perlmutter (D-CO), Denny Heck (D-WA), Steve Stivers (R-OH), Warren Davidson (R-OH), and over 200 other members of the U.S. House of Representatives, and Senators Jeff Merkley (D-OR), Cory Gardner (R-CO), and nearly thirty other members of the U.S. Senate.

Cannabis banking issues have long been both a significant hamper on industry growth vis-à-vis access to capital and a public safety risk-including the risk of kidnap, torture, and mutilation for the purposes of extortion-by compelling a cash-laden industry.

But beyond the well-documented industry issues cannabis entrepreneurs and small businesses encounter, the lack of banking access puts a significant onus on the 200,000plus employees of U.S. cannabis businesses. Cannabis businesses have extreme logistical difficulty providing benefits to employees, providing a payroll system, and applying withholdings. Oftentimes, GACC memberbusiness employees are forced to live cash lifestyles without access to proper retirement or healthcare savings. We urge the swift passage of this act.

Mr. SIMPSON. Madam Speaker, I rise today with great respect and gratitude for the 480 men and women of the Advanced Mixed Waste Treatment Project (AMWTP) as they complete the facility's waste treatment mission for the State of Idaho and the country.

The State of Idaho didn't generate the waste treated at AMWTP, but the citizens of Idaho along with the entire nation benefitted from our nation's unrelenting drive to keep the peace through our strength. In many ways, the waste that the AMWTP team retrieved, characterized, treated, certified, and shipped out of the state was the byproduct of our freedom. It was the legacy of the Cold War. Through their hard work, dedication, and sacrifices, they helped close the chapter on this part of the Cold War.

In addition to the AMWTP employees, we owe Idaho governors Cecil Andrus, John Evans, Dirk Kempthorne, Jim Risch, Phil Batt, C.L. "Butch" Otter, and Brad Little a great thanks for their insistence that this waste would not remain in Idaho in perpetuity over our precious Snake River Plain Aquifer. Our aquifer, our citizens, and our nation are safer with this waste safely disposed of at the Waste Isolation Pilot Plant.

We also owe the Department of Energy (DOE) a heartfelt thank you for committing to this project in the mid-1990s and staying with it until the end. It wasn't easy; it wasn't without contention or disagreements, but all sides worked together for a common goal of success.

The contractors that have been associated with the AMWTP also must be recognized, from BNFL Inc., to Bechtel BWXT, to the Idaho Treatment Group, to the current contractor; Fluor Idaho. The amount of ingenuity, engineering, and technology at this waste treatment facility is unmatched anywhere else in the world. AMWTP, backed by the DOE and its contractors and committed management and employees, had the brawn and brains to ment mission.

But none of this would have been possible without the men and women of the AMWTP. Each and every one of them made sacrifices to support this mission. They sacrificed quality time with family members to commute to the facility in the early hours of the morning, often leaving at night-never seeing the light of day. They knew they were effectively working themselves out of a job, just as all employees of the Idaho Cleanup Project are doing.

The employees of the AMWTP should be the models for the entire workforce of the DOE Complex. When they encountered challenging waste types and containers, they developed the procedures and processes to safely and compliantly address them. When the specialized equipment didn't exist, they fabricated it, tested it, and put it to work. They adapted and found solutions to the most complex challenges they encountered.

Several more years will be needed to ship out the balance of the 65,000 cubic meters of waste to WIPP. For those who stay with the project, the Idaho Congressional Delegation wishes them the best of luck in safely carrying out the remainder of the shipping mission.

For those who retire, take other jobs in Idaho, or leave to pursue opportunities elsewhere, we wish them the best of luck and again sincerely say thank you. AMWTP and the impact of its workforce to the State of Idaho and the nation will be remembered for generations to come.

In 2018, he was awarded the Secretary's Meritorious Service Silver Medal for his leadership and service to the Department of Homeland Security. He also earned the Commissioner's Strategic Problem Solving Award for the South Texas Railroad Strategic Problem Solving Initiative, and Assistant Commissioner recognition for his outstanding contribution to the Land Border Directive Working Group.

Mr. Higgerson is a graduate of the St. John Military Academy and holds an Associate's Degree in Accounting. After honorably serving in the U.S. Army, he was Customs Inspector at the Panama Canal Zone and was then transferred to Laredo, Texas in 1978. He was also Port Director in Hidalgo-Pharr, Texas, and DFO in El Paso, Texas and Tucson, Arizona.

It has been an honor to work with Director Higgerson for the past seven years. I thank him for his service in keeping our borders safe, while also taking care of our officers on the front line. As we celebrate David P. Higgerson's retirement, I ask my colleagues to join his family, our community, and me in recognizing his legacy and wishing him a happy retirement.
