Secondary and Preparatory Schools; Teachers

4. Clause (c) of Article 66 of the Principal Regulations shall, in so far as it is applicable to the recognition of men teachers, cease to have effect during the period from 1st October, 1937, to 31st December, 1938. Recognition shall not be withdrawn from any assistant teacher on or after the expiration of this period solely on the ground that the suspension of the rule as provided in thissection has ceased to have effect.

5. These regulations shall be construed with and as forming part of the Principal Regulations and they shall take and have effect from 1st October, 1937, except as otherwise provided herein.

6. These regulations may be cited as the Public Elementary Schools Regulations, 1934, Amending Regulations No. 6, 1937.

ORDER IN COUNCIL, DATED 19th DAY OF NOVEMBER, 1937, APPROVING TEACHER'S SUPERANNUATION SCHEME FRAMED BY THE MINISTRY OF FINANCE IN PURSUANCE OF SECTIONS 70 AND 71 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923.

WHEREAS a Scheme (hereinafter referred to as "the Principal Scheme"), dated the 11th day of March, 1925, was framed by the Ministry of Finance in consultation with the Ministry of Education, in pursuance of Section 70 of the Education Act (Northern Ireland), 1923 (hereinafter referred to as "the Act of 1923"), and was approved by Order in Council on the 29th day of May, 1925:

And whereas the Principal Scheme was amended by Amending Scheme dated the 17th day of May, 1926, the 25th day of November, 1929, and the 15th day of October, 1936, which were approved by Orders in Council on the 29th day of July, 1926, the 27th day of January, 1930, and the 23rd day of November, 1936, respectively :

And whereas the Principal Scheme as so amended is hereinafter referred to as "the Principal Scheme as amended":

And whereas it has been deemed desirable to amend the Principal Scheme as amended in certain particulars :

And whereas the Ministry of Finance in consultation with the Ministry of Education has, in pursuance of Sections 70 and 71 of the Act of 1923, framed a Scheme (hereinafter referred to as "the Amending Scheme") for amending the Principal Scheme as amended, which Amending Scheme is set out in the Schedule to this Order :

And whereas the Amending Scheme has been laid before both Houses of Parliament and neither such House has within the period prescribed in that behalf by Section 71 of the Act of 1923, as amended by Section 4 of the Rules Publication Act (Northern Ireland), 1925, presented an Address praying the Governor of Northern Ireland to withhold his assent from the Amending Scheme:

Now I, James Albert Edward, Duke of Abercorn, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in exercise of the powers conferred upon me by Section 71 of the Act of 1923, do hereby approve of the Amending Scheme.

SCHEDULE.

In pursuance of Sections 70 and 71 of the Education Act (Northern Ireland), 1923, the Ministry of Finance after consultation with the Ministry of Education hereby frames the following scheme for amending the Teachers' (Secondary and Preparatory) Superannuation Scheme, 1925, as amended by the Teachers' (Secondary and Preparatory) Superannuation (Amendment) Scheme, 1926, the Teacher's (Secondary and Preparatory) Superannuation (Amendment) Scheme, 1930, and the Teachers' (Secondary and Preparatory) Superannuation (Amendment) Scheme, 1936, and all such schemes are hereinafter referred to as the "Principal Scheme as Amended."

1. This scheme shall apply to all Principals and Heads of Departments to whom the Principal Scheme as amended applies.

2. With effect from the 1st February, 1937 (which date shall be called the operative date) the expression "salary" shall be deemed to include the Governor's Grant and the Departmental Secondary and Preparatory Schools : Teachers

Allowance payable to Principals and Heads of Departments respectively in accordance with the Regulations for Secondary Teachers.

3. In the case of a teacher who was a Principal at the operative date there shall be payable with effect from that date by the School Authority under which he is for the time being serving a contribution of an amount as stated in the Appendix to this scheme supplemental to the contribution deductible under the Principal Scheme as amended in respect of that portion of the teacher's salary in excess of £700 per annum in the case of a male honours graduate, £575 per annum in the case of a female honours graduate, £650 in the case of a male pass graduate, £525 in the case of a female pass graduate, and these salaries are referred to in the Appendix as the "maximum figure."

4. In the case of a teacher who was a principal at the operative date and in respect of whom a supplemental contribution was payable and who retires on pension or gratuity before the expiration of the period during which such contribution was to have been paid, the supplemental contribution shall be paid for the balance of that period by the School Authority under which the teacher concerned was employed at the date of the retirement, and for the purpose of the calculation of the amount of each contribution his salary shall be taken to be the full rate of salary payable to him at that date provided that no contribution shall be payable in respect of any period subsequent to the death of the teacher.

5. In the case of a teacher who retires on or before 31st January, 1940, the salary on which his pension or gratuity is based shall be either the average annual emoluments (including an added sum of £50 per annum in the event of a free residence having been provided) received by him from the School Authority in the three years immediately preceding the date of retirement, or the amount he would have received had the Governor's Grant or the Departmental Allowance, as the case may be, been payable over the entire three years herein referred to whichever is the less.

6. This scheme may be cited as the Teachers' (Secondary and Preparatory) Superannuation (Amendment) Scheme, 1937.

REGULATIONS DATED 20TH MARCH, 1937, MADE BY THE MINISTRY OF EDUCATION, NORTHERN IRELAND, UNDER SECTION 77 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923 (13 AND 14 GEO. 5, CH. 21) AFTER CONSULTATION WITH THE MINISTRY OF FINANCE AND DULY LAID BEFORE PARLIA-MENT IN ACCORDANCE WITH THE PROVISIONS OF SECTION 99 OF THE AFORESAID ACT.

1937. No. 23.

1. These Regulations may be cited as the Technical Attendance Grants Regulations, 1932, Amending Regulations, No. 2, 1937.

2. Regulation 15 of the Technical Attendance Grants Regulations, 1932 (hereinafter called the "Principal Regulations") is hereby repealed and the following Regulation substituted therefor :---

15. The grant payable to the managers of each recognised school or class shall be calculated at the rate of 12/for each unit of attendance made by students in accordance with Regulation 16 of the Principal Regulations.

The rate of grant may be revised at the end of three years from the date of these Regulations.

3. These Amending Regulations shall take and have effect as from 1st August, 1936, and shall thereafter be construed with and as forming part of the Principal Regulations.
