Public Safety Division, CIS, GHQ Approximately 1135, on the 18th of November 1947, Miss Lois Pinchard, Pfe. Richard Letaw, Pvt. James Teague, Pvt. Robert Chambers, Pvt. Merton Parker and myself caught a G.I. bus in front of the Dai Ichi Building. Our destination was the NYK Building, where we go for chow. Before we reached the bus stop, the buszer was sounded two or three times. The driver became angry and demanded the name of the person who rang the buzzer. We did not see where he was in the right to ask for any names of his passengers, as nothing out of the way had happened. It seemed rather foolish and also funny to us, and a couple or three of us laughed. We were already at the rear exit of the bus, waiting for him to open the door. He refused to open the door and let anyone out. We waited at the exit a while for him to open the door. As he made no move to do so, we returned to our seats. One woman passenger asked to be let off, so she could catch another bus. He refused her, saying no one could get off until he got our names. Other passengers on the bus did not like his attitude and asked to get off the bus. Only then did he let the other passengers off, after he saw they did not like his actions. He also let Miss Pinchard off. Miss Pinchard works in the Public Safety Division, CIS, office with us. After chow, when she came in the office, she said some woman started to get on the bus as they got off. The driver closed the door quicker than usual and hit her foot with the door. The driver, still refusing to let us off, turned the bus around and drove to the Provost Marshal's office building. Here he called the M.P. on duty outside the door. He told the M.P. we had pulled the buzzer and had laughed at him, also refused to give him our names. Before this he had refused to give a woman passenger his name when asked it, at the time he refused to let anyone off the bus. The M.P. took our names and gave them to the driver, at the same time we got the driver's name. Everyone on the bus at the time the incident occurred plainly showed by their actions that the driver was in the wrong. The driver's name is Larry Sakoki.
