1. Recommend that the Military Barracks of the former Japanese 136th Infantry Regiment, located at Awano-mura, Tsuruga Gun, Fukui Ken and the Military Barracks of the former Japanese 80th Trench Mortar Regiment, located at Tachimachi-mura, Nyu Gun, Fukui Ken, be returned to the Japanese Home Ministry.

2. Surveys of both establishments listed above, (complete with sketches) and requests by the Governor of Fukui Ken for their release are attached as inclosures No 1 and No 2 respectively.

3. An investigation, conducted by this organization, of this request for the release of these two establishments reveals that the main buildings are badly needed to replace destroyed school facilities, and that they are quite suitable for such a use. In addition it is believed that many of the auxiliary buildings would be of great value in the reconstruction of the devastated nearby cities of Tsuruga and Fukui, since they are of such nature as to readily lend themselves to salvage of their component parts; lumber, tile, and brick foundations. Furthermore, the extensive parade and other ground areas would afford a sizeable land plot for much needed cultivation in these stricken areas.

4. Both these establishments are not being presently used by any Occupation Forces. No information is locally available as to their possible future use by the Military.
