AN ACT to amend an Act entitled an Act to regulate Proceedings in Civil Cases in the Courts of Justice of the State, passed April

The People of the State of California, represented in Senate and Assembly, ao enact as follows:

Section 1. The Act entitled an Act to regulate proceedings in civil cases in the Courts of justice of this State, passed April 29, 1851, is hereby amended as provided in this Act.

Sec. 2. Section two hundred of said Act is amended so as to read as follows: Sec. 200. In an action to recover the possession of personal property, judgment for the plaintiff may be for the possession or the value thereof, in case a delivery cannot be had, and damages for the detention. If the property has been delivered to the plaintiff, and the defendant claim a return thereof, judgment for the defendant may be for a return of the property, or the value thereof, in case a return cannot be had, and damages for taking and withholding the same. In an action on a contract or obligation in writing for the direct payment of money, made payable in a specified kind of money or currency, judgment for the plaintiff, whether the same be by default or after verdict, may follow the contract or obligation and be made payable in the kind of money or currency specified therein; and in an action against any person for the recovery of money received by such Court of Sessions-1st Monday in April; 1st person in a fiduciary capacity, or to the Monday in July; 1st Monday in December. use of another, judgment for the plaintiff. whether the same be by default or after verdict, may be made payable in the same kind of money or currency so received by such person:

Sec. 3. Section two hundred and ten of said Act is ammended so as to read as follows: Sec. 210. The writ of execution shall be issued in the name of the people, sealed with the seal of the Court, and subscribed by the Clerk, and shall be directed to the Sheriff, and shall intelligibly refer to the judgment-stating the Court, the county where the judgment roll is filed, and if it be for money the amount thereof, and the amount actually due thereon, and if made payable in a specified kind of money or currency, as provided in section two hundred of this Act, the execution shall also state the kind of money or currency in which the judgment is payable, and shall require the Sheriff substantially as follows:

First-If it be against the property of the judgment debtor it shall require the Sheriff to satisfy the judgment, with interest, out of the personal property of such debtor; and if sufficient personal property cannot be found, then out of his real property; or if the judgment be a lien upon real property, then out of the real property belonging to him on the day when the judgment was docketed; or if the execution be issued to a county other than the one in which the judgment was recovered, on the day when the transcript of the docket was filed in the office of the day, or any time thereafter.

Second-If it be against real or perso-ATTORNEY AND COUNSELLOR AT | nal property in the hands of the personal representatives, as devisees, legatees, tenants of real property or trustees, it shall require the Sheriff to satisfy the judgment, with interest, out of such property.

> Third-If it be against the person of the judgment debtor, it shall require the Sheriff to arrest such debtor and commit him to the jail of the county until he pay the judgment with interest, or be discharged according to law.

> Fourth-If it be issued on a judgment made payable in a specified kind of money or currency, as provided in Section 200 of this Act, it shall also require the Sheriff to satisfy the same in the kind of money or currency in which said judgment is made payable, and the Sheriff shall refuse payment in any other kind of money or currency; and in case of levy and sale of the property of the judgment debtor, he shall refuse payment from any purchaser at such sale in any other kind of money or currency than that specified in the execution. The Sheriff collecting money or currency in the manner required by this Act shall pay the plaintiff, or party entitled to recover the same, the same kind of money or currency received by him; and in case of neglect or refusal so to do, he shall be liable on his official bond to the judgment creditor in three times the amount of the money so collec-

Fifth-If it be for the delivery of the possession of real or personal property, it shall require the Sheriff to deliver the possesston of the same, particularly describing it, to the party entitled thereto, and may at the same time require the Sheriff to satisfy any costs, damages, rents or profits recovered by the same judgment out of the personal property of the person against whom it was rendered, and the value of the property for which the judgment was rendered to be specified therein; if a delivery thereof cannot be had, and if the same kind of money or currency, and

Sec. 4. Section two hundred and eleven execution is issued on a judgment recovered against two or more persons in an action upon a joint contract in which action all the defendants were not served with summons, or did not appear, it shall | direct the Sheriff to satisfy the judgment out of the joint property of all the defendants, and the individual property only of the defendants who were served or who appeared in the action. In other respects the writ shall contain the directions specified in subdivisions one and four of the last section.

Sec. 5. Section two hundred and twenread as follows: Section 221. Before the sale of property on excecution, notice thereof shall be given as follows:

First-In case of perishable property, by posting written notice of the time and place of sale in three public places of the township er city where the sale is to take place, for such a time as may be reasonable, considering the chacter and condition of the property.

Fourth-When the judgment under which the property is to be sold is made payable in a specified kind of money or currency, the several notices required by this section shall state the kind of money or currency in which bids may be made at such sale, which shall be the same as that specified in the judgment.

Sec. 6 Section two hundred and twenty-nine of said Act as amended by Section 3 of an Act entitled an Act to amend an Act entitled an Act to regulate proceedings in civil cases in the Courts of justice of this State, passed April 29, 1861, passed May 15, 1862, is amended so as to read as follows: Sec. 229. Upon the sale of real property, the purchaser shall be substituted to and acquire all right, title, interest and claim of the judgment debtor thereto, and when the estate is less than a leasehold of two years unexpired term, cases the property shall be subject to redemption, as provided in this chapter. The officer shall give to the purchaser a certificate of sale containing : First-A particular description of the real property sold. Second-The price bid for each distinct lot or parcel. Third—The whole price paid. Fourth—When subject to redemption, it shall be so stated; and when the judgment under which the sale has been made is made payable in a specified kind of money or currency, the certificate shall also state the kind of money or currency in which such redemption may be made, which shall be the same as that specified in the judgment. A duplicate of such certificate shall be filed by the officer in the office of the Recorder of the county.

Sec. 7. Section three hundred and forty nine of said Act is amended so as to read as follows: Sec. 349. If the appeal be from a judgment or order directing the payment of money, it shall not stay the execution of the judgment or order unless a written undertaking be executed on the part of the appellant, by two or more sureties, stating their places of residence and occupation, to the effect that they are bound in double the amount named in the judgment or order, that if the judgment or order appealed from, or any part thereof, be affirmed, the appellant shall pay the amount directed to be paid by the judgment or order, or the part of such amount as to which the judgment or order shall be affirmed, if affirmed only in part, and all damages and costs which shall be awarded against the appellant upon the appeal. When the judgment or order appealed from is made payable in a specified kind of money or currency, the undertaking required by this section shall be drawn and made payable in the same kind of money or currency specified in

such judgment. Sec. 8. Section two hundred and thirtythree of said Act is amended so as to read as follows: Sec. 233. The payments mentioned in the last two sections may be made to the purchaser or redemptioner, as the case may be, or for him to the officer who made the sale. Resolved, That foremost among these principles are the freedom of speech, the liberty of the press, and the free and unrestrained exercise of the elective franchise, which are the boast of freemen, and are "formidable to

tyrants only."
Resolved, That while we will cheerfully submit to constitutional authority, we would at the same time say to the party now in power, you cannot, shall not, under the pretext of subduing the rebellion in the south, utterly extinguish the liberties of the people in he

Resolved, That we will, and do now, constitute ourselves into a Democratic Glub, for the purpose of carrying into effect the foregoing resolutions, and recommending to our fellow democrats the organization of similar clubs in every precinct in Yolo county.

Something to be Considered.

The prospect of a failure of the crops in this and other counties, is now the theme of general conversation among the farmers and business men; and well it may, for if the crops fail this year, it will set the farmers back to where they were three years ago, and of course injure the merchants, and business men generally, to a proportionate extent. This year, in consequence of good crops last, most of our farmers have largely involved themselves, taking for granted as true, that "one wet season will insure good crops for two years with but light rains"-the fallacy of which has, we are sorry to say, been proven too often, yet our people in the valley appear to cling to the theory with a tenacity that is truly surprising, notwithstanding all the proof to the contrary, and, like a consumptive who is sinking at every breath, yet believing he will recover, when every moment should admonish him to prepare for the worst, so it is with us all, we cling to this false theory with the hope that it may prove true some time; and here is the rub, and the consequences are too plainly to be seen this season in men hoping against hope. We have entirely laid aside and apparently forgotten that old and true maxim, that "in time of peace prepare for war," and have adopted the one that "we can afford to loose every other crop and yet remain in good circumstances," therefore we have neglected to guard against the danger of dry weather Ought not our farmers to learn a lesson by their past experience in farming in this portion of California, and try to devise some plan whereby they can appropriate the means at hand to prevent the failure of crops in future? and should not our business men assist them to the extent of their ability? Certainly they should; for they surely are aware that from them they draw all their trade and support that is really of a substantial and permanent nature, and In another column will be found an

article, written by W. S. Green, Surveyor of Colusa county, to the editor of the Colusa Sun, on the subject of irrigation .-As to the feasibily of his plan we are not prepared to give an intelligible opinion, but the article nevertheless is on a subject that should just now attract the attention of the settlers and men in business of this siction, and indeed of the people of the entire valley, and we therefore re commend that our readers carefully consider what he has suggested, and perchance it may lead to some good and much need results. It cannot be denied that at some future time irrigation must and we believe that the sooner commenced the better for all concerned. The farmers and business men are not the only ones who have adopted the motto refered to, but our legislators during last winter took the same view, as appears from their indefinitely postponing a resolution offered for the purpose of raising a committee to consider the propriety of a survey for a canal from Knight's Landing across the tule lands of Yolo and Solano counties to Suisun Bay. The plan of Mr Green differs only as regards the place of commencement of the main canal. He thinks it should start above Colusa instead of at this place. Well, he may be correct, and if he is, we care not, so the great object is attained, viz: Irrigation.

Irrigation is not only offered by his plan, but if adopted, will reclaim to the State over half a million acres of swamp lands, and nearly the same amount of high prairie lands, which are rendered almost worthless by the lack of the means for irrigation This alone should have been inducement sufficient to have raised said committee, and to have authorized a survey at the expense of the State; but no, the vital interests of the State and people must give way for party purposes and personal aggrandizement, and therefore it behooves the people to look to their own interests in matters that effect their pecuniary welfare.

We do not propose any plan for irrigating, for the simple reason that others are better capable, and undrstand better how it should be done, but merely call attention to this important subject, with the hope that others will take up the pen and give us their views through our columns, for what is their interest is ours also, and we sincerely desire to see this county at least saved in the future from the impoverishing effects of the frequent drouths, and we hope those interested will not be

WE publish some new laws which will be found interesting to our readers.

Irrigation.

The Surveyor of Colusa county, W. S. Green, writes to the Sun as follows:

There is no subject of more importance to the people of the Sacramento Valley than irrigation. All are interested in it; for it has been thoroughly demonstrated that there is no portion of the valley free from the danger of short crops, without the land can be overflowed during the winter and spring months. There is no question about the utility of a system of irrigation. The only question to be answered is, can there be a plan adopted by which all the lands in the valley can be

flooded during high water? I answer this in the affirmative. I propose to levee the west bank of the Sacramento river from a point near Jacinto to the high lands below Rio Vista, and the east bank from a point a little higher up to the mouth of the Feather river; then levee up Feather river to the high lands of Oroville; then cut Butte creek into the river at the lower end of Grizzly Bend, and dam across so it could not run below. Near this, on the west side of the river, I propose to begin to cut a canal of a sufficient size to carry off all the water that now fills up the tule on either side of the river. I would cut this about eighteen feet deep at the river, and run in such a direction as to get to the top of the ground in the low lands back in the shortest distance. I would then build levees of sufficient strength to hold the water, keeping as far in the plains as the fall would permit, so that by the time it should reach a point west of Colusa, it would be as far back as Gibson's. Crossing Cache creek above Cacheville and Putah above Davis' and keeping around near the joints of the hills of Vacaville, I would run it into the bay just east of Suisun City. This would totally reclaim over a half million acres of swamp and overflowed lands, and nearly the same amount of high prairie lands which are now almost worthless, and which Congress would very readily grant to the

State to assist such an enterprise. At the head of this canal it would be necessary to construct a lock, in order to regulate the water through it. In a season when there is not a great deal of high water, the gates of the lock need never be opened until the water had fallen several feet below the natural bank of the river, giving persons below all the time possible in which to flood their lands .-Then the canal being eighteen feet deep at the river, and running out to the top of the ground. It would give plenty of time to flood the plains back. A regular system of irrigation should then be inau-

gurated, both from the river and canal. I am becoming an enthusiast on the subject of this canal, for it has been my canal for the past ten years. It can be done; it must be done; it will be done. I have mentioned it along from time to time, when I thought I would be listened to. At first the idea was derided, but now practical men favor it. I explained my plan to the present Surveyor General just as he was elected to office, and I see by his Annual Report that he in part adopts it. He says take the canal out obove Knight's Landing, when it should be above Colusa. In my swamp land paper published in the first number of n, you will find this subject men But that is a subject of the future, and now let us talk of something that should be done this year-now.

For five thousand dollars the water of Sycamore Slough can be made to irrigate fifteen thousand acres of the best grain land in the world!

To do this it would only be necessary to construct about four locks on the slough -one just below the 'Dry Slough Ditch,' one near Allen's, one near Steele's and one near Spicer's. When the river was anything near bank full, all the ranches might be irrigated at once, as there need not be more than a quarter of the slough stopped at the first to throw the water over the bank; then shut up half the channel at the second, three-fourths at the third, and all at the fourth. It might be necessary to use it exactly in this proportion, but it could be so managed that all the water that runs through the slough could be used for irrigation, if required; for whenever the water will run in the slough at all, it can be thrown out of the banks at Steele's or Spicer's. This would enable the 'Dry Slough Company' to get plenty of water without interfering with the interests of those living down Sycamore Slough.

This work would not be lost if the other larger plan spoken off should be carried into operation, for all that it would then be necessary to do would be to construct a lock at the head of the slough to shut the water entirely off when everybody believed they were through with it.

THE MORMONS .- The 'faithful' in Salt Lake City are growing troublesome again, and have ordered the U. S. officers to leave the Territory. A Salt Lake City dispatch of the 9th inst., to the Chicago

Tribune says: "Gov. Harding, as well as Judges C. B. Waite and Drake, in very emphatic language, refuse to resign or leave the Territory. Gov. Harding said to the committee: 'I will not cowardly abandon my post of duty until it shall please the President to recall me. I may be in danger of personal violence by remaining, but I will not leave. I will not be driven from the Territory. As this is said to be a land of prophecy, I too will prophecy: If one drop of my b'ood is shed whilst in the discharge of my duties, by your ministers of vengeance, it will be avenged, and not one stone in your city will remain upon another."

BY OVERLAND TELEGRAPH.

The following dispatches are from the Sacramento Union of May 9th:

CHICAGO, May 5th-10 A. M .- The Times and Herald contain long and interesting accounts of the operations of Hooker's army. The Times' correspondent states that after three days skirmish. ing on both sides, on Saturday afternoon and evening the rebels attacked our right flank, Jackson, with his whole corps of 40,000 men, throwing himself impetuously on Howard's Eleventh Corps; but the movement was only partially successful, and, reinforcements being promptly sent by Hooker, the rebels were handsomely checked. Howard's corps consisted of Schurz's, Steinwehr's and Devens' divisions. The Times' correspondent says this corps disgracefully abandoned their position behind their breastworks and rushed panic stricken towards headquarters. Our right was thus completely turned and the rebels in a fair way of doubling us up. Hooker was immediately in the saddle, and turning to the commander of his own old corps, Gen. Berry, shouted 'General, throw your men men into the breach and receive the enemy on your beyonets! Don't fire a shot. They can't see you." Berry's men rushed gloriously on the doublequick to the rescue, pressing forward with a horrid array of glittering steel. The enemy were checked, and retired to the breastworks just abandoned by Howard's corps. Our batteries were immediately massed on the crest of the hill, pouring in a terrific fire until far into the night. In the charge of the rebels they took from the Germans twelve pieces of cannon. The Germans fled past Hooker's headquarters in a panic. Many members of the staff, with pistols and sabers, vainly endeavoring to stay their flight. The artillery combat continued fiercely until midnight. Hooker and staff were all the time under the severest fire.

The enemy are no longer in our rear, but directly in our front, between us and our forces in Fredericksburg-we occupying a fortified and intrenched position. The enemy gained some ground, but at the sacrifice of five of his seven divisions. On Sunday afternoon the rebels made several attempts to force our lines-several of his batteries and regiments being actually destroyed in attempts to carry the apex of our position, near Chancellor House, where a large quantity of our artillery is massed. Our present position is impregnable. Gen. Lee ordered that our lines must be broken at all hazards, but the rebels will only destroy themselves by their attacks. Our troops are perfectly cool and confident. The rebel General Hill is reported killed. Gen. Berry was

killed while leading his brave men. NEW YORK, May 5 .- Among the killed and wounded are the following: Maj Gen. Berry of Maine, killed; General Devens of Mass., wounded in the foot; Gen Mott, wounded in two places; Lieut. Col. Scott of the Third Wisconsin, killed; Capt. Templer, Second Regulars, killed; Lieut. Crosby, Fourth Regulars, killed ; and also a large number of field and company officer killed and wounded, mostly from New York and Pennsylvania.

A Falmouth letter dated Sunday even-

ing, May 3d, says:

Gen. Sedgwick (Sixth Corps) attacked the hights of Fredericksburg to-day, gallantly carrying them by storm, capturing the 16th and 18th Miss. Regiments, one company of the New Orleans Washington Artillery, with eight guns, and over 1,000 prisoners. Gen. Gibbon planted the stars and stripes over the rebel works. Our loss is moderate. Sedgwick afterwards drove the rebels back, and at six P M. on Sunday had advanced to the Brick Church four and a half miles towards Chancellorsville, on the plank road. Here he had a severe fight with Earl's rebel division, reinforced by Lee, but repulsed them, taking a lot of prisoners.

The enemy are now hemmed in between Hooker and Sedgwick, and the advantage is decidedly with us. The Herald says our loss in storming the Hights of Fredericksburg was about 1,000 killed and wounded.

CINCINNATI, May 5.—C. L. Vallandig ham was arrested at his residence in Dayton, Ohio, this morning, by soldiers sent from here. An attempt to rescue him failed. He has been brought to this city. NEW YORK, May 6.—The following is

from the Herald's Extra:

Our messengers from Hooker's army bringing the details of his movements to Monday night, and of the movements of Sedgwick to two o'clock Tuesday morning. Hooker maintained his new line on the edge of the woods, a short distance north of Chancellorsville, crossing the main road leading to U. S. Ford, without important change. There was no fighting there until late Monday afternoon, when a division of the Fifth Corps advanced towards Fredericksburg, meeting the rebel skirmishers in the woods and driving them back. The main body pushed ou, meeting large bodies of rebels in double line of battle. A half hur's fighting ensued, our batteries compelling the rebels to fall back in disorder. The division then returned to our main line and rested, having ascertained the enemy's position .-Hooker on Sunday night and Monday intrenched himself, and is abundantly able

to resist any rebel attack. From various published sources the following is compiled:

From Sedgewick's corps, the Herald prints the following in substance:

His men were obliged to give way to overwhelming masses of rebels, and his discomfiture seemed certain, when a Vermont brigade made a furious charge, re-

pulsing them, and securing the safety of that portion of the army. The slaughter of the enemy here and near Banks Ford was perfectly terrible—whole brigades of the rebels being wiped out. Sedgwick recrossed the river, the enemy raking our brigades with artillery, and causing great loss of life. He succeeded in crossing in comparatively good order, and marched immediately to U. S. Ford to gain the

Longstreets's forces are not with Lee, but between Richmond and Suffolk.

In answer to a question from the President, on Monday night, Hooker said :-"The matter of retaking Fredericksburg by the rebels was of no consequence." Gold unsettled, closing at 51% (a)52.

The Tribune has a Murfreesboro telegram of May 5th, which says: Deserters report that communication between Vicksburg and Richmond, Charleston and Tullahoma has been cut off.

WASHINGTON, May 5th .- Additional prisoners from the Rappahannock, making in all over 4,000, have arrived.

MOBBED ..- Thad. Stevens, late Chairman of the Ways and Means Committee, when addressing a public meeting at Lancaster, Pa., on the 11th of March, was interrupted by groans and yells, and received a liberal shower of assorted vegetables and rotten eggs. The proceedings were very riotous, but nobody was hurt.


