SUMMARY OF INFORMATION:

SUBJECT became Vice-Consul, Manila, P.I. in October 1984. In 1940 he was promoted to Consul, in which capacity he served in Davas, P.I. and later in Manila, P.I. (1942).

SUBJECT was relieved of his position in Manila in favor of an assignment to the Foreign Ministry, Tokyo. During the year of 1943 SUBJECT assumed the title of Civil Administrator, Military Government Headquarters, Philippine Islands, wherein he served until promoted to Consul-General, Manila, 24 September 1945. Left for Japan 3 November 1945.

REMARKS:

CIS/G-2. FEC, recommends release of KIHARA without preference of charges unless a basis for charges has been uncovered in Manila. P.I. It is to be noted that SUBJECT held an influential office in the Philippine Islands during the period of occupation. It is a matter of common knowledge that during SUBJECT's term of office mass atrocities were committed in the Philippines. It must also be noted that during this period of time the Japanese Government promoted a program of New Philippines. This plan had among its numerous purposes the formation of a new government for the Philippine Islands. Attention must also be given to the fact that SUBJECT rose rapidly in diplomatic ranks, and that, by virtue of the varied positions he held in the Japanese Government he exerted or failed to interrupt the influence of the Japanese war program in its course of conquest and expansion.

RECOMMENDATION:

as a Class A war criminal suspect and tried before an International Military Tribunal in Tokyo.
