The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred on it by paragraph eighteen of Part II of the First Schedule to the Public Health (Tuberculosis) Act (Northern Ireland), 1946, and by sections twelve, seventy-six, eighty and eighty-one of the Health Services Act (Northern Ireland), 1948, with the approval of the Ministry of Finance for Northern Ireland, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Health Services (Charges) (Amendment) Regulations (Northern Ireland), 1952, and shall have effect as from the first day of June, 1952.
- (2) Any reference in these Regulations to any enactment shall be construed as a reference to that enactment as amended by or under any subsequent enactment.
- (3) The Interpretation Act, 1889, shall apply for the interpretation of these Regulations in like manner as it applies for the interpretation of an Act of the Parliament of Northern Ireland.
- 2.—(1) In Regulation five of the Health Services (Hospital Charges for Drugs and Appliances, etc.) Regulations (Northern Ireland), 1952 (a) the words "and appliances" shall be deleted.
- (2) At the end of the said Regulation five there shall be added the following paragraph:
 - "(2) The charges authorised by these Regulations shall not be payable in respect of appliances prescribed or ordered before the date on which these Regulations come into operation notwithstanding that they may have been supplied on or after that date."
- 3. At the end of paragraph (ii) of Regulation four of the Health Services (Charges for Drugs and Appliances) Regulations (Northern Ireland), 1952 (b) there shall be added the words:—

"or upon which another drug or appliance is ordered on a prescription form for supply otherwise than by the practitioner."
