Diary of Frank A. Kimball

The saddest "New Year" ever passed in this house where we have lived more than 26 years - "Sister" & Mrs. Kimball's with her brother James Currier at Polero - 40 miles away - just watching him pass to the great "Unknown" - and I look for her to come home - bringing with her, the last of her race - except herself - poor dear "Sister" -

It has been an exceedingly pleasant day - Angelo Poggitti helped me take down a large limb which had been broken & by weight of the cones, from the great Cyprus tree in front of our house. The limb was more than 35 feet long. Rode to Cemetery to take the measure for stone wall to put around Mother's grave. Mattie went with me to hold the horse. Came back by the

Post Office
 and got "Sisters" letter "Bless her"
 have written a good many letters to-
 day and this way - Poor dear "Ma" I
 wish she were here tonight -

Wednesday January 2^d 1895

Took the 8^o train and went to Enci-
 nitas - W. C. K. with me - Geo Michener
 took us over the ranch - met a number
 of Ranchers and agreed to lease land
 to them for 1/5 of the crop in sack or bale
 delivered on cars at Encinitas Station
 Geo Michener is to set stakes for all
 of the parties and see that no one in-
 terferes with another - we are to have
 the stubble - when a crop is gathered
 each man is to surrender the land.
 Came home at 10 o'clock P.M.

Angelo let Kitty run home alone but
 nothing was damaged or lost from
 the buggy -

Thursday January 3^d 1895

1895-

Recd "Sisters" letter in P.M. "Bliss Ter"

Have worked around the yard, side-walks, trees &c - The Russian tree trimmer helped me get wood into the shed and clear up the yard and plant a bed of Tulips Narcissus^{es}, Hyacinths and Crocuses
Went to Mr. Slocums - San Diego and got Photographs of Olive Orchard - same showing picking of fruit - also interior of mill - showing Olive Oil making machinery - filtering & packing room and exterior of mill building 75 x 50 + 25 x 40 feet - two stories high - Also Old Mission Olive Orchard & ruins of Old Mission buildings - and have packed and mailed them with my "Paper on The Olive Industry" - To Prof. C. S. Luges - U.S. Permittologist, Washington D.C.

Friday January 4, 1895

Waited for Mr. Harris all of am + till post 3 in P.M. then went to San Diego - on the way delivered a 3 gal. keg of olives at Mr. Slocums house
wrote Sister "Bliss Ter" - Attended School meeting

Sunday Jan. 6. 1895.

At home in Am. writing most all the time. In P.M. Carried Myrna Patters down to Chulu Vista to Mr. Johnsons. - The roads are awfully muddy. Reading in evg. rained a little at 5 o'clock - Wrote "Sisters" a good long letter "Blephar" -

Monday 7. Jan. 1895.

Finished "Sisters" letter and carried it and her coat to the P.O. to be taken to Patros by the Stage driver. I expected to have gone to the Quarry at 1.40 but W. C. K. came over and said he had made an appointment with Mr. Seth Abbott to meet us here at my office tomorrow at 10 o'clock. Mattie Johnson drove home Chulu Vista - this P.M.

Have begun "Sisters" letter to go Wednesday morning. Am all alone in this great house tonight - unless Mr. Bell comes over to sleep here.

Theodore Araara came to get his pay for 145^{ft} of very small olives - paid

ticultural Hall - I moved to appeal

midnight. Then came home &
read till two o'clock and think
I had best go to bed - Bless my "Ma"

Saturday ~~Dec~~ 12, 1895 -

Up in good season and took the 8⁰⁵ train for Encinitas - with Mr Dilas Abbott and a Mr Burns of San Diego. They left the cars at Encinitas and I kept on as far as San Onofre where I took the train for National City. At the apple orchard to see how the Russian is getting on trimming trees - has worked all day when cutting weeds. Or. one day -

 stage could not get through - at home
 all day alone - not a soul here - "Phy Ma"

Wednesday, Jan. 16, 1895
 Carried "Sisters" letter to P.O. but no mail will go

Heavy rain and wind began at midnight and has continued all day - with very little cessation and at 10 o'clock evening is raining steadily -

Have been at home all day except to go to the P.O. to take a letter for "Sisters".

Nothing has yet been heard of the stage which should have arrived from Potrero yesterday P.M. - Sweetwater reservoir full and overflowing - the waste weir being too small - the water has risen over the parapet wall and is now flowing a solid stream over the whole length of the dam - Water now covers 800 ft.

National Avenue from bank to bank of Paradise Valley. DeFord had to secure the foundation of his Barley mill with ^{buys of} sand.

Started to go to Sandings on the 8:15 train but got only to Coronado Crossing - when the train returned S.P. R.R. only took the train to Linda Vista and has not returned

Thursday, June 17, 1894.
 Rained a good deal during the night.

and at 7 o'clock had the heaviest wind and rain since the storm began. and has blown down over half of my largest olive trees here at my house -

sent another letter to P.O. for "Sister" - but do not know when it will go -

Began to cut the grass on the lawn North end of the house -

In P.M. rode to the Curitwater Dam and found the water running 17.5 down inches deep over the parapet wall. Last night at 8 o'clock it was running 22, twenty two inches over the parapet - Wrote up Paradise valley to the North of the R.R. bridge - unhampered and tied the horse and walked about a mile and a half to the dam - and back again - Russian at work about $\frac{3}{4}$ of the day in the green house - Mr. Bell $\frac{1}{2}$ day on lawn - No letter from Sister - "Stephan"

Friday January 18, 1895
 Some slight showers during the
 day - but not enough to make us quit
 work. The Reesian has been at work in
 the Green House all day - and Mr.
 Bell and Chair been at work mow-
 ing and clearing the lawns -
 Took "Sister's" letter to Post office at
 7 o'clock - no Paturo mail has come
 in and none will go out -

Rain began again at 9 o'clock evg - with
 heavy wind from S.S.W. nearly and
 Barometer at 29³⁰ appears as though
 the storm has just begun - Bless my
 "Ma" - Joe Sherman called a few
 minutes - to enquire for "Sister" -

Saturday January 19, 1895
 No letter from "Sister" - Not possible for
 for a mail to get from Paturo to Na-
 tional - Rained very heavy nearly
 all of last night - and has rained
 a good many times during the day

Saturday Jan. 19, 1895

Rain fell in greater quantity in same time this P.M. than at any other time during the storm. Frank Hargis and Joe Sherman had to turn back from going down to Frank's cuds.

The sailing of the bridge at 24ST + 6 ac^E is all under water. Bread — .10

The Popian has worked about 3/4 day trimming mounds, lawn &c. Mr. Bell has worked about the same time on lawn &c. — I have worked awful hard and am very tired.

This evg. my heart troubles me a good deal. Labors very heavy.

I do hope "Sister" may come before it may be too late. I can't stand this fearful financial strain much longer. Something must give way, and I expect it will be my heart. Dear dear "Ma" — I can bear everything else but you — without regret. How wretched man can be —

Sunday January 20. 1895

Have been alone all day - till afternoon Myrtle and Hattie came up from Okula Vista on foot, over the Coronado RR track which in some places was only held in place by the Fish plates - which kept the rails in place - the grade being all washed away in places - and submerged all of the way across Surtwater valley - Myrtle rolled her wheel all of the way - The post work has been awful tiresome but seems so much more comfortable since they came - The house is not nearly so large - Have written a good many letters today - Bless My Ma "P"

Monday January 21. 1895

Rufusian at work cutting the tops from the Olive trees which were blown down during the storm - Mr. Bill. went to San Diego with Quarus. for Mr. Gatis.

Carried "Sieters" letter to the P.O. in the morning - but with no expectation that it would

A bright pleasant day -

Russian cutting tops from the Olive trees which were blown down - Mr. Bell worked at the barn in A.M. and at the olive trees in P.M.

Wrote "Lister" and got 2 prescriptions filled at Mr. Hills. from Dr. Risdon - also got from him a letter to send to Sister -

Rode a mile on a bicycle today. Reading a novel in eve. Stamps 1.00

Friday January 25. 1895 -

The Russian Mr. Bill and the other man - at work with me on the olive trees. Poggelli took the team and

 Had some boys picking skins -

Angels hauling wood from the wharf -
 Hattie drove to San Diego in A.M. and
 in P.M. I drove her to Chula Vista &
 back again over the worst road I ever
 saw - Wrote "Sister" and sent a long
 letter "Blapher" - My heart is again
 tumbling me - from indignation per-
 haps. Has taken a spoon full of Jamaica gum

 Letter from "sister" came at 11 am
