- 12—Autograph Letter to Lieutenant Maury, from His Imperial Highness Ferdinand Maximilian, Archduke of Austria, transmitting, on behalf of His Imperial Royal Apostolic Majesty the Emperor of Austria, the Austrian great golden medal for art and science, with reply from Lieutenant Maury.
- 13—Gold Medal, presented by the King of Sardinia. Obverse: The bust of the King, with the words Vittorio Emanuele II. Reverse, within a wreath of laurel: 'Le Capitano M. F. Maury, Insigne Idrographe Benemer Ito Della Navigazione' 1858.
- 14—Gold Medal, presented by the Emperor of the French. Obverse: Napoleon III., Empereur. Reverse: Donne Par Empereur a Monsieur La Lieutenant Maury, Directeur De L'Observatoire a Washington. 1859.
- 15—A set of thirteen (13) Silver Medals, commemorative of the following principal events of his Pontificate on behalf of His Holiness, Pope Pius IX.: (1) On the 22d of August His Holiness visited those afflicted with the plague at the Hospital of the Holy Ghost; (2) He renews and extends the means of education of boys, "Suffer little children to come

unto me"; (3) Extension of museum of the palace; (4) The first visit to the prisoners; (5) The opening of the railway from Rome to the provinces; (6) The Appian way reopened; (7) Reornamentation of the Vatican Basilica; (8) The destruction of the dragon, "And Daniel said, Behold what you have been worshipping"; (9) Restoration and ornamentation of the gateway upon the summit of Saniculum; (10) The immaculate conception of the Virgin declared December 8, A. D. 1854; (11) Thou shalt appoint teachers through the tribes; (12) Albano and Aricia united by a bridge; (13) The guardians of Rome and the judges of nations. As a mark of his appreciation of Lieutenant Maury's services in the cause of science, His Holiness established distinguishing flags to be carried at the mast-head of all vessels from the States of the Church whose masters would co-operate at sea in his new system of research. Those whose journals were approved by its founder received military rank from the government, and became entitled to salutes as they passed its forts.

- 16—Medal of the Universal Industrial Exhibition, London, 1851, awarded for the wind and current charts and the sailing directions. Obverse, Incircling a head of Prince Albert these words: H. R. H. Prince Albert, President of the Royal Commission. Reverse: For Services. Exhibition of the Works of Industry of all nations. MDCCCL.
- 17—Gold Medal of the French Exhibition, 1855. Obverse: Napoleon III., Emperor. Reverse: Medaille D'Honneur Agriculture Industrie Beaux-Arts. Exposition Universelle de 1855.
- 18—The Cross of the Order of the Danebrog Presented by His Majesty the King of Denmark. By special act of Congress consent was given to Lieutenant Maury to accept this decoration.
- 19—The Cross of the Order of the Tower and Sword of Portugal, presented by His Imperial Highness the King of Portugal for "Valor, Loyalty, and Merit."

(NOTE.—These decorations, The Danebrog and The Tower and Sword, in accordance with custom and the express directions of Captain Maury, were, upon his death, returned to their Majesties who had presented them, but Colonel Maury then begged

that they might be sent back to him, to be retained as precious souvenirs of the honors conferred upon his father. This prayer was graciously granted and the decorations were subsequently returned to Colonel Maury.)

- 20—The Grand Cross of Our Lady of Guadeloupe of Mexico, conferred by His Imperial Highness the Emperor of Mexico.
- 21—Autograph letter from Maximilian conferring the above-mentioned order.
- 22—Diamond Pin, presented by His Imperial Highness the Archduke Ferdinand Maximilian of Austria, with accompanying autograph letter.

- 24—Autograph letter to Lieutenant Maury from His Imperial Highness the Grand Duke Constantine, Grand Admiral of Russia, written at the instance of the Czar, offering a home upon the banks of the Neva.
- 25—A Casket, which was presented (a gift contributed by friends and admirers in Europe) in 1866, and a Testimonial illuminated upon parchment “To Captain Matthew Fontaine Maury, LL. D., etc., etc. We, the undersigned, beg your acceptance of the accompanying purse of three thousand guineas in appreciation and acknowledgement of the eminent and disinterested services which, through years of untiring zeal in the cause of science, you have rendered to the maritime nations of the world. Receive from us this public testimony of our regard, with every wish for your future welfare and happiness.”

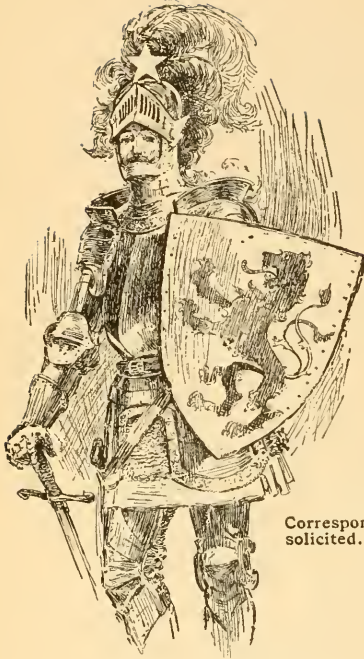

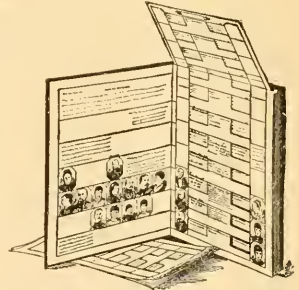

Showing one page of Bailey's Ancestral Album filled.

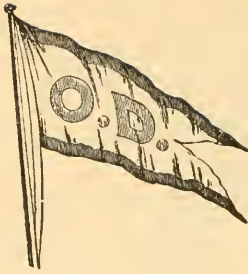
