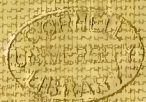



He drove from Bellport to Smithtown with his son John to a family named Smith, and signed his will on the top of his hat while seated in his wagon. The Smiths witnessed it. He was mentioned by his gdmother Willempy in her will as Charles Duryea's son George, the lame boy.
