On this date, advice was received from CIS that contact was made with an informant who was present at the GEA Conference, and the informant advises that FUTAARA's remarks were confined to a brief address of welcome to the students who attended the meeting. He states that Futaara was chosen for this address because of his eminent position and high standing in the Japanese Foreign Ministry, but distinctly recalls that Futaara made no further statement at the meeting after his brief welcome spee ch.

CIS further advises that new information supplied by the referenced informant indicates FUTAARA did NOT preside over this conference, as had been reported previously, and his role there following his speech was only that of a spectator.

Search through the columns of Tokyo daily newspapers of the time of the conference, discloses no mention thereof appeared in any of the daily papers, according to CIS.

countries and the welfare of the whole world. He said that the young generations are protesting against the obstinate thought of the old, which confines the aims of the nature of the state only to the self. Therefore, he says, it is premature to condemn them on grounds of disloyalty to the State. The author states that he, too, protests against the old concept of the State, and is highly confident of the dignity of Japan and in her role in the mission to carry out the work of divine purification of the world. He writes on the characteristic features of Japan and her geographical environment. Japan is fortunate to be surrounded by young and vigorous nations with a great future before them and she has a right and the duty to share it with them. He said, "Some are pessimistic of Japan's future from the fact that she has too large a population for too small a land. This pessimism is due to the feudalistic concept of the State with restrictive boundaries separating one from another. In view of the new concept of the State, there is a great possibility of solving this problem." (p 26)

The author states that Japan lacks self-discipline and further stated, "Japan has been fortunate and has not experienced much hardship so she became arrogant and haughty." (pp 32 - 33)

On the term "KOKUTAI", he stated that is is the feature of that country as defined by its environment, origin, andowment, and discipline. (pp 33 - 34)

In the chapter on the reflections of life and the loyalty of the people, the author states that the Emperor and the people are mutually dependent and co-existent like the sum and the night. So, the glory of the Emperor is the glory of the people and vice versa. (pp 45 - 49)

The people's belief in the ever-prosperity of "Life" with the Emperor as the incarnation of the "Truth" necessitates the installation of shrines where each individual practices his own truth. Thus, there is a toleration of other religious because each is considered to be a different manifestation of the truth.

The National Foundation Labor Service Corps of which FUTAARA, Yoshinori was Superintendent (SHIDO TOKAN), was inaugurated on 5 November 1939. The object of the organization was to commemorate the forth-coming 2600th Anniversary of the founding of the Japanese Empire by a program for beautification of the outer palace grounds in Tokyo. The work was planned to extend over a period of four years with participation of approximately 1,000,000 persons. Chief of the Directing Headquarters (SHIDO HOMBUCHO) was Major General SAKAI, Ikuzo (Retired).

participation in the beautification project was voluntary. Students from all types of schools and universities, employees of private companies, government workers, members of neighborhood associations (TONARI GUMI) and members of youth organizations (SEINEN DAN) were encouraged to contribute their labor services for one or two days.

Work on the palace grounds actually began on 15 November 1939. An average of 2,000 persons took part daily, and the number of contributors of free labor totalled 890,000 in October 1941.

SUBJECT: The Greater East Asia Youth Rally Conference.

Known also as "The Greater East Asia Youth Conference," this conference was a gathering of approximately thirty students from East Asiatic countries such as Burma, Siam, India and the Philippines. The meeting at which FUTAARA, Yoshinori was present was held from 1600 hours to 1900 hours, 11 May 1944 on the seventh floor of the Japan Life Insurance Building, Marunouchi, Tokyo. It was not a formal conference, but rather a discussion of Japan's foreign policy as explained to the gathering.

### SUMMARY OF RELEVANT POINTS

The author in this book gives a picture of the Imperial family and the Japanese state in ofder to combat what he calls the current tendency of "fearing" "dangerous thoughts" by certain people. He attributes the existence of "dangerous thoughts" (which he calls disloyalty to the Imperor and the State and antagonism to the government officials) to enthusiastic research on the nature of the Imperial family and the State without obtaining understanding and deep confidence in the doctrines of the conception of the State and the Imperial Family. The State is a living thing that grows day and night.

The author states that Japan has gone through two evolutionary stages; the first was confidence that Japan was not inferior, but even superior to other powers during the MEIJI Era, and the second was consciousness of the mission of Japan during the TAISHO Era. Now, during the SHOWA Era, Japan's outlook has become world-wide. It no longer was marrow and selfish, and now began to think of the other

countries and the welfare of the whole world. He said that
the young generations are protesting against the obstinate
thought of the old, which confines the aims of the nature
of the state only to the self. Therefore, he says, it is
premature to condemn them on grounds of disloyalty to the
State. The author states that he, too, protests against the
old concept of the State, and is highly confident of the
dignity of Japan and in her role in the mission to carry out
the work of divine purification of the world. (p 19)

He writes on the characteristic features of Japan and her geographical environment. Japan is fortunate to be surrounded by young and vigorous nations with a great future before them and she has a right and the duty to share it with them. He said, "Some are pessimistic of Japan's future from the fact that she has too large a population for too small a land. This pessimism is due to the feudalistic concept of the State with restrictive boundaries separating one from another. In view of the new concept of the State, there is a great possibility of solving this problem." (p 26)

The author states that Japan lacks self-discipline and further stated, "Japan has been fortunate and has not experienced much hardship so she became arrogant and haughty." (pp 32 - 33)

On the term "KOKUMAI", he stated that is is the feature of that country as defined by its environment, origin, endowment, and discipline. (pp 33 - 34)

In the chapter on the reflections of life and the loyalty of the people, the author states that the Emperor and the people are mutually dependent and co-existent like the sum and the night. So, the glory of the Emperor is the glory of the people and vice versa. (pp 45 - 49)

The people's belief in the ever-prosperity of "Life" with the Emperor as the incernation of the "Truth" necessitates the installation of shrines where each individual practices his own truth. Thus, there is a toleration of other religious because each is considered to be a different manifestation of the truth.

In the last chapter entitled "Criticism of the Idealogical Tendency of Present Japan", the author criticizes the imitations of the West. He said the main danger lies in certain elements attempting to effect a reformation in the manners of the West. The SHOWA tendency, he lamented is national consciousness, a faith in the expression of its own national characteristics.
