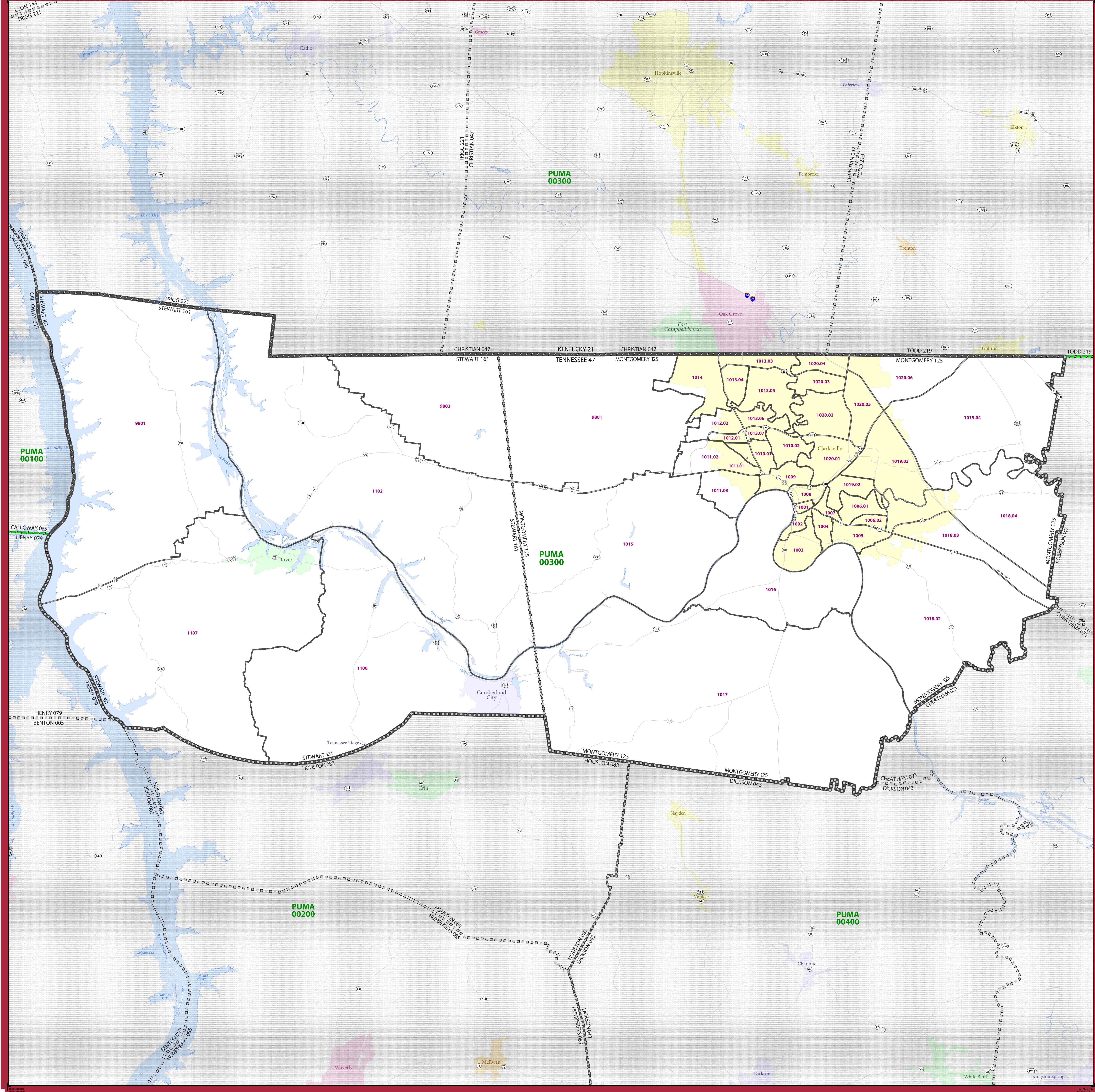


2010 CENSUS - PUMA REFERENCE MAP: Montgomery & Stewart Counties--Clarksville City

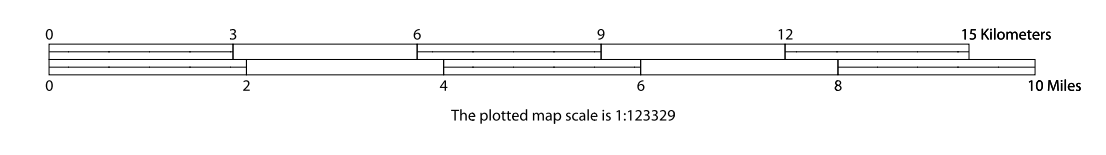
