

Carlos Antonio Piad y Del Pino, a Cuban exile residing in Washington, D. C., had been interviewed by representatives of the Federal Bureau of Investigation (FBI) in Washington. D. C., on June 6, 1968, relative to a "report", elleging great discontent in Cuba against Prime Minister Fidel Castro which he had received. Piad stated that the "report" was from a female friend in Cuba whom he declined to identify, and he said that this "report" was received in the mail addressed to his wife. Plad also said that he did not now have this written "report" which was received from the woman in Cuba. Piad said that he was certain that there was an apparatus in operation in Cuba which was fighting Prime Minister Castro, but "reports" were vague and he had no close idea of this patter. Pied was of the coinion that

Piad, in a letter to the FBI dated June 6, 1968, among other things, furnished the following:

"I am totally ignorant of any plans which
