引言

本館設立,十有餘载。先期所竅圖書,大都由中外人士之捐助,而得之于尼亞勃白恩先生家周者尤多。其後逐年添騰,蒐竅漸富。唯歷屆主持館務者,未按適當方法管理,各書大都未經分類編目。民國廿年秋,編者來館服務,乃重加整理,將全館書籍用最新方法分類編目,以利本院師生之閱讀。奈事甫進行,而溷戰突發,本院遷避西區,以館字狹小,工作因生阻礙。廿二年素,本院遷囘岷山路,始克繼積整理。至十月底,始將所有應用書籍,大抵編發。爰為便利檢查起見,因之彙印成編,以供讀者。斯編分類,雖以杜威分類法為遊本;但為適合本館之用,其中法律類之細目,略有歷補變更。編者於分類時,或因觀察之不同,或因材料之複雜,歸類自不無偏倚。舛誤之處,尚望明遠有以教正,是幸!民國二十二年十一月喻友信諧證

- 1. 本館圖書除有卡片目錄外,為求閱者更便於檢查起 見,特刊印此書本目錄。
- 2. 本館圖書,係按照杜威分類法分類;惟於法律類中 細目,及中日文分類,略有變更,以求適合本館之用。
- 3. 本目錄因急於付印,故本館所藏之九通,二十四史 ,刑統,大清律例根原,大元聖政國朝典章等書,未及分類 編入。
- 4. 本目錄內所載之書,十之七八係法學書,為求閱者 檢查便利起見,特編一西文法學類名索引,附於本目錄之後 ,以供檢查。例如,閱者如欲閱證據學(Evidence)書籍,可 於索引內,依字順檢查,證據學號碼為 347.94 ,再檢查目錄 卽得。
- 5. 本館已訂購而未到館之西文新書,特預列於目錄後 之附錄中,藉便參考。
 - 6. 本目錄編入圖書,截至民國二十二年十月止。
