

RICHARD L. NEUBERGER

Democrat, Candidate for Nomination for United States Senator



Richard L. Neuberger, famous Oregon author, has filed for United States Senator on the Democratic ticket. Thousands of people have read Mr. Neuberger's magazine articles about the Northwest and his books such as "The Lewis and Clark Expedition."

Now, Richard Neuberger seeks to stop the give-away of our natural resources. He will work to establish in Oregon a genuine two-party system, ending the Republican political monopoly which has dominated our state for generations.

Richard Neuberger says:

"With all my heart and soul, I believe the Hell's Canyon power site should not be surrendered to piecemeal

development. Along with nearly every leading educational organization in America, I think the tidelands oil deposits should have been preserved to help pay for mounting school costs in Oregon and other states.

"I agree with our major sportsmen's groups that the bill to let big timber corporations grab land within the National Forests is a blow to our conservation principles.

"We are being asked to trade proven power policies for a vague 'partner-ship' that has yet to generate a single kilowatt. Let us not forget that the New Deal power program, now ended by the Republicans, has been our main hope for new industrial payrolls. This program also brought a vast increase in electrification of Oregon farms from 27 per cent to 98 per cent, between 1933 and 1952.

"I shall work untiringly for the oil-for-education bill. This measure is desperately urgent to Oregon, where taxpayers are struggling to carry ever-

increasing school costs. Using the income from the oil deposits for the education of children is the grandest purpose to which it could be put."

Mr. Neuberger has emphasized that he will have only a small campaign treasury. "I am not pledged to special interests," said Mr. Neuberger. "I believe the voters will view with suspicion huge political slush funds to barrage the state with billboards, radio and TV time and countless printed broadsides."

Richard Neuberger is an Oregon product. He was born in this state 41 years ago. His wife Maurine, born and raised on an Oregon farm, has taught school in Milton-Freewater, Newberg and Portland. The two Neubergers are the only husband-and-wife legislative team in our history. In 1952 they polled the highest votes for the Legislature ever recorded.

The two Neubergers are associated with humanitarian proposals—help for retarded school children, statewide meat inspection to protect our health, colored margarine, tax deductions for money spent on baby-sitters by working mothers, conservation of state school timber. The Neubergers opposed vigorously the bill to harass elderly people with the relatives' responsibility act. They voted against the publicizing of old-age assistance rolls.

Richard Neuberger favors a progressive foreign policy to thwart the threat of world Communism. He believes a strong United Nations will help to prevent atomic wars that could imperil all mankind. Mr. Neuberger says: "I oppose the Bricker amendment, which would undermine the prestige of the President of the United States, and lessen his influence in international affairs."

Richard Neuberger is a veteran of World War II. He served more than three years in the Army. He is a member of the American Legion, Veterans of Foreign Wars and American Veterans Committee. He was aide to General James A. (Patsy) O'Connor, who constructed the Alaska Military Highway. During this duty in the wilds of the Yukon, Mr. Neuberger had many of the experiences which led recently to his famous best-selling book, "Royal Canadian Mounted Police."

All of Oregon recognizes that Richard L. Neuberger, one of the North-west's brilliant sons, will make a truly great United States Senator!

DONNELL MITCHELL

Democrat. Candidate for Nomination for Representative in Congress, First District



Donnell Mitchell was born in Oklahoma March 22, 1923. He moved to Oregon with his parents in 1925. He has spent the last 23 years in Willamina where he attended the public schools and the Methodist Church. After graduating from high school in 1940 he worked two years in the lumber industry before going into the army in February, 1943.

His army life was spent as a machine gunner in the 33rd Infantry Division in the South Pacific. The division saw action in New Guinea, Netherlands East Indies, the Philippine Islands, where he received the purple heart, and the Occupation of Japan.

He was discharged in December 1945 and has since worked as a hardware salesman, tire salesman, and is now employed as a salesman for Fredricks Motor Co. in McMinnville.

He attended Linfield College where he served on the student body council and was elected president of the Oregon Federation of Collegiate Leaders.

His major study was history with a minor in political science. He was also active in the speech department.

He was married in 1952 to Lucille Aerts of Banks, who holds a B.A. degree from Pacific University at Forest Grove and a M. A. degree from Columbia University in New York City. She is now the commercial instructor in the high school in Willamina.

He has two brothers, one older and one younger, who are stock holders in the Western States Plywood Mill in Curry County. His mother, Mrs. Lee Mitchell, who was active in the local democratic party for many years now lives with his younger brother since the death of his father.

He is now chairman of the Political Action and Industrial Development Committees of the Willamina Chamber of Commerce.

He believes that the economic and industrial expansion of Oregon hinges on our continued development of our water resources. This will insure an adequate supply of low cost power, which will make Oregon more acceptable to new industry. This will also help stabilize our economy and take up the slack from our declining lumber production in this area.

He believes in private development of our water ways so long as a small private project does not interfere with, or make impossible the development of a larger and more desirable project that could only be financed by the federal government.

The water shortage of this district is to him a very serious problem and he is convinced that something must be done in the near future to insure sufficient water for our farmers and industry.

CARSON HAS A PROGRAM

• He stands squarely for the full development of the Columbia, the Snake and their major tributaries, for the benefit of the people and not for the private power interests.

A program towards this end has been successful for a generation in providing cheap power for the use of rural and urban areas and the encouragement of industrial expansion.

CARSON IS EXPERIENCED

Carson, born in Kentucky, came to Oregon with his parents when a small boy. He attended the public schools in Hood River, and after leaving school worked in the orchards, logging camps and sawmills. He also worked in a dry goods store.

In 1914 he came to Portland and got a job at \$10.00 a week as a retail shoe salesman and at the same time entered University of Oregon Law School, attending law school at night and working in the daytime. Upon graduation in 1917 he was admitted to the Bar, and in May of that year enlisted as a private in the Oregon National Guard.

In July of 1918 he was commissioned a 2nd Lt. and in November of that year went to France in command of a company as a 1st Lieut. He returned to civil life in October, 1919.

For a while he was employed in Baker and Grant counties, Oregon, by a lumber company, but in 1921 returned to Portland and commenced the practice of law. (Continued)

CARSON WILL GIVE OREGON FORCEFUL LEADERSHIP—THE VITAL NEED OF THE HOUR

He continued in the practice of law until he was elected Mayor of Portland in 1932.

Carson ran on a platform of debt reduction and balancing the city's budget. Portland's finances were in a precarious position. He told the people exactly what he intended to do and after election proceeded to see that it was done. The city's finances were straightened out, its budget was balanced, the debt was reduced and its credit improved. While Mayor, a number of public improvements were planned or commenced, such as the sewage disposal system and Harbor Drive. He appointed the committee that originally undertook the job of planning for a new airport in Portland, which work was undertaken by the Port of Portland, resulting in the building of the Portland Columbia Airport. In 1936 he was re-elected, but did not seek any office in 1940.

In 1941 he was elected Department Commander of the American Legion, and at or about the same time was named by the late Mayor LaGuardia of New York to assist in the organization of the Civilian Defense. He continued in the capacity of Inspector General of Civilian Defense until called to active duty as a reserve officer in the early part of 1942.

He entered the service in March of 1942 as a Captain and was detailed to the Corps of Engineers. In the summer of 1943 he was ordered to duty overseas.

In London he became a member of a Joint Planning Staff, whose mission was the planning for the occupation of Germany and for the rehabilitation of liberated areas.

In March of 1945 he was assigned to the Headquarters, 12th Army Group, commanded by General Omar Bradley, and served as Executive Officer of the Displaced Persons Branch. He returned to the United States from Germany in November, 1945 and was separated from the service in March, 1946, as a Colonel.

Upon his return he re-engaged in the practice of law. In 1947 he was appointed by the President to be a member of the United States Maritime Commission, where he served until its reorganization placed maritime matters under the Department of Commerce.

While in the service, he was awarded the Bronze Star and now holds decorations from Norway, Belgium, Holland and Czechoslovakia.



POLITICAL VIEWS:


