The under following pistol received from your Headquarters on June 13 , the safety band and trigger is badly damaged and as it is impossible for repair and usage, we have made complete abandonment disposition as follows on June 14, 1950 under the presence of Assistant Police Inspector Takashi Yamasaki of Police Affairs Section, Police Affairs Division, Hiroshima Municipal Police Headquarters, so we shall submit this report.

In addition, the accessory 4 rounds ammunitions is under the custody at our Headquarters to be used on pistol of same calibre, and as it is registered in the ledger shall together make this notification.
