**DND BAC 2 RESOLUTION NO. AFPMP-PA-BALHELMET-2022-05-001**

***“Resolution Declaring MKU Limited as Post-Qualified and the Single Calculated Responsive Bidder and further recommending to the Secretary of National Defense for the issuance of a Notice of Award (NOA) in its favor for the Acquisition of 47,584 Units Ballistic Helmet Project.”***

**WHEREAS**, on 30 January 2020, the Secretary of National Defense issued Acquisition Decision Memorandum No. 2017-028-A.1 directing the immediate implementation of the 47,584 Units of Ballistic Helmet Project of the Philippine Army (PA) with an Approved Budget for the Contract (ABC) amounting to PhP1,189,605,000.00;

**WHEREAS**, the DND Bids and Awards Committee 2 (DND BAC 2) conducted the Pre-Procurement Conference for the project on 29 October 2021 and the Pre Bid Conference on 02 February 2022 respectively;

**WHEREAS**, on 23 & 28 February 2022, the DND BAC 2 conducted the Submission, Opening of Bids, where a total of Four (4) Bidders participated for the PA 47,584 Units of Ballistic Helmet Project;

**WHEREAS**, on the same conference, one (1) bidder was declared as eligible to bid while the three (3) other bidders were declared ineligible to bid and subsequently, manifested their intention to file their respective motion for reconsideration;

**WHEREAS**, on 11 March 2022, MKU Limited was declared by the DND BAC 2 as the Single Calculated Bidder (SCB) with a financial offer in the amount of PhP1,077,539,680.00 and the conduct of its post qualification;

**WHEREAS**, on 11 March 2022, MKU Limited was declared as the Single Calculated Bidder (SCB) for the PA 47,584 Units of Ballistic Helmet Project with a bid price offer of PhP1,077,539,680.00;

**WHEREAS**, on 04 to 21 April 2022, the Post-Qualification Team conducted the Post-Qualification of MKU Limited pursuant to Section 34 of the IRR of RA 9184;

**WHEREAS**, on 18 May 2022, the PQ Team presented to the Committee the results of the Post-Qualification and recommended the following:

1. To declare MKU Limited as "Post-Qualified" for the PA 47,584 Units Ballistic Helmet Project;
2. To declare MKU Limited as the Single Calculated and Responsive Bidder (SCRB) for the PA 47,584 Units Ballistic Helmet Project; and,
3. To recommend to the Secretary of National Defense the issuance of a Notice of Award (NOA) in favor of MKU Limited.


