Bases referral this case to Bureau is information contained letterhead memoranda and a report furnished CSC which reveals Kantor was contacted by [Soviet Intelligence.] (S)

Bureau is considering possibility of [developing] (S) Kantor [as a double agent.] (S)

Do not include in urep any information furnished by "Sammy" who is Yuri Ivanovich Masensko, soviet defector whose bona fides has not been established.

WASHINGTON FIELD: CIA has furnished Bureau information concerning Kantor. Do not check CIA records concerning applicant as Bureau is requesting CIA permission to disseminate information previously furnished by CIA to Bureau. (McWilliams, Div. 5 Handling)

A reference advised Kantor was in Russia visiting relatives and he was expelled by the USSR. Kantor was put in prison about 48 hours and told to leave the country. The Department of State reportedly has information which was considered not favorable. Check State Department records.
