Re AGAO-C 400.7 (3 Aug 49) CSGLD, 5 Aug 49, "Excess Prop on Guadalcanal" (not to CINCFE nor needed). Bids were invited for sale of residual US prop at Guadalcanal as authd by ref ltr, award has been made to high bidder, L and M Newman, a partnership of Melbourne, Australia. Contract was tendered Newman 20 Feb 50 for signature, Salv Off USARPAC is now advised by H Meyer, Vice President Ayrton Metal Co Inc, New York, representing Newman, that Americans have only short lease Henderson Field Area, and that Lever Brothers will insist on their occupational rights upon release of area by US forces. Purchaser rqsts written guarantee 1 to 2 years time for clearance of prop from Henderson Field Area.

This comd has withdrawn from Guadalcanal all troops except security det (1 off, 8 EM) which was scheduled to remain until final turnover of prop to purchaser planned for no later than 15 Apr 50. Purchaser withholding payments to salv off and completion of contract arrangement pending guaranteed removal rights.

This comd has no knowledge of real estate agreements. Rqst early advice on terms of existing arrangements involving Henderson Field and adjacent areas formerly occupied by 30th Engr Base Topo Bn. Further rqst that negotiations with British for return of land include provisions permitting removal of US prop sold by Salv Off, USARPAC.

Rqst expeditious handling considering continuing difficulties and expense in supplying and maintaining security det and desire to speedily consummate sale contract with Newman.

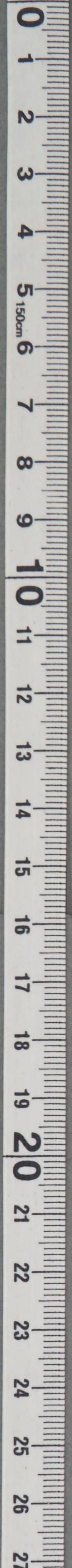

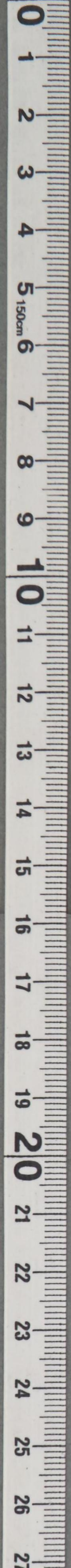

In view of fact that developments London mtg IWC will be made public Dept has prepared following statement regarding status Jap application membership in IWA for use at SCAP's or your discretion with press:

"On March 15 the International Wheat Council, meeting in London, considered an application for Jap membership in the International Wheat Agreement, which has for some time been sponsored by the US. The Council did not find it possible at this time to approve Jap membership, although all exporter countries and many importer countries favored it. There was no adverse decision, however, and the question was left open for settlement at a later date."

FYI and for possible use as background, IWC accepted Ger as member, officially and formally without condition. Nevertheless such admission was possible only because Ger deposited with IWC a letter declaring Ger intention not purchase more non-dollar wheat than amount added to non-dollar exporter quotas as result Ger accession. Because this appeared in fact to be conditional membership, Austral voted against it. Absence such letter in case Jap was reason UK, with more than 1-3d importer votes, opposed Jap membership except on basis formal condition equivalent to provisions letter. When IWC faced question voting on admission Jap on conditional basis, it decided postpone decision. US had previously tried and failed link Germany and Jap memberships, although 16 countries out of 24 favored joint consideration.

Comment: There appears good possibility Austral-Brit arrangement in near future which will satisfy Brit concern over access non-dollar wheat, without tying formal condition Jap membership. If such arrangement made, Jap unconditional accession can easily be voted next IWC mtg, to be held before July 31. Dept believes sharp criticism of Brit opposition to unconditional Jap accession might at this time endanger possibility such arrangements, which are entirely feasible if not unduly publicized.

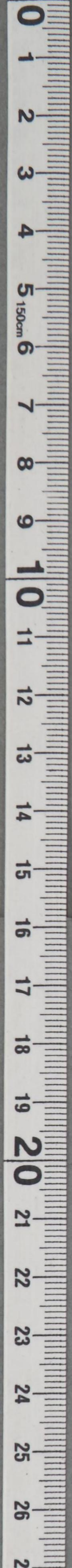

1. The proposed agreement between the Pacific Fisheries Co. and the Polar Whaling Co. does not come within the provisions of SCAPIN 2035, governing the travel of Japanese technicians.

2. G-1 concurs in the views of ESS outlined in par 4, C/N 6. G-1 perceives no objection to the Japanese sailing under the Portuguese flag nor to the Portuguese Government assuming responsibility for protection of the Japanese technicians.

3. Provided the questions raised in previous C/N's can be resolved to bring the travel in consonance with SCAPIN 2035, G-1 will give further consideration to the proposed travel.

SUBJECT: Agreement Between Pacific Fisheries Co., Ltd., and Polar Whaling Co.

1. ESS/FIB by C/N 1, subject as above, 27 Oct 49, forwarded agreement between Pacific Fisheries Co., Ltd., and Polar Whaling Co., Ltd., for comments. Subject agreement proposes a joint venture by the above named companies to operate small trawling fishing with Portuguese Macao as its base.

2. NRS by C/N 2, 4 Nov 49, concurs in the proposed export of Japanese fishermen and charter of Japanese fishing boats for development of commercial fishing off Portuguese Macao. They advise against the use of the Japanese flag by the Japanese fishing vessels during operation from the land base at Portuguese Macao.

3. By C/N 3, G-4 to ESS, 8 Nov 49, it was stated that insufficient information was presented for G-4 to render an opinion on the matter, and that if the subject warrants further consideration, a thorough study should be made prior to further routing.

4. C/N 4, FIB to ESS/FTC, 17 Nov 49, requested ESS/FTC to obtain the information requested by G-4.

5. a. C/N 5, NR to ESS/FTC, 16 Jan 50, contained answers to questions previously requested by G-4.

b. NR recommended that this project be approved. Because of the excessive number of boats and fishermen now operating under the Japanese flag, which are in many cases causing depletion of resources, NR is strongly in favor of such projects as the one proposed, providing they are approved by the foreign government involved and the interests of the Japanese are protected. Such projects are in accord with SCAP policy of exporting technicians.

6. a. C/N 6, ESS to G-1, 2 March 50 states that the proposed agreement does not fall under the provisions and authority contained in SCAPIN 2035 and is in effect a request for the Japanese Government to make a foreign investment in a foreign country with its operating revenue and net profits available to it in foreign exchange outside Japan. ESS withholds concurrence until such time as SCAP policy permits Japanese firms to make foreign investments and realize foreign exchange earnings outside of Japan and concurs in the proposed agreement if the following conditions are met:

- (1) A charter contract is executed providing for a foreign exchange payment to the Japanese for the use of the Japanese fishing boats by the foreign company;
- (2) Contracts of employment are executed providing for the payment of the technicians services in accordance with provisions of SCAPIN 2035;
- (3) Prior concurrence of the Japanese FECB is obtained indicating that adequate benefit accrues to the Japanese economy and that there is no flight of capital possible.

M/R Cont'd:

Further the question is raised as to whether the ships may fly the Portuguese flag, and if the Portuguese Government will assume responsibility for the protection of the technicians.

b. ESS proposes to return this action to DS to determine if the Portuguese Government will assume responsibility for protection of the Japanese, and if so negotiations will proceed to resolve the questions raised by ESS.

7. By C/N 7, G-1 to ESS thru G-4, 6 March 50, ESS is informed that if the travel can be brought within the provisions of SCAPIN 2035, and assurance can be made for the protection of the individuals concerned, further consideration in the matter will be given by G-1.

8. NAVFE, Operations (Cdr Burns, 26-7467) stated that the Japanese ships could be registered by the Portuguese consul in Macao and could then fly the Portuguese flag.

9. From a G-4 viewpoint, no objection is seen provided the travel involved can be interpreted to fall within the provisions of SCAPIN 2035, 1 Aug 49, subject: Travel of Japanese Technicians Outside of Japan.

10. By this action G-4 concurs with the views expressed by G-1 in C/N 7.

11. Within established policy.

12. Completes action on G-4 Journal No. 2761; relates to G-4 Journal No. 92114.

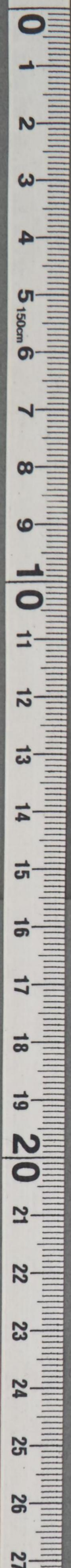

1. Inclosed for your information are copies of:

- a. Agreement between United States Forces in Austria and Federal Government in Austria.
- b. Lease form used by the Army in Austria and related forms.
- c. Technical instructions No. 17 regarding execution of supplemental agreements.

2. It will be noted that the standard form of lease, among other things, provides as follows:

"6. The Lessor shall furnish to the Government, as part of the rental consideration, the following:

See Annex "A" which is made an integral part of this lease as if written herein.

"9. a. The Lessor shall maintain the said premises and property in good repair and tenantable condition during the continuance of this lease; provided that, until building materials and other such supplies are freely available in the Austrian economy so as to be procurable by the Lessor, the Government may furnish labor and material required to effect repairs, giving notice of the extent and cost of such maintenance measures to the Lessor and deducting the cost thereof from the rental herein provided.

b. The Lessor shall be responsible for and keep in operating condition all electrical fixtures, electrically operated devices, the plumbing and sewerage systems, heating plant, refrigerating systems, and all other devices, installations, and systems which are necessary to the full use and enjoyment of the premises; provided that, until electrical,

plumbing, and other such supplies are freely available in the Austrian economy so as to be procureable by the Lessor, the Government may repair the aforesaid devices and installations, giving notice of the extent and cost of such maintenance measures to the Lessor and deducting the cost thereof from the rental herein provided."

3. The arrangements referred to in Paragraph 2 above are very satisfactory in Austria. Unless your Headquarters is already doing so, it is suggested that consideration be given to having leases provide for the lessor to furnish repairs and utilities services.

1. The attached correspondence relative to the delimitation of the Mariveles Military Reservation is forwarded in compliance with Department of the Army message WCL 37743, dated 5 May 1949.

2. The Commander-in-Chief, Far East, concurs in the recommendation for transfer of the Mariveles Military Reservation to the Philippine Government. However, it is recommended this transfer not be accomplished until completion of the permanent POL system referred to in paragraph 4 of second indorsement.

3. In view of the recommended release of the reservation, it is not considered necessary to complete the work of delineating the boundaries of the privately owned land plots located therein.

4. Your attention is invited to paragraph 4 of second indorsement. Approval by the Director of Installations, United States Air Force, is required prior to the extension of the leases comprising the POL terminal. These leases are now in effect and funds for their payment were included in the budget requirements for Fiscal Year 1951.

1. Attached is a report prepared by the District Engineer, Manila District, concerning the metes and bounds description and history of acquisition of the "Mariveles Military Reservation, POL Terminal and Training Area, Bataan," an Annex "A" Base.

2. Metes and bounds description of the POL Terminal is shown although acquisition of the land, which is owned by private individuals, has not been approved. This is an active installation.

3. Metes and bounds description and history of acquisition of the Bataan Military Reservation (Training Area, Bataan), are included in this report.

4. MANED has completed field surveys of the northern boundary of the Mariveles Military Reservation, but this survey has not as yet been approved by the Bureau of Lands of the Philippine Government. The boundary was monumented. MANED also surveyed 120 private properties contiguous to this boundary. Sufficient funds have been budgeted for completion of the work involved in completing the registration of this survey.

5. Innumerable tracts of private properties are located within the Mariveles Military Reservation and information concerning descriptions of all these tracts is not readily available. Inclosure #16 of the brochure is a reproduction of several plans on file in the Bureau of Lands, Republic of the Philippines. It covers only a portion

of the plans which were prepared from surveys made in 1936 of the entire reservation, including private properties, to delineate the present boundaries of the reservation as described by Executive Order dated 16 December 1924. This is the only reproduction which MANED has of any kind of any of the plans resulting from that official survey. However, research reveals that all the plans covering the entire reservation which also set out the private properties, are on file in the Bureau of Lands. All of the technical descriptions of the surveys from which the plans were drawn could not be located, but it is believed that at least 95% of them are available for reproduction, if required. It is estimated that the tracing of the plans and the copying of the available field notes would require 5 months to complete at a cost of approximately \$4,000.00. If the presently unlocated field notes cannot be found, it is estimated that the work necessary to make a resurvey and recomputation of the areas involved would take approximately 8 months to complete at a cost of about \$8,000.00. These figures do not include the costs of remonumenting the privately owned properties, which if required would cost an estimated \$75,000.00.

6. Information is requested as to action to be taken with respect to including in this report data concerning private properties located within the Mariveles Military Reservation.

1. In order to be able to present to the Philippine Government as complete a report as is possible concerning the metes and bounds description of the Mariveles Military Reservation, it is recommended that funds in the amount of \$12,000.00 be made available to the District Engineer, Manila District, for establishing locations of parcels of privately-owned land within this Annex A base as indicated in paragraph 5 of basic. Re-monumenting these privately-owned properties is believed unnecessary at this time.

2. With reference to the metes and bounds description of the POL Terminal, which is within the Mariveles Military Reservation but is located entirely on privately-owned property, the area indicated in the attached report is that presently in use. Purchase of this land has not been authorized to date. It is recommended that every consideration be given to reaching an early decision relative to POL facilities as leases at the Bataan Terminal are for the "duration of the war and six (6) months."

3. This Headquarters has no requirement for the Bataan Military Reservation (listed in Annex A as Training Area, Bataan). This reservation is adjacent to the southern boundary of the United States Naval Reservation at Olongapo. If it is determined to be surplus to the needs of the Department of the Air Force and the Department of the Army, it is suggested that the concurrence of the United States Navy be obtained prior to transferring the reservation to the Philippine Government.

4. Attached as Inclosure #2 is a copy of Department of the Army radio WCL 37743, dated 5 May 1949, which indicates the procedure established by the Department of the Army for forwarding subject brochures for approval.

5. Subject to the above comments, this Headquarters concurs in the attached report.

2. In compliance with paragraph 4, Article 1, of the Philippine Base agreement, this headquarters concurs in the necessity of completing the work of delineating the boundaries of all privately owned land plots in the Mariveles Military Reservation, and recommends that funds in the amount of \$12,000 be made available as noted in paragraph No. 1, 1st indorsement.

3. This headquarters has no present or foreseeable requirement for the Bataan Military Reservation area and recommends that subject to Navy concurrence it be transferred to the Philippine Government.

4. It is requested that necessary action be taken to extend indefinitely the leases covering privately owned land comprising the FOL terminal, pending finalization of plans, construction and placing in operation of Permanent FOL system, as contained in the budget for FY 1951.

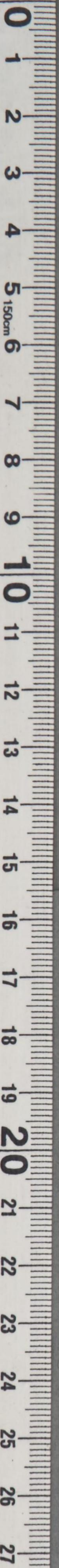

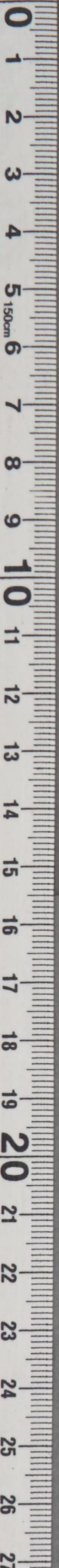

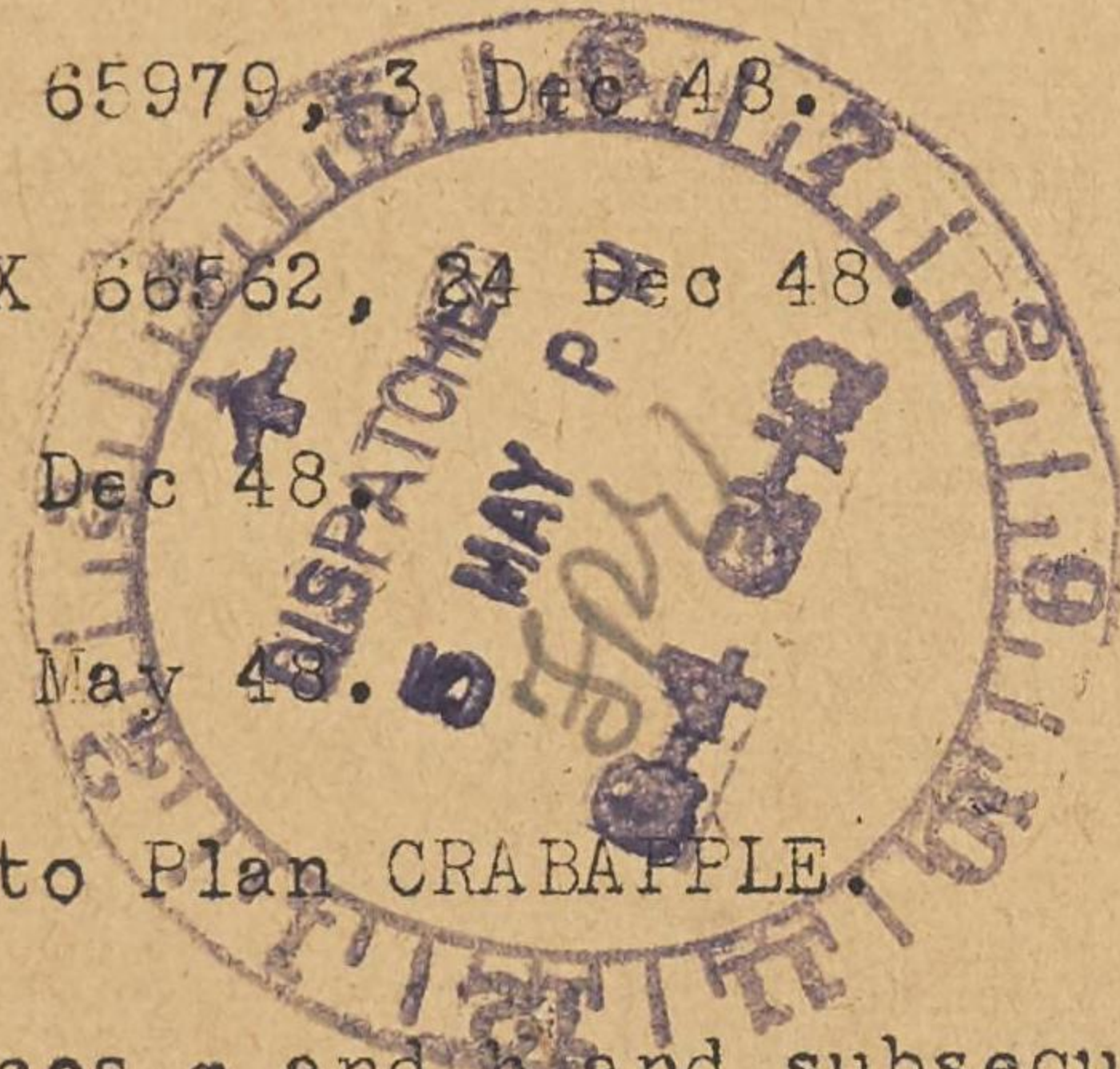

Part 1. a. References g and h and subsequent instructions provided that CG USAFIK would from excess Army stocks in Korea make available to State representatives in Korea, at that time known as POLAD, an initial issue of necessary equipment and supplies, and would insofar as his excesses permitted stockpile six months supplies and replacement parts for equipment so furnished.

b. Transfer of above initial issue and stockpile was to be accomplished at department level in accordance with reference f.

c. Upon receipt of reference g, CG USAFIK immediately requested State representatives to submit their list of requirements and offered the assistance of his technical service experts in estimating AMIK's requirements. A detailed plan for accomplishing the necessary surveys and earmarking of equipment was inaugurated. A special property account was established to receive shipment of such equipment and supplies and technical services directed to make shipments as rapidly as AMIK representatives could assume responsibility and control. No repeat no limit was placed upon the type or amount of equipment or supplies to be furnished AMIK dependent on their availability in Korea and being in excess of USAFIK requirements prior to withdrawal.

d. The directive contained in reference g clearly indicates no obligations accepted by D/A to import equipment or supplies into Korea to provide initial issue and six months stockpile for AMIK on a non-reimbursable basis.

e. Wolfe Mission just prior to departure Korea and again at CINCFE enroute to U.S. expressed complete satisfaction with provisions USAFIK had made for AMIK.

Part II. a. When instructions were received continuing USAFIK in Korea beyond 15 Jan 49, initial issue and stockpile had been completed except for some equipment that had been earmarked for transfer but required by USAFIK until withdrawal. (Examples, signal center equipment, and office furniture for USAFIK headquarters.) USAFIK requested instructions as to length of time AMIK could continue to draw equipment and supplies under terms reference g.

b. Reference d (transmitted for your info by separate message) directed USAFIK secure firm requirements from AMIK for initial issue and stockpile from USAFIK excesses, and when this completed all future mission requirements would be provided on normal logistic support basis. Pertinent D/A regulations require reimbursement for such support and in absence of instructions to contrary normal procedures applied.

c. In compliance with above USAFIK reached agreement with AMIK representative (Benjamin) that all requirements submitted by AMIK for USAFIK excesses prior to 10 Dec would be on a non-reimbursable basis as provided by reference f. That all requirements which could not be met from existing USAFIK excesses and requirements generated subsequent to 10 Dec would be on reimbursable basis. Letter mentioned in reference a embodied this agreement.

d. Our rad reference b restates above arrangements, which were discussed in detail with JAS representatives by representatives this Ho and USAFIK 22 April.

e. Cannot understand here how State representatives can take position obligations of USAFIK not completed since all requirements stated up to 10 Dec had been made available as initial issue or stockpile without reimbursement within USAFIK excesses, except for items referred to in Part II a.

Part III. a. The logistic support of AMIK falls generally into four phases (1) The issue of AMIK's initial requirements and a six months stockpile from then existing USAFIK excesses not critical and not required elsewhere in FEC, based upon previous plans for withdrawal of USAFIK 15 Jan 49 (2) Normal logistic support for AMIK by USAFIK during period 1 Jan 49 to 30 Jun 49 (3) Supply of new and additional requirements of AMIK from present excess USAFIK stocks generated as result of complete withdrawal (4) Normal logistic support for AMIK after 30 Jun 49.

b. In connection with phase one, obligations of USAFIK were fully discharged except as noted in Part II a. USAFIK is taking current action to complete initial equipment requirements withheld when withdrawal postponed as provided in reference b. Understanding here and USAFIK this to be on non-reimbursable basis as contemplated in reference g.

c. In connection with phase two, USAFIK has complied with current D/A regulations governing the furnishing of supplies and equipment to other governmental agencies by requiring certificate that funds for reimbursement were available when requisition was submitted.

d. In connection with phase three, reimbursement at D/A level is envisaged. See references b and c.

e. In connection with phase four, the continued logistic support of AMIK, details are currently being determined. Regulations governing reimbursement for equipment and supplies furnished other governmental agencies will apply. Dollar credits will be required for procurement in Japan and for items procured in ZI.

Part IV. a. Notwithstanding agreement reached between USAFIK and JAS and embodied in letter of 6 Dec 48 referred to in reference a, which inaugurated phase two, the implementation of which required a certificate of availability of funds by JAS, JAS now takes position all supplies except

subsistence items requisitioned for import by USAFIK for AMIK during second phase should be supplied on non-reimbursable basis. This position wholly unwarranted and without basis in any instructions received or issued by this headquarters.

b. Further understood here that extensive rehabilitation program beyond that embodied in Wolfe-Coulter agreement was undertaken by JAS which completely exhausted stockpile of building materials provided from original USAFIK excess stocks. This rehabilitation program involved complete renovation including painting, new floors, new bathrooms, rearrangement of interiors, etc. of quarters previously occupied by commissioned personnel on basis that Army standards were not equal to State standards. As of 10 Dec USAFIK had turned over to AMIK all suitable construction materials under his control.

c. In view of foregoing it is maintained here that AMIK has been provided for as adequately as USAFIK excess resources permitted except on basis that present ideas are more elaborate than was the case formerly. This does not serve to change the non-availability of excesses to meet this change in concept.

d. Reiterated is understanding here that any import of supplies for AMIK is reimbursable. Neither USAFIK nor FEC have funds to cover such requisitions, therefore certificates of availability of funds to cover have been required.
