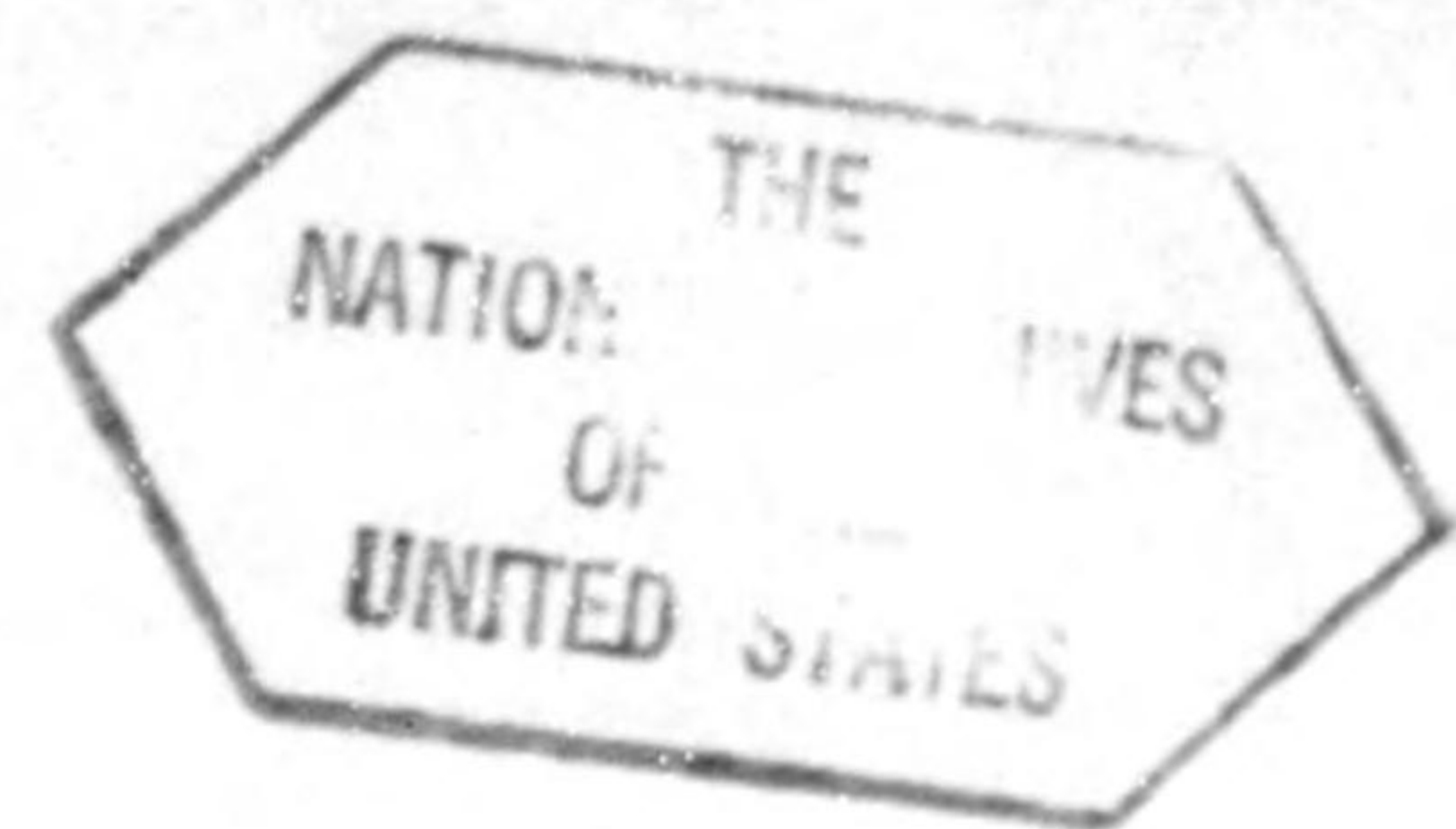

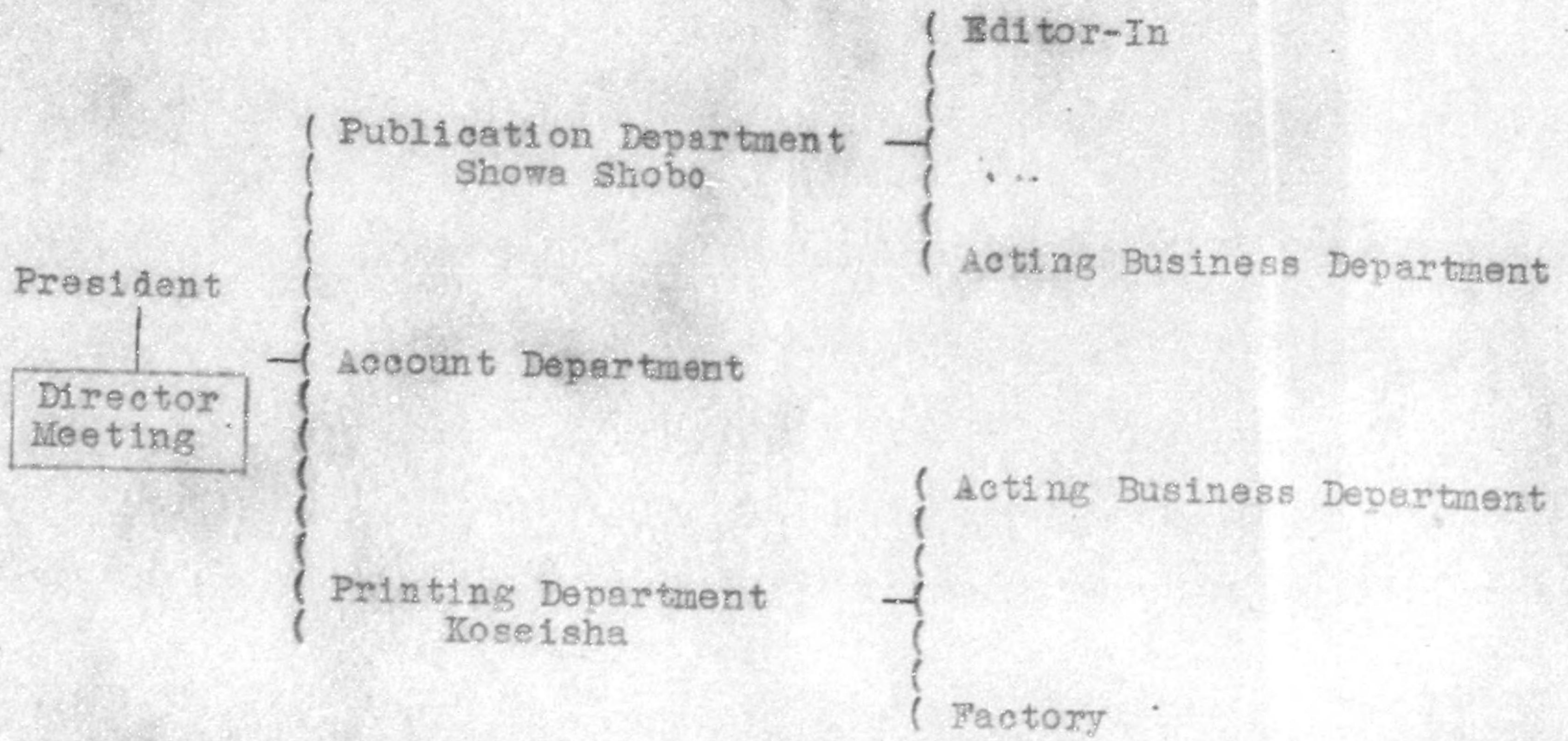

C. Acting Business Department:

Executes management for Printing, book-binding of publications, and propagating, selling the publications, and collecting the prices of publications.
