PRESIDENT'S PROCLAMATION.

WASHINGTON, Dec. 8. 1863. Whereas, in and by the Constitution of the United States it is provided that the President shall have power to grant reprieves and pardons for all offenses against the United States, except in cases of impeachment; and whereas, a rebellion now exists whereby the loyal States and the Governments of the States have, for a long time been subverted, and many persons have been committing and are now guilty of treason against the United States; and whereas, with reference to said rebellion and treason, laws have been enacted by Congress calling for the forfeiture and confiscation of property and the liberation of slaves, all upon terms and conditions therein stated, and also declaring that the President was thereby authorized at any time thereafter, by proclamation, to extend to persons who may have participated in the existing rebellion in any State or part thereof, pardon, or amnesty, with such exceptions and on such terms and on such conditions as he may deem expedient for the public welfare; and whereas, the Congressional declaration for limited and conditional pardon accords with well established judicial expositions of the pardoning power; and whereas with reference to said rebellion the President of the United States has issued several proclamations with provisions in regard to the liberation of slaves; and whereas, it is now desired by some persons heretofore engaged in said rebellion to resume their allegiance to the United States and re-inaugurate loyal State Governments within

When you wake up, do not roll over, but roll out. It will give you time to ditch out perpendicular view of the rainbow, all your sloughs, break them up, harrow them, and sow them with timothy and red clover. One bushel of clover seed to ten

Make your fences high, tight and strong, so that they will keep cattle and pigs out. If you have brush, make your lots secure, and keep your hogs from your cattle; for it your corn is cleau, they will eat it better than if it is not.

Be sure to get your hands to bed by seven o'clock. They will rise early by the force of circumstances.

Pay a hand—if he is a poor hand—all you promise him. If he is a good hand, pay him a little more; it will encourage him to do still better.

Always feed your help as well as you do yourself; for the laboring men are the bone well treated.

WAR NEWS.

Dates to December 17th.

Cincinnati, Dec, 16 .- Advices from Knoxville the 10th inst, state that the main body of Longstreet's army was at Rogerville. During the retreat, Longstreet lost -3,000 men in prisoners and deserters .-There were swarms of fugatives from his ranks, and his army was worn out from hard service and were dispirited. Longstreet abandoned his seige train of six guns, after burning the gun curriages, The guns fell into our hands. The people around Knoxville are destitute, the rebel army having consumed everything eatable, Longstreet's army is represented to be almost entirely seate, Dec. 1, 1863. demoralized.

Chicago, Dec. 16th .- By way of Memphis we learn of another victory gained over the rebels in Texas. Official information has been received at headquarters of the Gulf, that all the rebel forces at l'ort Cavallo were captured by the Union troops under General Washburn. It is not known what the number of the enemy was, but accounts previous to capture placed the number of the garrison at one thousand men, under Colonel Bradfate of Texas. A refugee states, that two months since, there were seven heavy guns and five field pieces at that point. The possession of the position clears the entrance to Matagorda Bay, and gives the Union army command of several important places. Port Lavaca, Matagorda and Silavia are a short distance back from the Bay, as well as Victory and

UNIVERSITY

Of Washington Territory.

THE UNIVERSITY established at SEATTLE on Puget Sound by Legislative Enactment and in ac-ordance with an Act of Congress approved July 17th 1854, being completed, now opens its doors to all those who desire to avail themselves of the facilities it affords for acquiring a thorough acquaintance with the common and higher English branches, and also

CONSTITUTION AND BY-LAWS. OF THE

KING COUNTY AGRICULTURAL SOCIETY.

PREAMBLE:

For the promotion of the Farming, Mechanical and Industrial Pursuits of King County Washington Ter ritory, we the citizens of the county, do mutually agree to associate ourselves together into a Society for that purpose, hereby pledging ourselves to be 1. The LONDON QUARTERLY, (Conservative.) governed by the following Constitution and By-Laws

CONSTITUTION:

ARTICLE 1. This Society shall be called the King County Agricultural Society.

ART. 2. Any person may become a member of this Society by paying Two Dollars and Fifty Cents into the Treasury, and signing his name to the Constitution.

ART. 3. The Officers of this Society shall be a President, Vice President, Secretary, Treasurer and Executive Committee of Five.

ART. 4. The officers of this Society, shall be elect ed by ballot, and shall hold their offices for the term of one year.

ART. 5. The President shall preside at all meetings of the Society; call meetings of the same and perform all duties imposed on him by any By-Law of the Society.

ART. 6. The Vice President shall act in all cases in the absence of the President.

ART. 8. The Treasurer shall take charge of all the same on the order of the Chairman of the Executive Committee, and make report to the Society of the condition of the funds at the annual meeting each year; but before entering upon the discharge of his duty he shall give a bond to the President, with approved sority in such sum as shall be fixed by the Society, faithfully to discharge the duties imposed upon him by the Constitution and By-Laws of this Society and to deliver to his successor all moneys, books and property of any kind belonging to the Society, had in his custody by virtue of his office.

ART. 9. The President Secretary and three members shall constitute the Executive Committee to do the business of the Society, a majority of whom shall be a quorum.

ART. 10. There shall be an annual meeting of this Society at such place as the Executive Committee may direct on the Third Saturday in June in each year, for the election of officers, payment of dues, and the transaction of any business that may be brought before the Society.

ART. 11. There shall be an Annual Fair held by the Society, under the direction of the Executive Com mittee, at such place as said committee shall designate, on the Third Wednesday in October, in each and every year.

ART. 12 Within four weeks after the annual meet, ing of this Socie y in June, the Executive Committee shall arrange and publish a list of premiums for the next annual Fair.

ART. 13. No Premium exceeding Ten Dollars for any one prize shall be offered by the Executive Committee.

ART. 14. Any person exhibting farm products for a premium, shall file with the Secretary a written statement showing the manner of their production.

ART. 15. Any person claiming a premium for the product of any field of grain or vegetables, shall present a fair specimen of the same and verify the amount of the production by the certificate of at least two disinterested persons.

ART. 16. Juries of not less than three competent members of this Society, shall be appointed annually, by the Executive Committee, to award premiums on each class of articles or products exhibited.

ART. 17 The President shall deliver or procure me one to deliver an address on the interests of Agriculture at each annual Fair.

ART. 18. Whenever a vacancy shall occur by death, resignation or otherwise, in any office of this Society, the same may be filled by the Executive Commistee, to take effect only until the next succeeding annual election of this Society.

ART. 19. This Constitution may be altered or amended at any annual meeting of the Society by a vote of two-thirds of the members present.
