Thank you for your patience. Sorry it took us longer to get back to you, but the problem is that the speaking fee is a bit too high and exceeds our budget at the moment, so we had to negotiate it with the management. Do you think there is any possibility to reduce the price to 45K? all other conditions (accommodation and flights) are fine.

If there is a chance to reconsider the fee, it would be great for us as we would love to welcome General Flynn in Moscow.
