It is noted that CIA letter dated 1/22/63, captioned, "MEMBERS OF THE DISSIDENT ELEMENT OF ALPHA 66," reveals that this group is referred to "as Command L, Commando Ponce, and L 66." The letter further lists ANTONIO CARASA as a delegate in Wash., D.C. In an interview with CARASA on 3/29/63, he denied that he has ever accepted any formal nomination as a representative in the Wash., D.C., area of Operation Alpha 66 or of any other similar organization of Cuban exiles. ~~Q~~ ~~X~~ (u)

CIA info is classified per their ltr dtd 1/20/85. WPT/ML/vp; 4/19/85; #235,869

Inasmuch as San Juan radiogram dated 3/29/63, captioned as above reveals that captioned organizations has been incorporated under the above described name, it is likewise being set forth as the true title in instant report.
