ADMINISTRATIVE

CALIF On March 5, 1965, the San Francisco Office advised that SF 2688-PC had reported that in April, 1963, ANGELO MARINO, San Jose member of the La Cosa Nostra, and his mistress MARIA MACK, traveled to San Diego where they contacted FRANK BOMPENSIERO. *CALIF* BOMPENSIERO then arranged for one Dr. VITALE (Since identified as Dr. SEBASTIANO VITALE) to perform an abortion on MARIA MACK at the residence of MARIA GAVIN. *CALIF* It should be noted that FRANK BOMPENSIERO is residing with MARIA GAVIN, who is the former wife of GIROLOMO ADAMO, deceased, brother of JOSE ADAMO.

San Francisco instructed that this information should not be set out in a report at this time.
