WE command you to attach the goods or estate of *Thomas Smallwood*
of *Newton* in the County of *Middlesex* and
District aforesaid, *Cabinet maker*

in our District of Massachusetts,
to the value of *Two thousand* dollars,
and for want thereof, to take the bod of the said *Smallwood*
(if he may be found in your District) and *him* safely keep, so that you have *him*
before our Judges of our Circuit Court of said United States for the first Circuit, next to
be holden at *Boston*, within and for our said District of *Massachusetts*, on the *second*
day of *May* next : Then and there, in our said Court, to answer unto
Samuel H. Bean of *Philadelphia* in the State of *Pennsylvania*, Gentleman,

In a plea of *Trespass* on the case, *For* that the said
Bean was the original and first inventor of a new
and useful improvement in the *Rocking Chair*, on the latter
patent hereinafter fully described, and which was not
known or used before his said invention, and which was
not at the time of his application for a patent as herein-
after mentioned in public use or on sale with his Con-
sent or allowance, and said *Bean* being so as aforesaid
the inventor thereof, and being also a citizen of the United
States, on the thirty first day of *March* in the year
of Our Lord *Eighteen hundred and forty*, upon due
application therefor, did obtain certain *Letters patent*
in full force of Law under the seal of the
well knowing the premises, but contriving to injure the
plaintiff did on the first day of *May* in the year
Eighteen hundred and forty and at divers times before
and afterwards during the said term of *fourteen* years
mentioned in said *Letters patent*, ~~at Boston in the County~~ to wit at
said *Boston* unlawfully & wrongfully, & without the con-
sent or allowance of said *Bean*, make, use, and vend
to others to be used ^{to wit one thousand rocking chairs, in imitation of} the said improvement ^{of said Bean} in violation
and infringement of the exclusive right so secured

to the said Bean by said letters patent, and
to the form of the Statute of the United States in
such case made and provided, whereby the
said Bean has been greatly injured and de-
prived of great profits & advantages which he
might and otherwise would have derived from
said invention; and has sustained actual damage
to the amount of one thousand dollars, & by
force of the Statute aforesaid an action has accrued
to him to recover the said actual damage, and such
additional amount, not exceeding in the whole
three times the amount of such actual damages,
as the Court may see fit to order & adjudge;

To the damage of the said *Bean*
as he say, the sum of *Two thousand* dollars, which shall then
and there be made to appear, with other due damages. And have you there this writ,
with your doings therein. Witness, the Hon. *Roger B. Tarey*,
at Boston, the *Seventh* day of *April* in the year of our
Lord, one thousand eight hundred and *forty two*

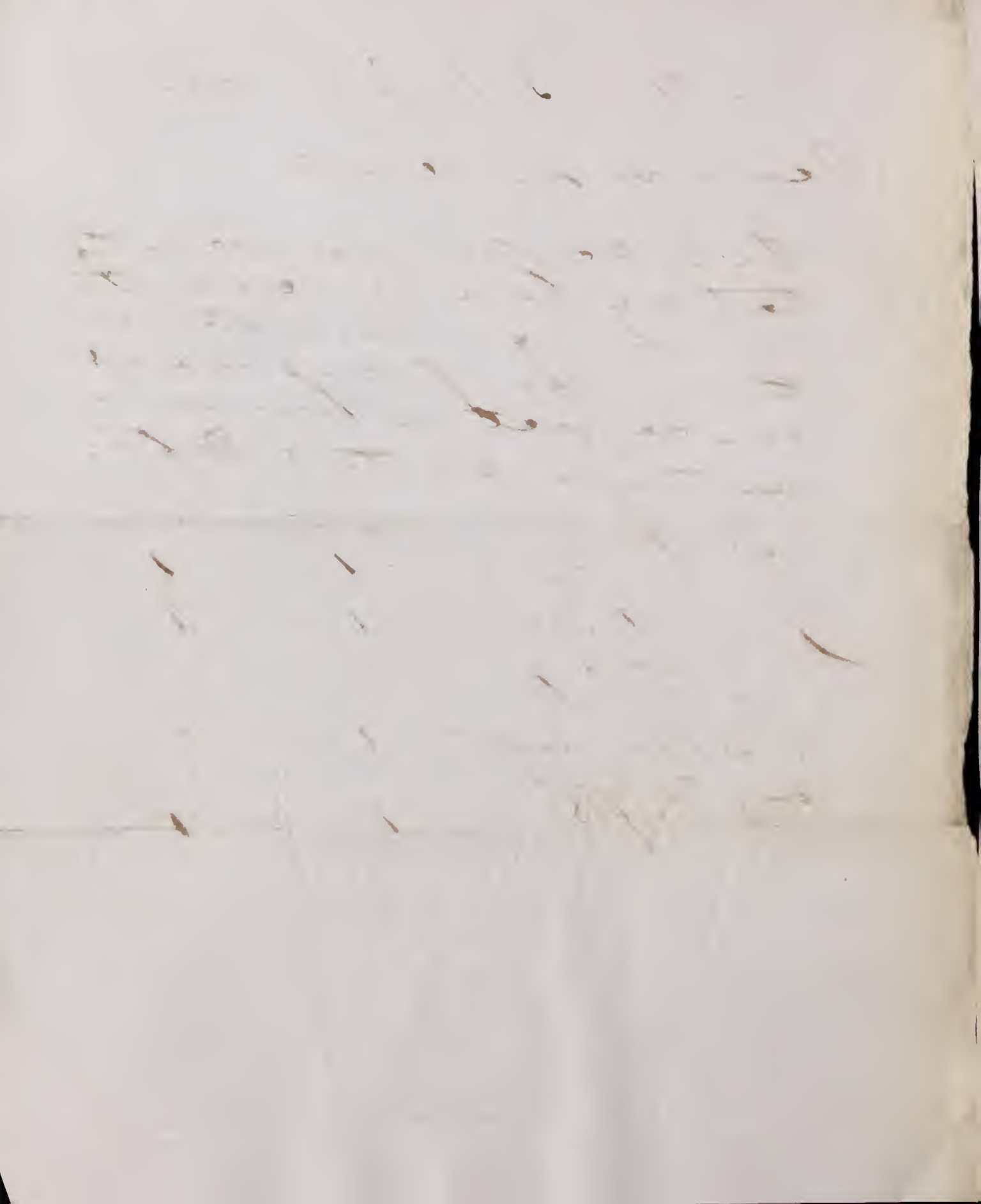

A. D. 1843 recovered judgment against Samuel H. Bean
of Philadelphia in the State of Pennsylvania,
Debtor,

for the sum of Sixty two Dollars of forty four
Cents

~~debt or damage, and~~

costs of suit, as to us appears of record, whereof execution remains to be
done :

WE command you, therefore, that of the goods, chattels, or lands of the
said Bean

within your District, you cause to be paid and satisfied unto the said
Smalleywood

at the value thereof in money, the aforesaid sums being Sixty two
Dollars of forty four cents

together with ~~dollar and~~ twenty five cents more
for this writ

and thereof also to satisfy yourself for your own fees : and for want of goods,
chattels or lands of the said Bean

to be by him shewn unto you, or found
within your District, to the acceptance of the said Smalleywood

to satisfy the sums aforesaid,
We command you to take the body of the said Bean

and him commit unto
either of our gaols in our District of Massachusetts

aforesaid, and detain in your custody within
either of our said gaols, until he pay the full sums above mentioned, with

your fees, or that he be discharged by the said Smalleywood
the creditor, or otherwise

by order of law.

HEREOF FAIL NOT, and make return of this writ, with your doings
therein, into our said Court, to be held at Boston within

our District of Massachusetts aforesaid, upon the fifteenth day
of May next.

early as the year 1818 & by Timothy
Claxton late of Boston & Solomon P.
Miles of Boston as early as the year
