SUBJECT: Administrative Review Board Input for Guantanamo Detainee, ISN: US9AF-000783DP (U)

1. (S//NF) JTF GTMO recommends to the Administrative Review Board (ARB) that this detainee be transferred to the control of another country for continued detention (TRCD).

2. (S//NF) Summary of Most Recent JTF GTMO Assessment, signed on 11 November 2003.

- a. (S//NF) Most Recent JTF GTMO Recommendation: Retain under DoD Control.
- b. (S//NF) Threat Level in Most Recent JTF GTMO Assessment: High.
- c. (S//NF) Intelligence Value in Most Recent JTF GTMO Assessment: Medium.

d. (FOUO) Note: JTF GTMO's system of identifying detainees as High, Medium or Low threat has evolved over time. The threat and intelligence values listed above may have been adjusted to conform with the most recent standards.

3. (S//NF) Updated JTF GTMO Threat and Intelligence Value Since Most Recent Assessment.

a. (S//NF) Updated Threat Level. JTF GTMO has determined that detainee is a Medium threat to the US and its allies based on the following facts.

(1) (S//NF) Detainee was captured during a raid on his family compound in Khowst, Afghanistan (AF) conducted by U.S. Special Forces and Afghani Military Force (AMF) personnel. When the raid began, detainee grabbed his AK-47 and went to hide it. The AMF

ordered him to stop, at which time a firefight broke out. Detainee fired his magazine full of ammo at the AMF forces, threw down his weapon and attempted to flee. He was shot in the hip and captured.

(2) (S//NF) The compound the detainee was captured in belonged to his uncle "Karim" ISN: US9AF-000975, Bostan Karim. Karim is a suspected Al-Qaida cell leader and bomb-maker who was captured by Pakistani Forces at the Khurgi checkpoint in Pakistan on 13 August 2002 along with Abdallah Muhammad, aka, Wazir.


(3) (S//NF) Detainee is a member of the Arbaqi security group. This group provides security to all merchants and their businesses at the bazaar located in Khowst.

(4) (S) After extensive searches on national-level counter-terrorism databases no further intelligence has been collected or found concerning this detainee.

b. (S//NF) Updated Intelligence Value. JTF GTMO has determined that the detainee is of low intelligence value. Detainee has limited knowledge of:

(1) (S) Terrorist operations in the CENTCOM Area of Responsibility.

(2) (S) Personalities and operations of Anti-Coalition Militia within the Khowst area in Afghanistan.
