Reference is made to your 1st Indorsement to the Osaka Military Government Team letter of 30 June 1949, subject, "Application for Travel from Japan to Ryukyu Islands", and letter from this headquarters, dated 19 October 1949, subject as above in which permission was granted for entry into the Ryukyus of ASASUKE TERUYA.

2. It has been brought to the Attention of this headquarters that due to inadequate translation of ASASUKE TERUYA's original application it was believed that his relatives had been located in the Ryukyus; however, further investigation reveals that the persons contacted are not the applicant's relatives and that to date, investigation has failed to locate his family at the address given in the application.

3. In view of the above it is requested that Asasuke Teruya not be permitted to travel to the Ryukyus and that our letter of 19 October 1949 regarding this case be disregarded.
