Our troops were advancing southward. All obstacles and buildings were being used by the Japs for protection. The Commander Support Air directed this flight of 1 VC-93 VF Air Coordinator, 4 VC-79 VF and 4 VC-93 VF strike planes to attack the town of Kokuba, in the path of the advance. After one run on this town all of the VF departed for other assigned targets. Among the other targets they subsequently hit were several trucks which were burned.

The VF executed nine runs from north to south from 6500 to 1000 feet, at 35 degree angle glide and 280 knots. Many fires were burning fiercely when the VF departed. A high wind was blowing and the extent of the damage to the town was probably substantial.
